

DESCRIPTION

FIG. 1 is a right side elevation view of a vest for pet, showing my new design in condition of use.
FIG. 2 is a ride side elevation view of the vest for pet of FIG. 1, shown enlarged for clarity of disclosure;
FIG. 3 is a left side elevation view thereof;
FIG. 4 is a top plan view of the vest for pet of FIG. 1, shown at a reduced scale;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a top, front, right perspective view of the vest for pet of FIG. 1, shown enlarged for clarity of disclosure; and, FIG. 7 is a top, rear, right perspective view thereof.
In the drawings, the equal-length broken lines on the vest for pet depict stitching and form no part of the claimed design. The equal-length broken lines showing a dog, fasteners, and straps depict environmental subject matter only and form no part of the claimed design.














