DESCRIPTION

FIG. 6 is a left side view thereof;

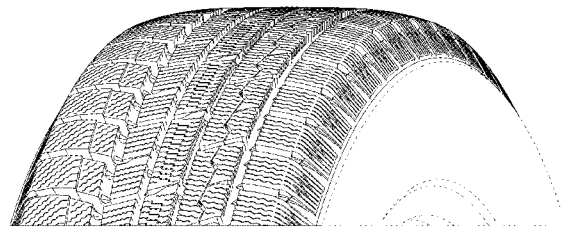
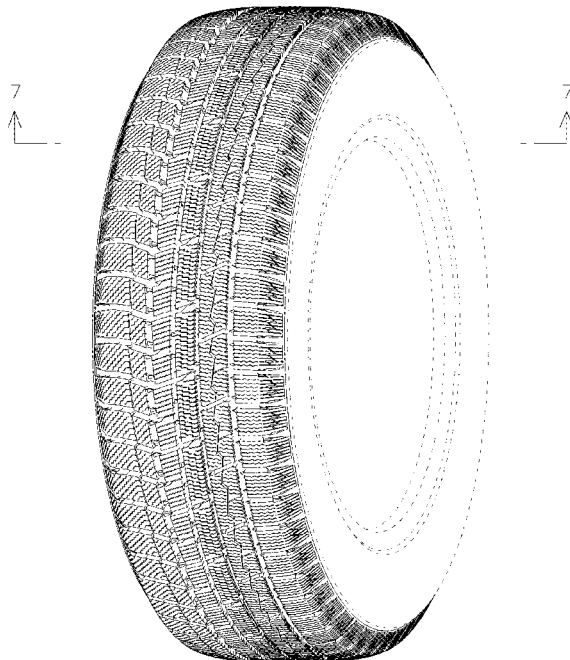
FIG. 7 is an enlarged view taken along line 7-7 in FIG. 1;

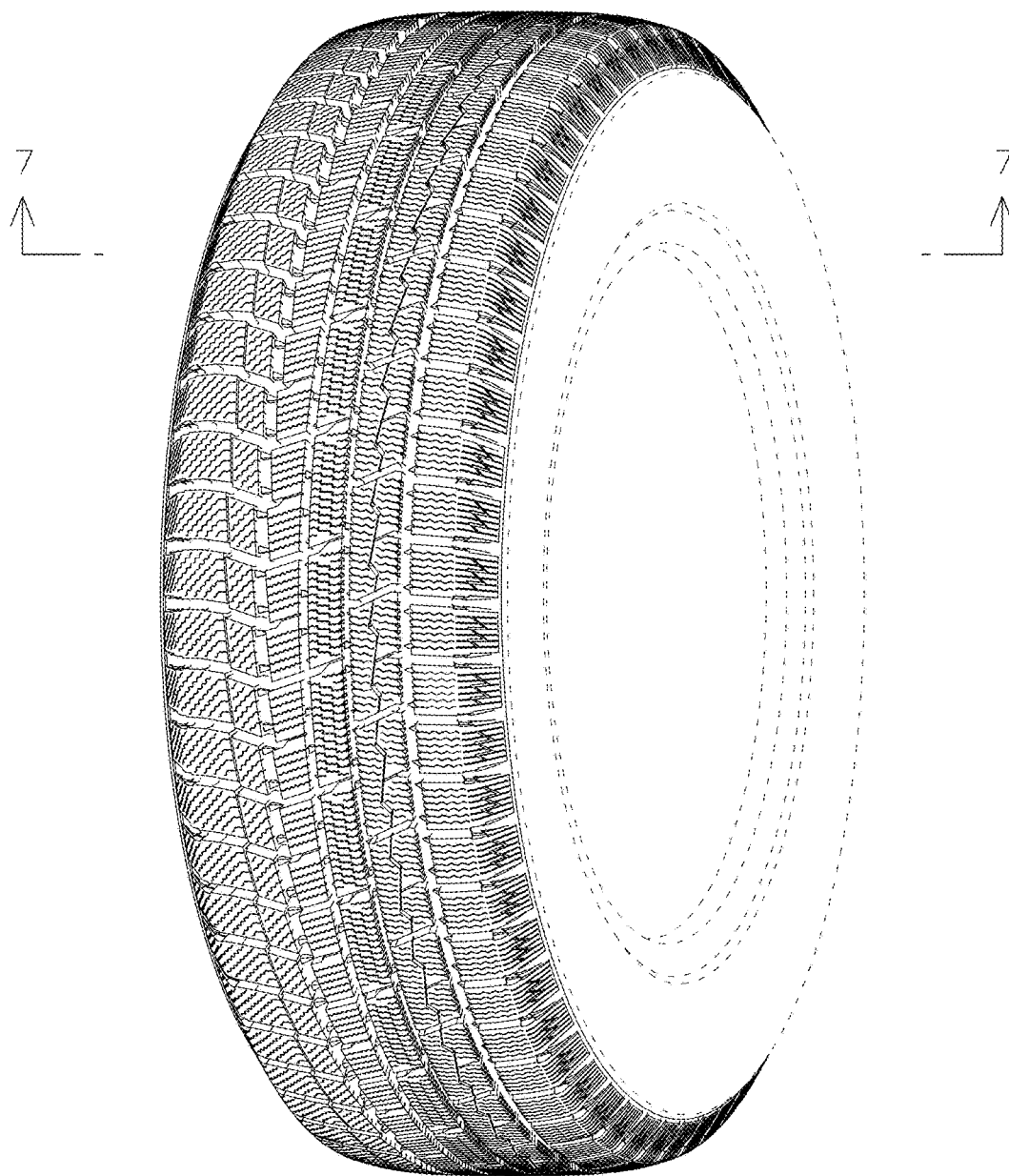

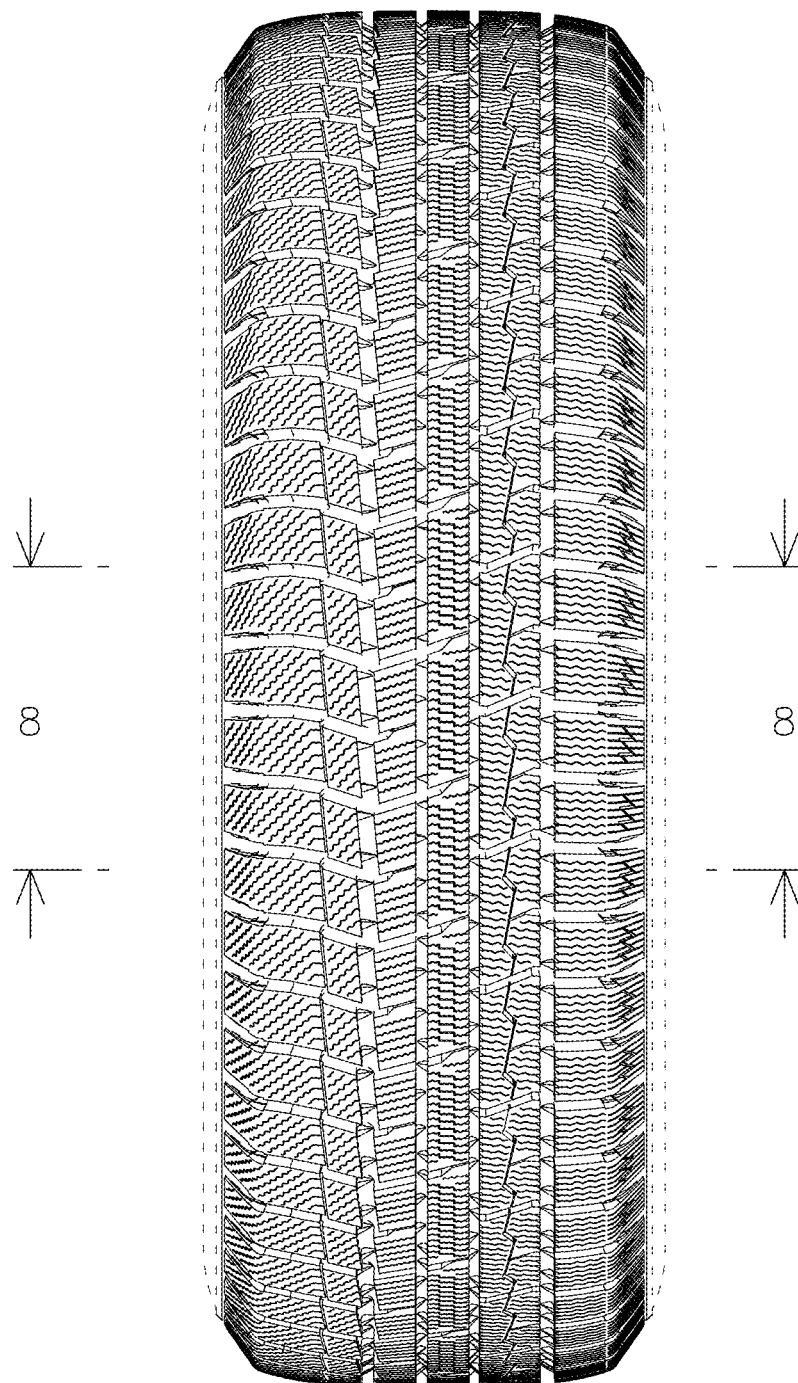

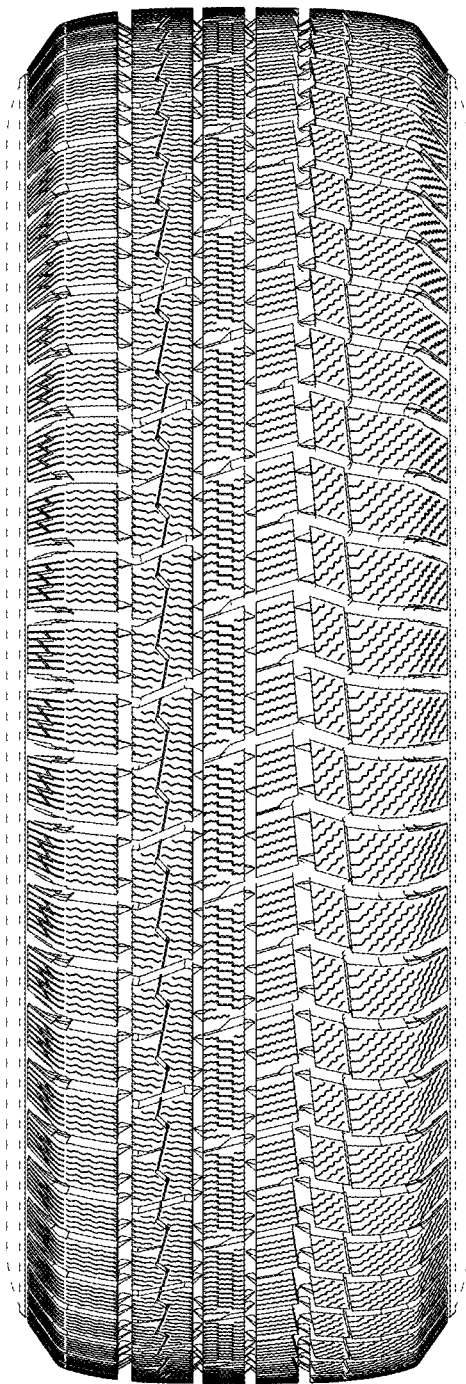

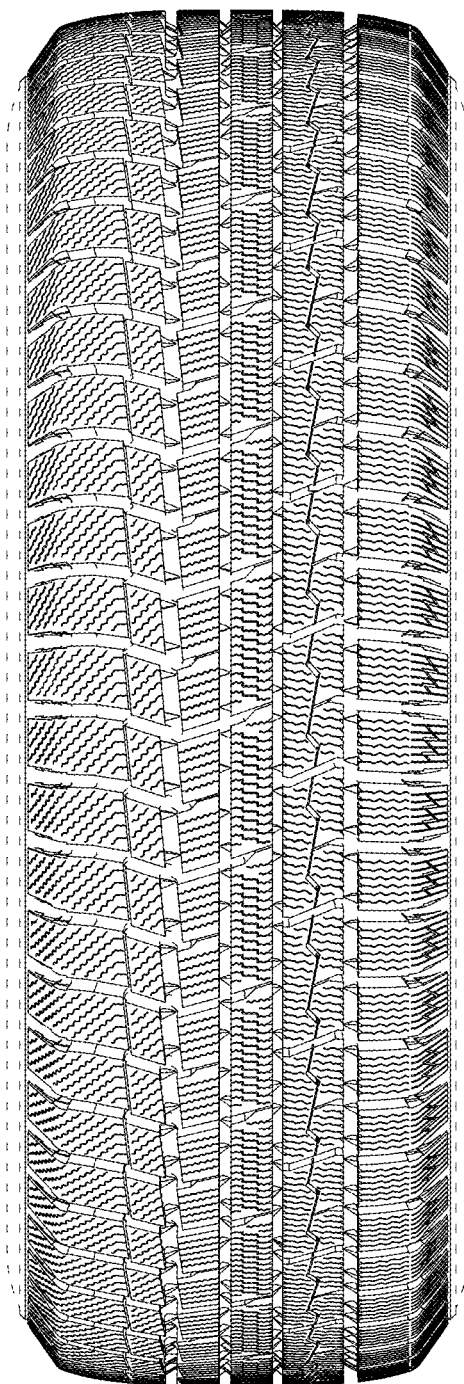

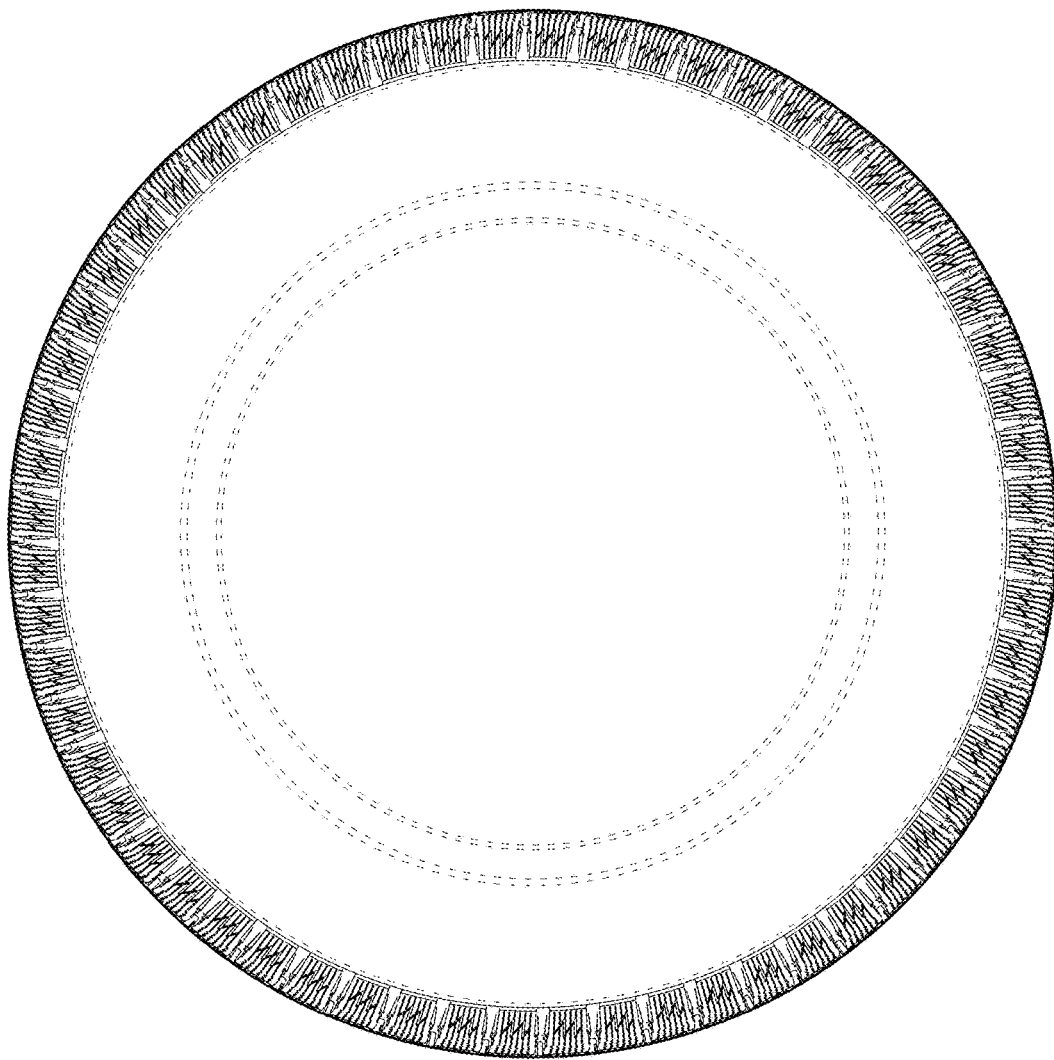

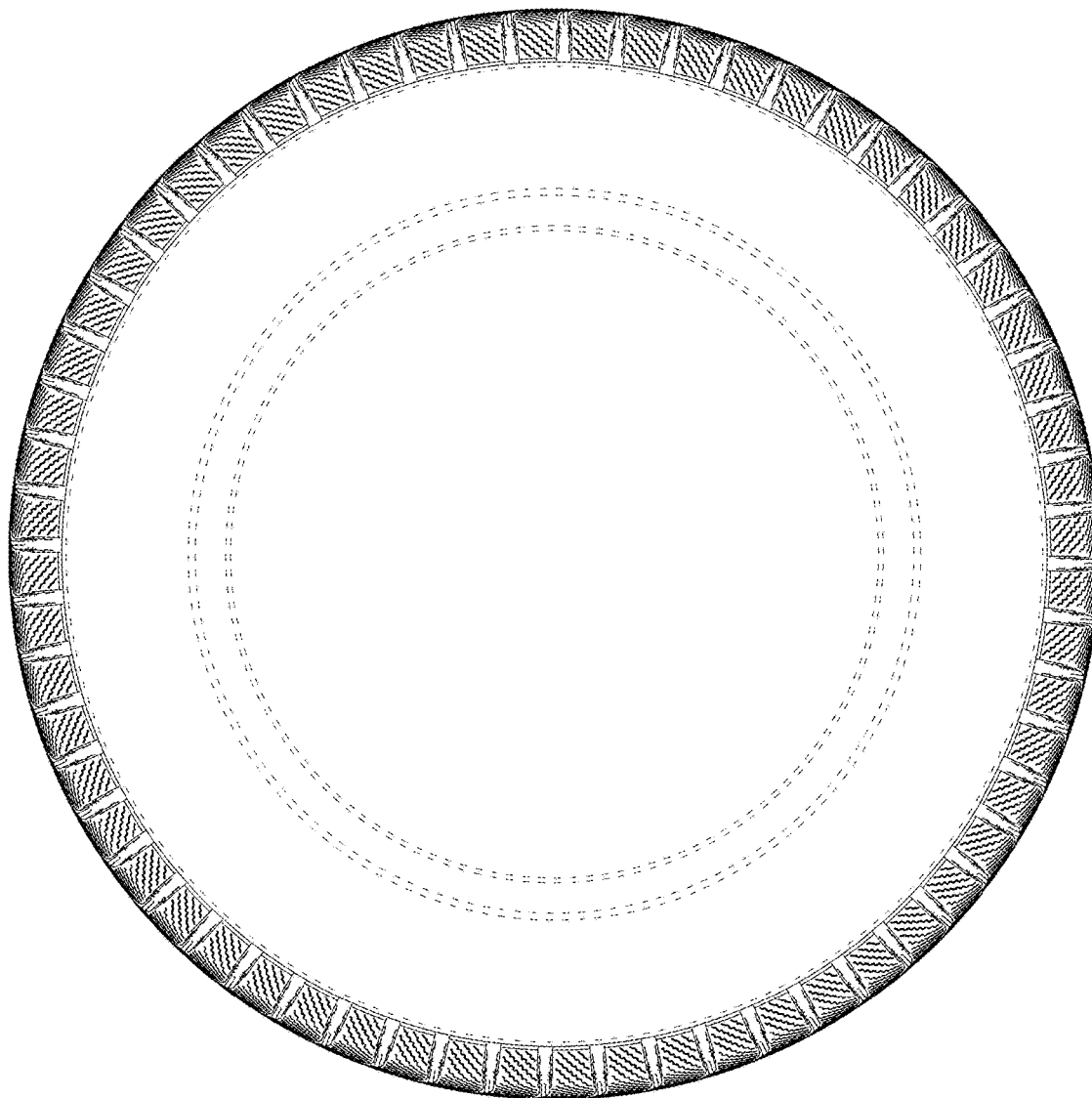

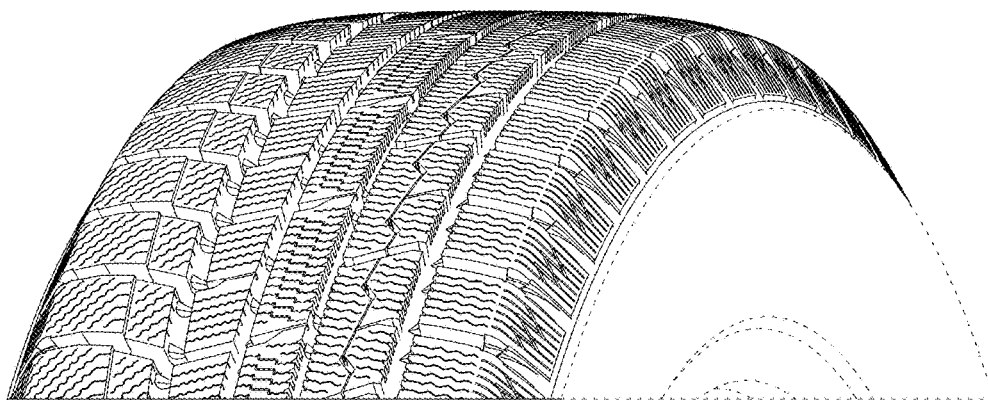

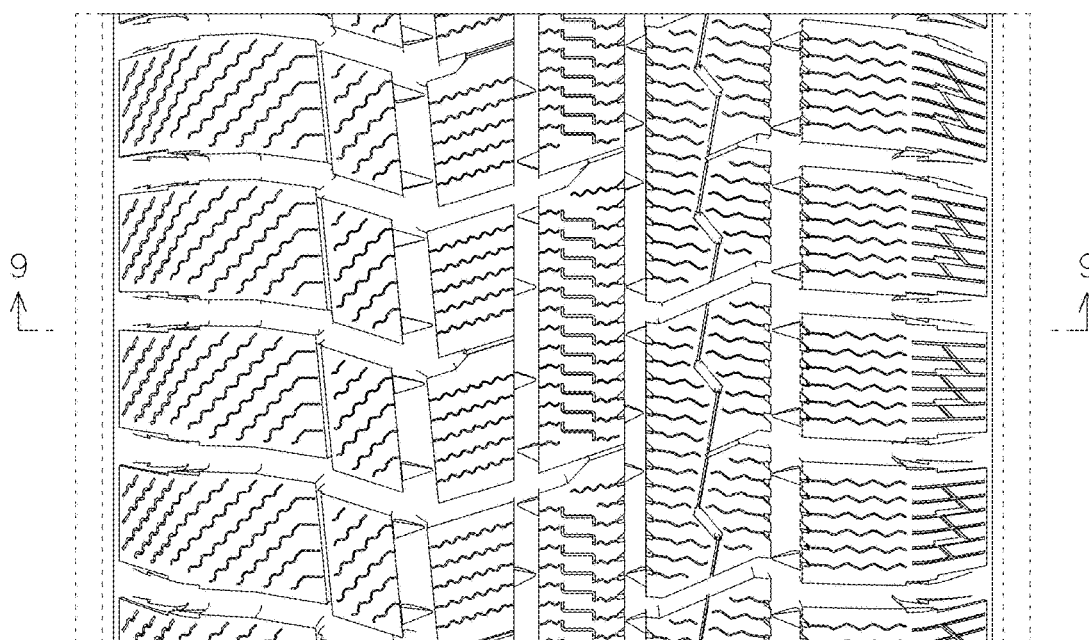

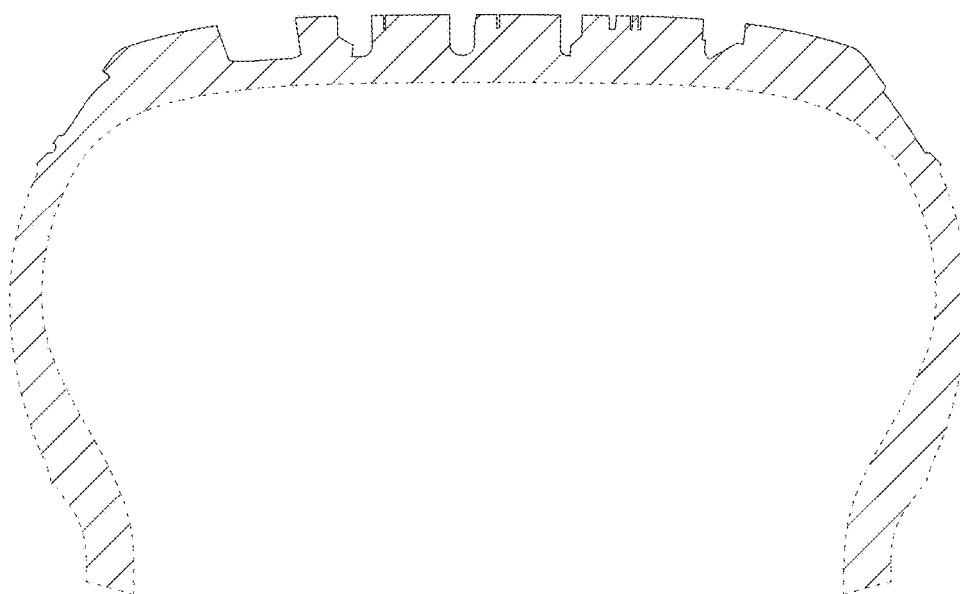
