[57] CLAIM

The ornamental design for a ring bottle opener, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of ring bottle opener showing our new design, everything shown in broken lines is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a right side elevational view thereof, the side opposite being a mirror image; and,

FIG. 6 is a bottom plan view thereof.

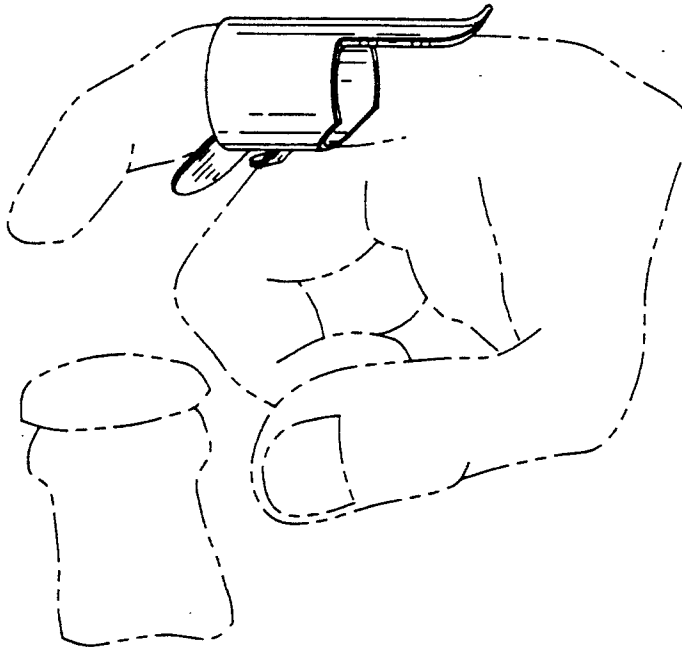

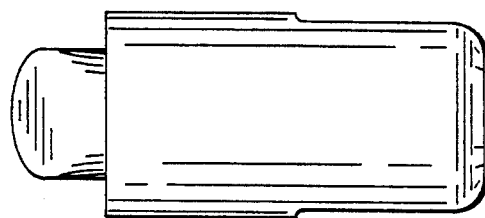
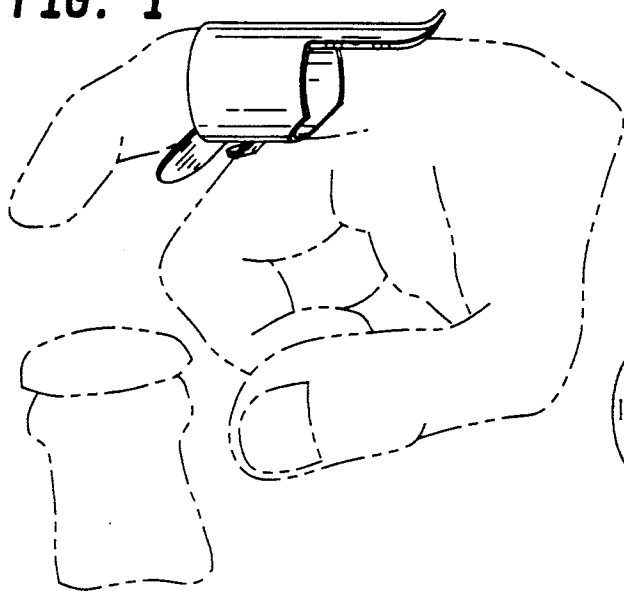

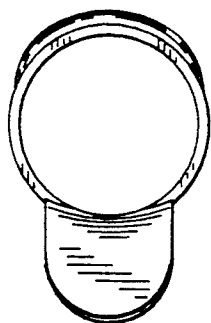

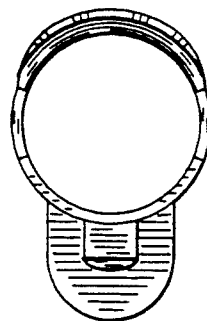

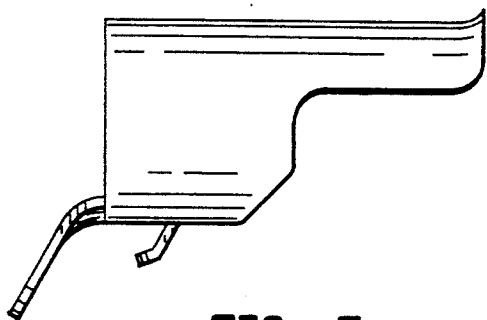

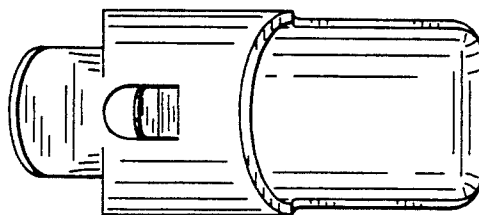
