(57) **CLAIM**

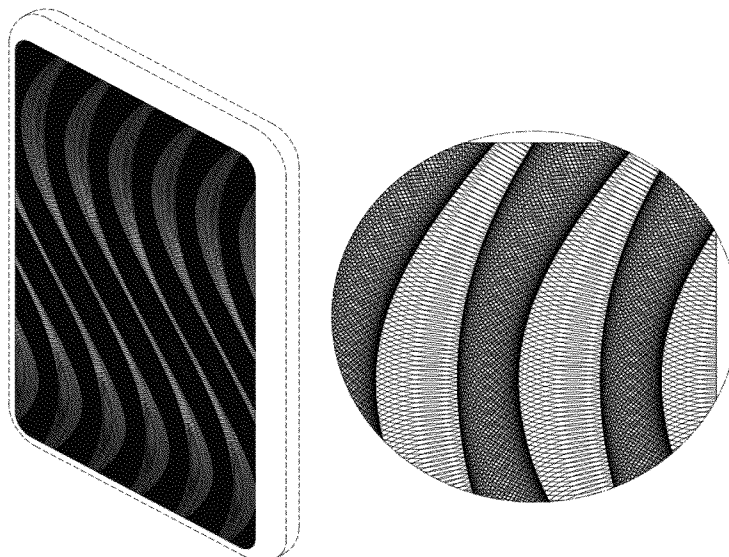
The ornamental design for a cover of an electronic device with surface pattern, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cover of an electronic device with surface pattern showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is an enlarged view thereof, of circled portion 4 in FIG. 2; and, FIG. 5 is a cross-sectional view thereof, along line 5-5 in FIG. 2.

In FIGS. 1-3 and 5, the evenly segmented broken lines indicate portions of the cover of an electronic device with surface pattern that form no part of the claimed design. In FIGS. 2 and 4, the alternating long-dash short-dash type broken lines represent the boundary of the portion of the cover of an electronic device with surface pattern that is shown on an enlarged scale in FIG. 4. The broken lines form no part of the claimed design.

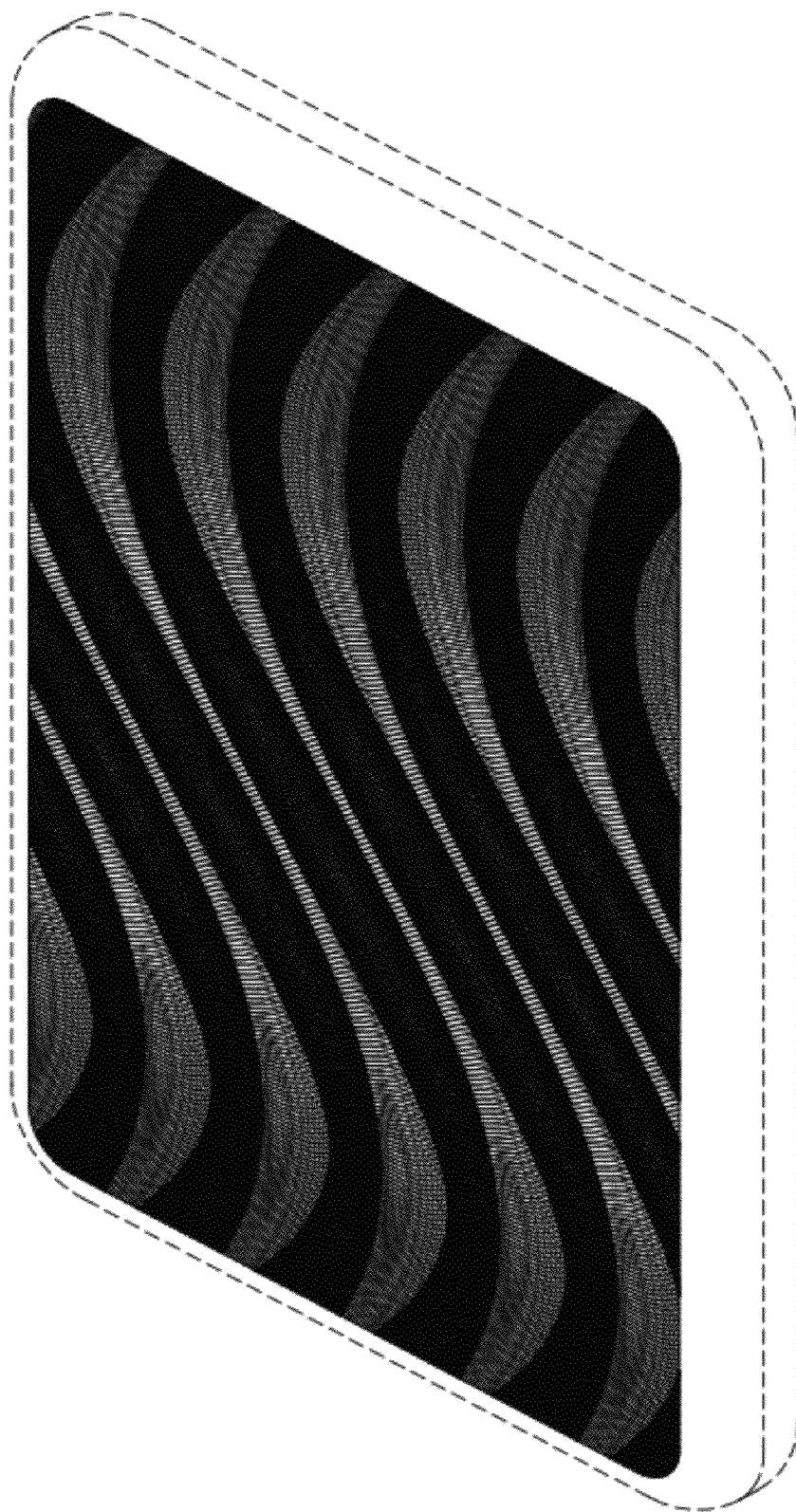
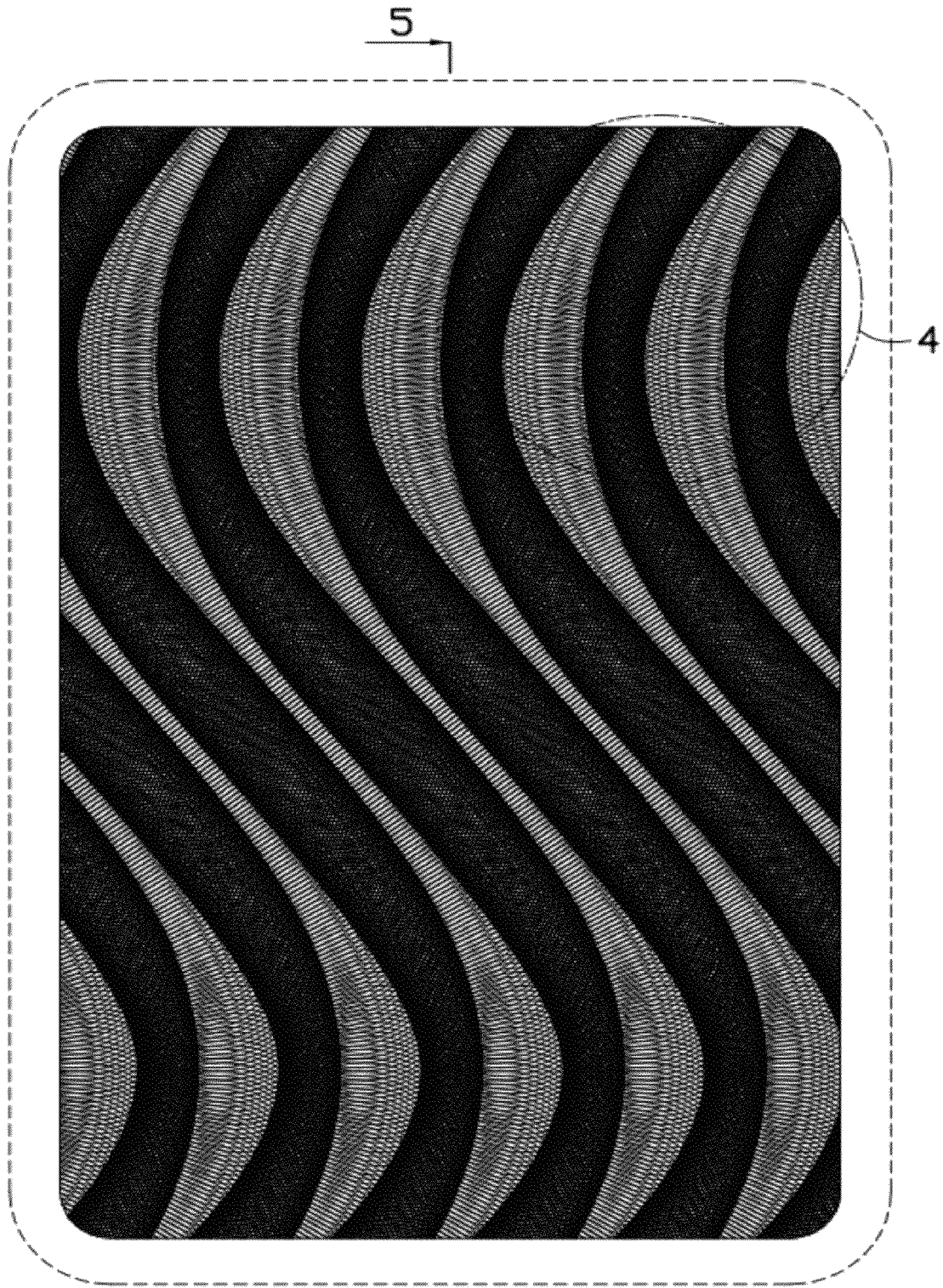

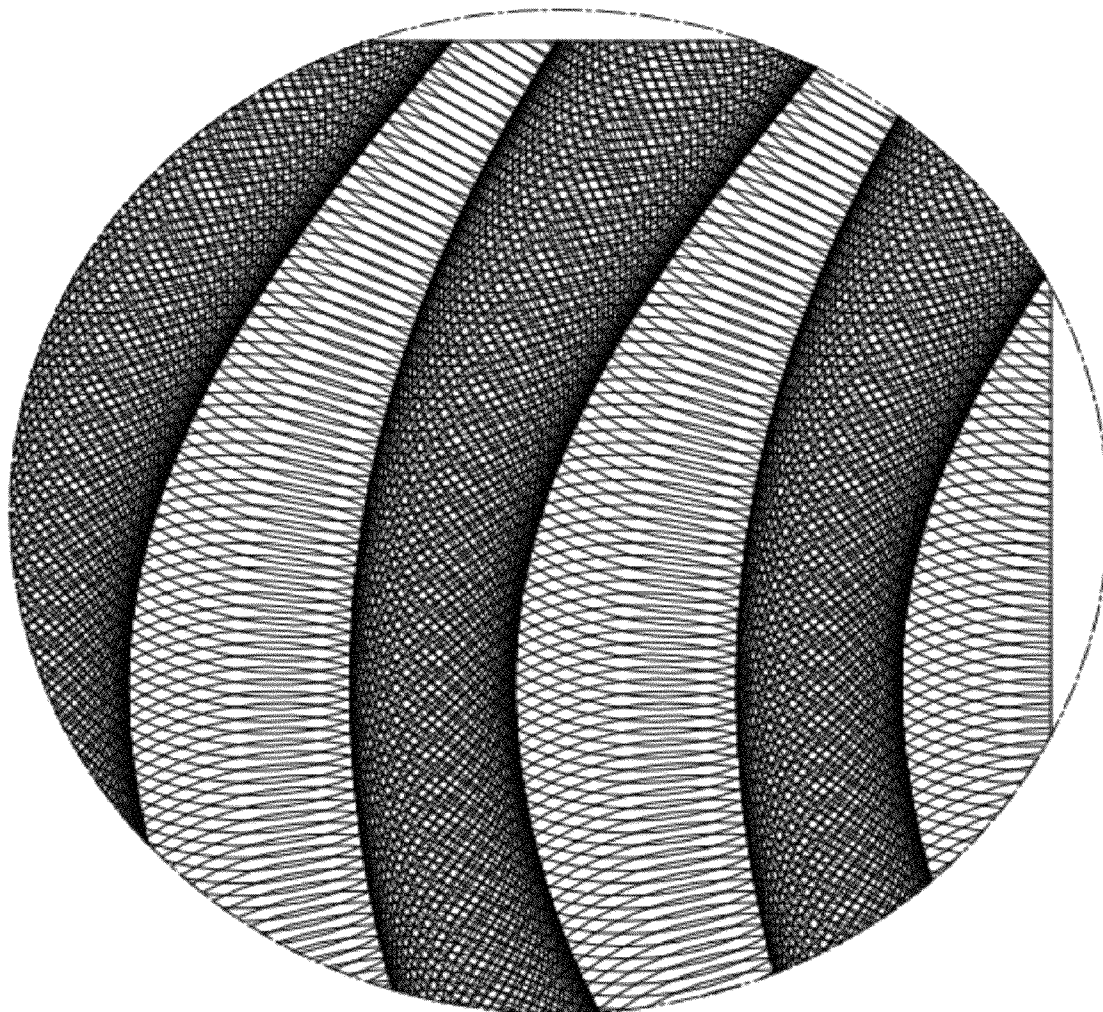

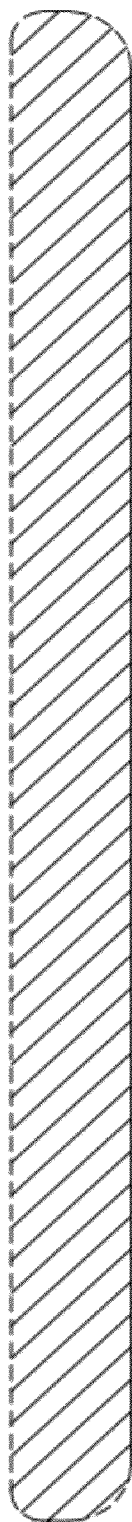
