
(57) **CLAIM**

The ornamental design for a miniature dome camera, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a miniature dome camera; FIG. 2 is a front elevation view of the dome camera of FIG. 1; FIG. 3 is a rear elevation view of the dome camera of FIG. 1; FIG. 4 is a right side elevation view of the dome camera of FIG. 1; FIG. 5 is a left side elevation view of the dome camera of FIG. 1; FIG. 6 is a top plan view of the dome camera of FIG. 1; and FIG. 7 is a bottom plan view of the dome camera of FIG. 1. The dashed lines in the drawings represent portions of the miniature dome camera that do not form part of the claimed design.














