The ornamental design for a watch casing and bezel, as shown and described.

**DESCRIPTION**

- FIG. 1 is a perspective view of a watch casing and bezel showing my new design;
- FIG. 2 is a left side elevational view thereof;

- FIG. 4 is a right side elevational view thereof;

- FIG. 7 is a bottom plan view.

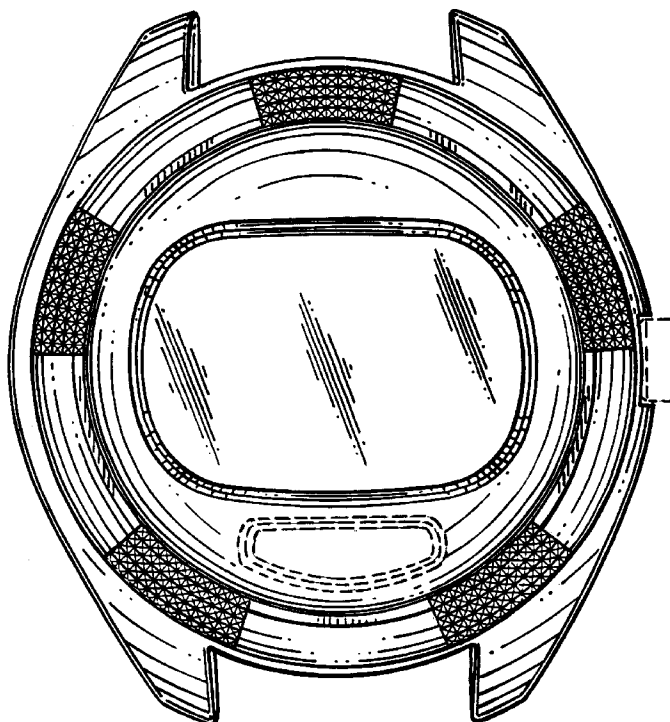

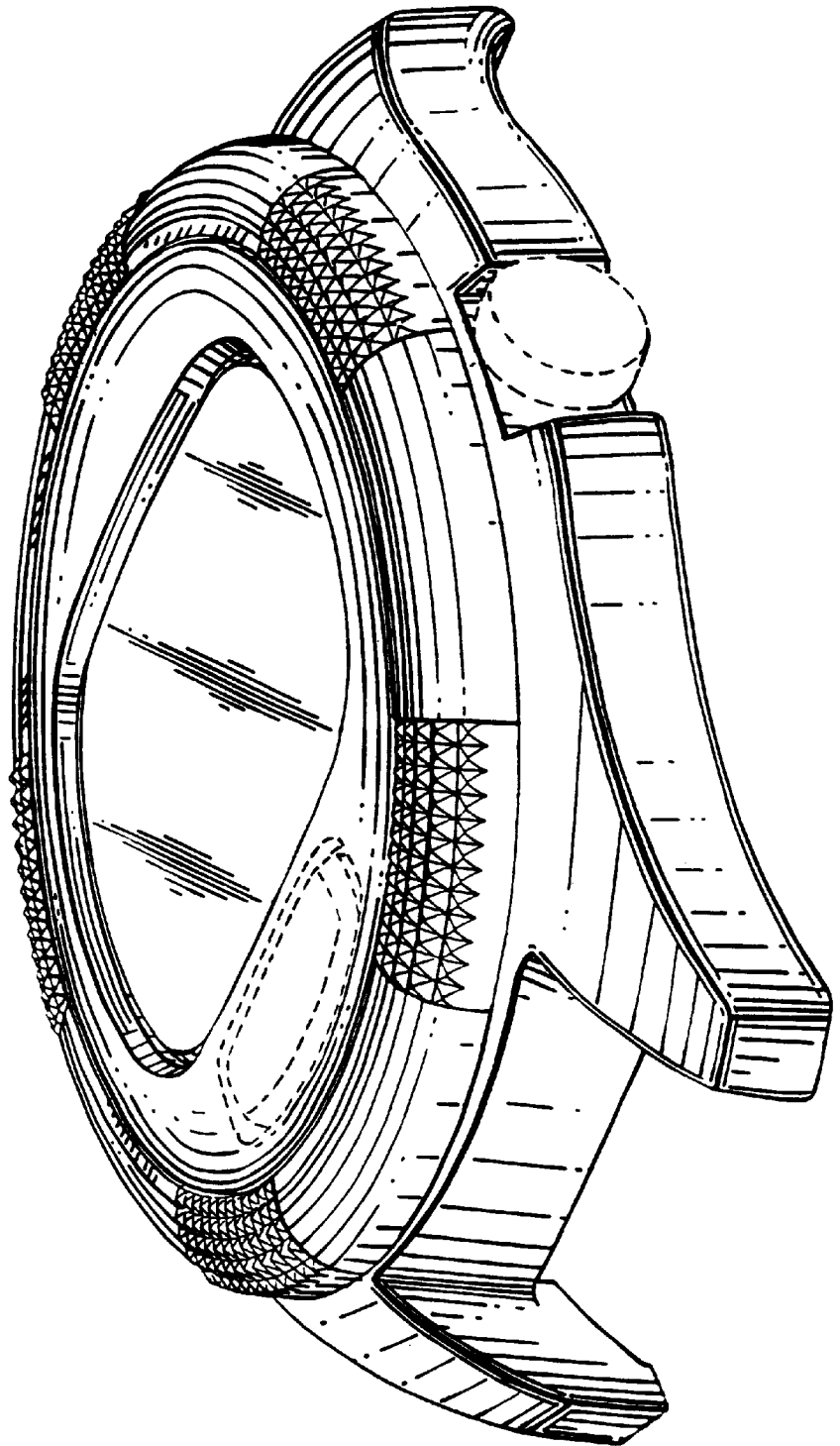

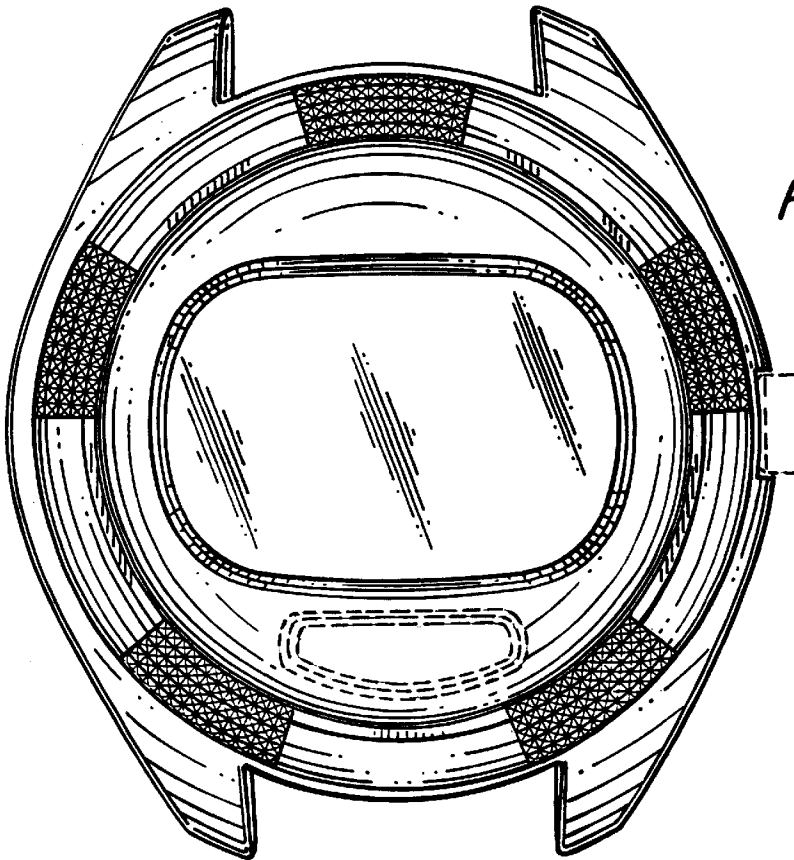
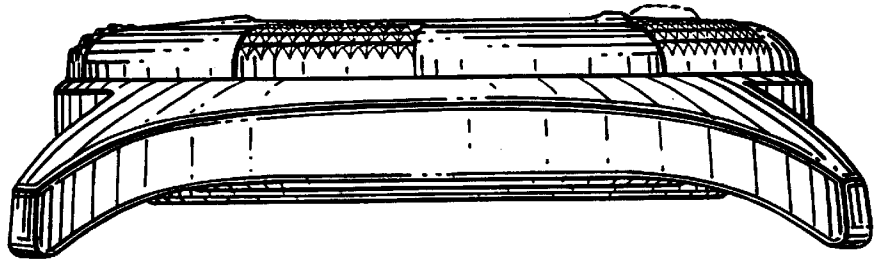

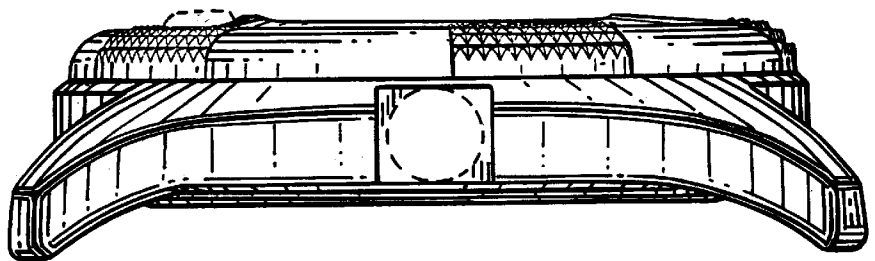

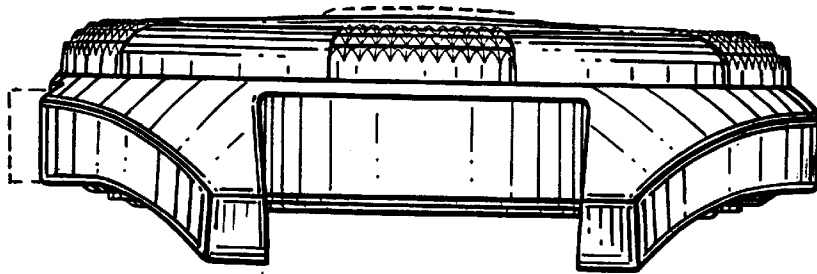
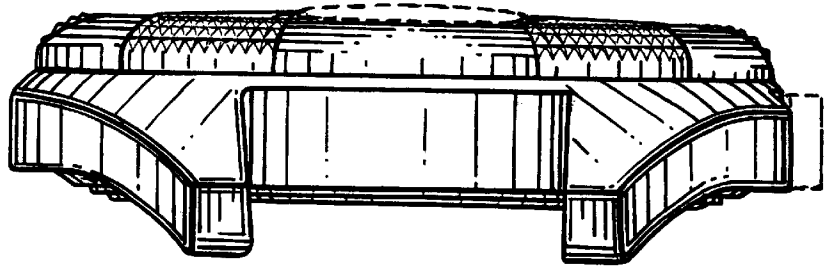
