DESCRIPTION


FIG. 1 is a perspective view of tubular packaging for a door knob assembly;

FIG. 2 is a top view thereof (the bottom view being identical to the top);

FIG. 3 is a front view thereof (the back, right, and left side views being identical to the front); and,






