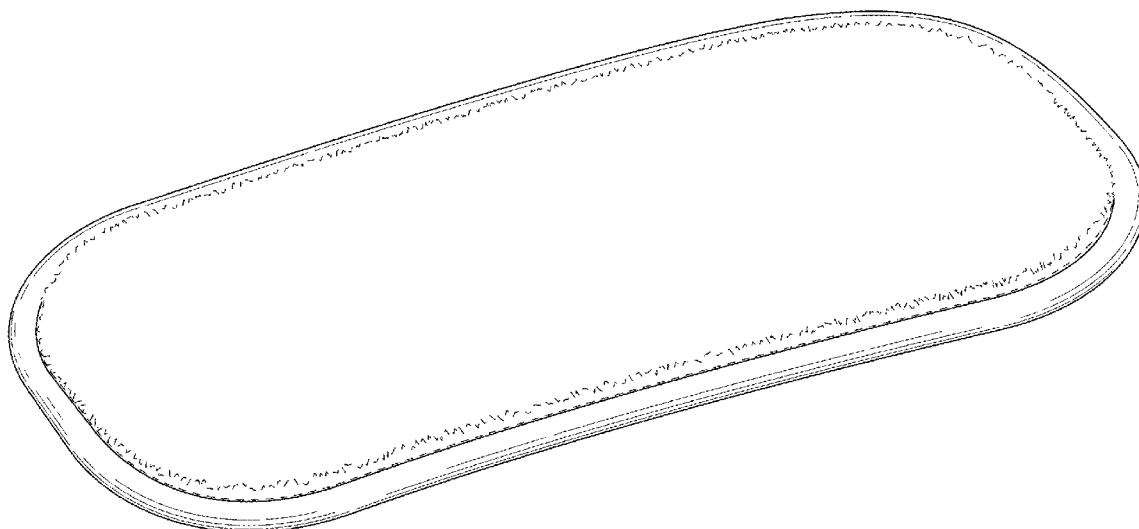
(57) **CLAIM**  
The ornamental design for a facial cleansing pad, as shown and described.

**DESCRIPTION**

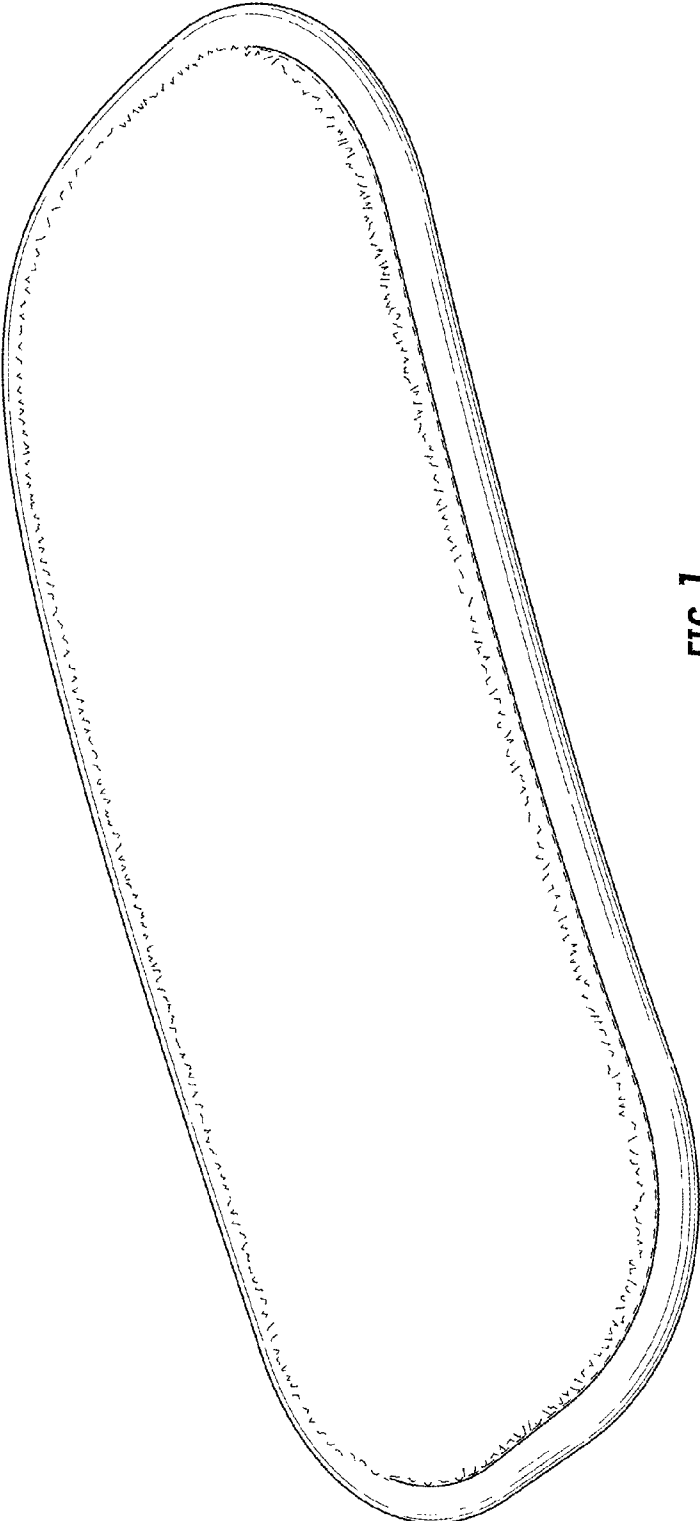

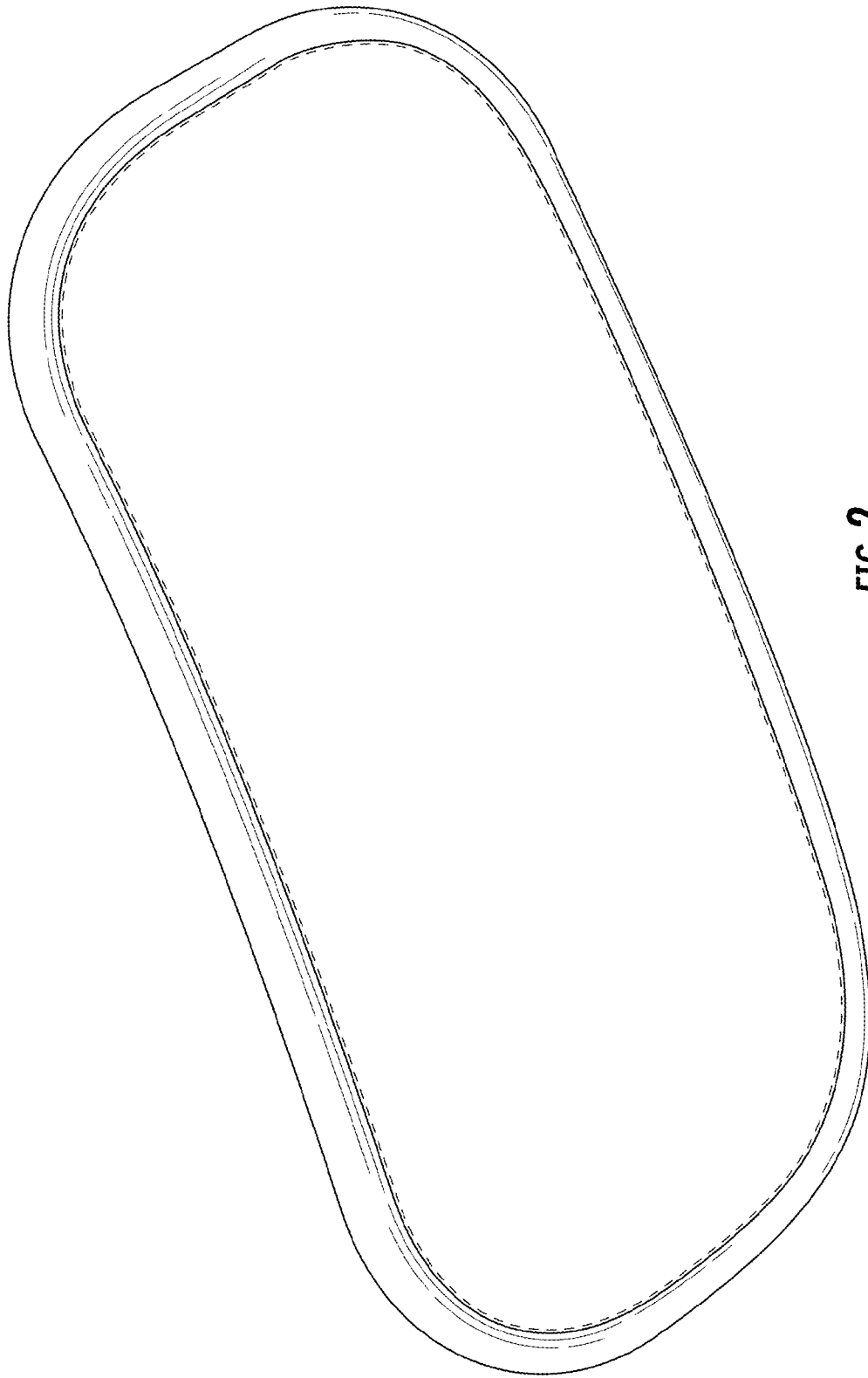

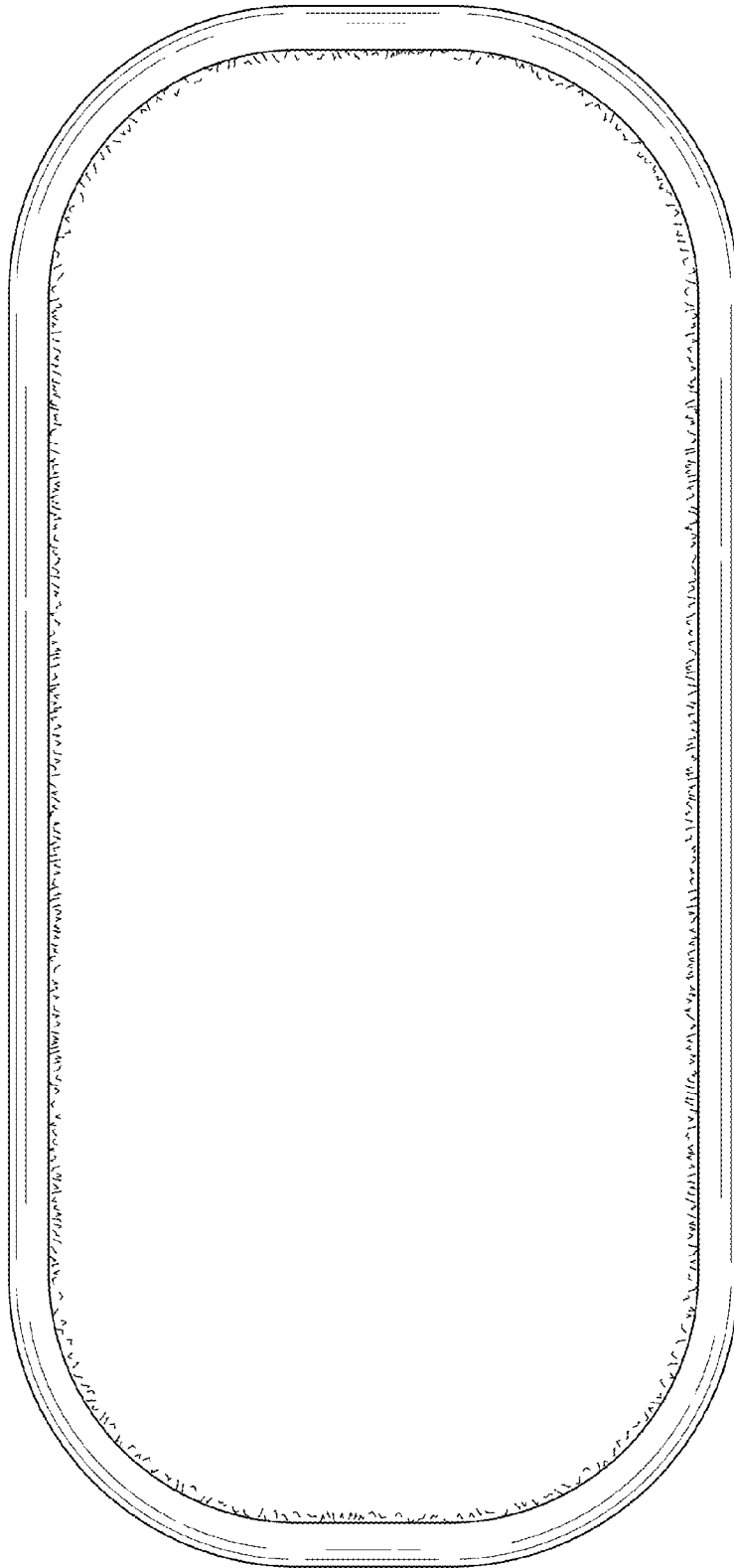
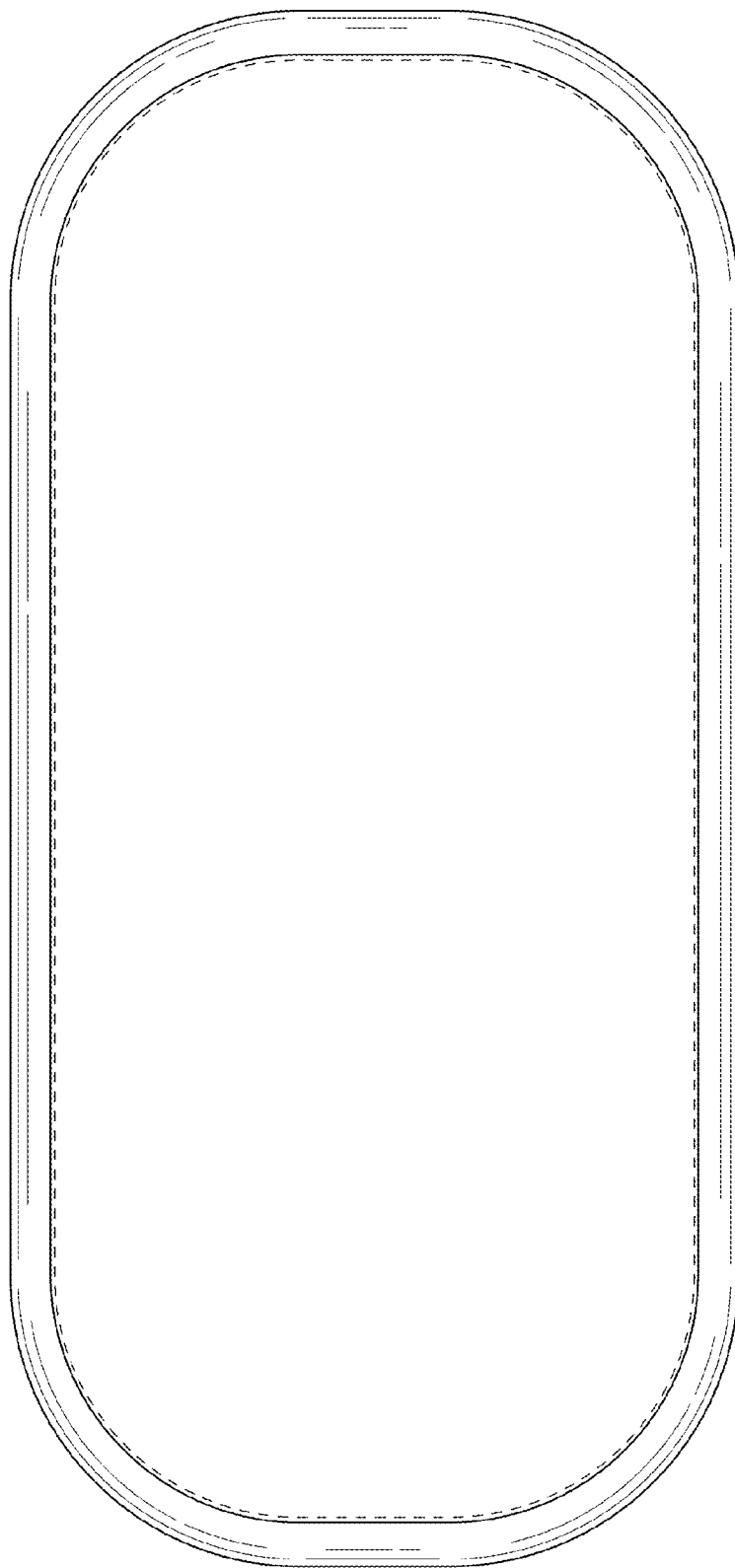
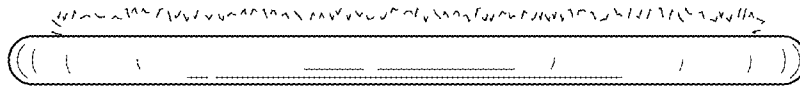


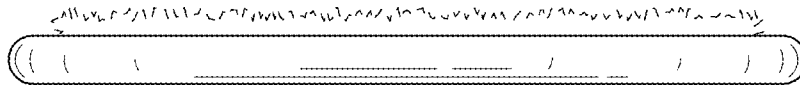

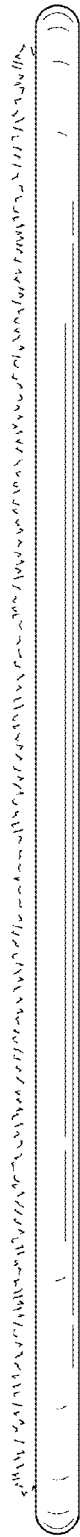

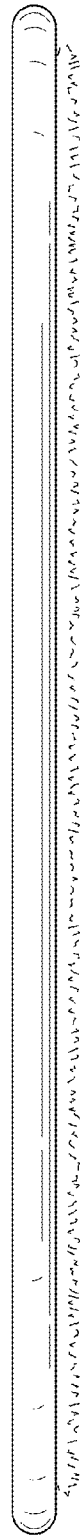
