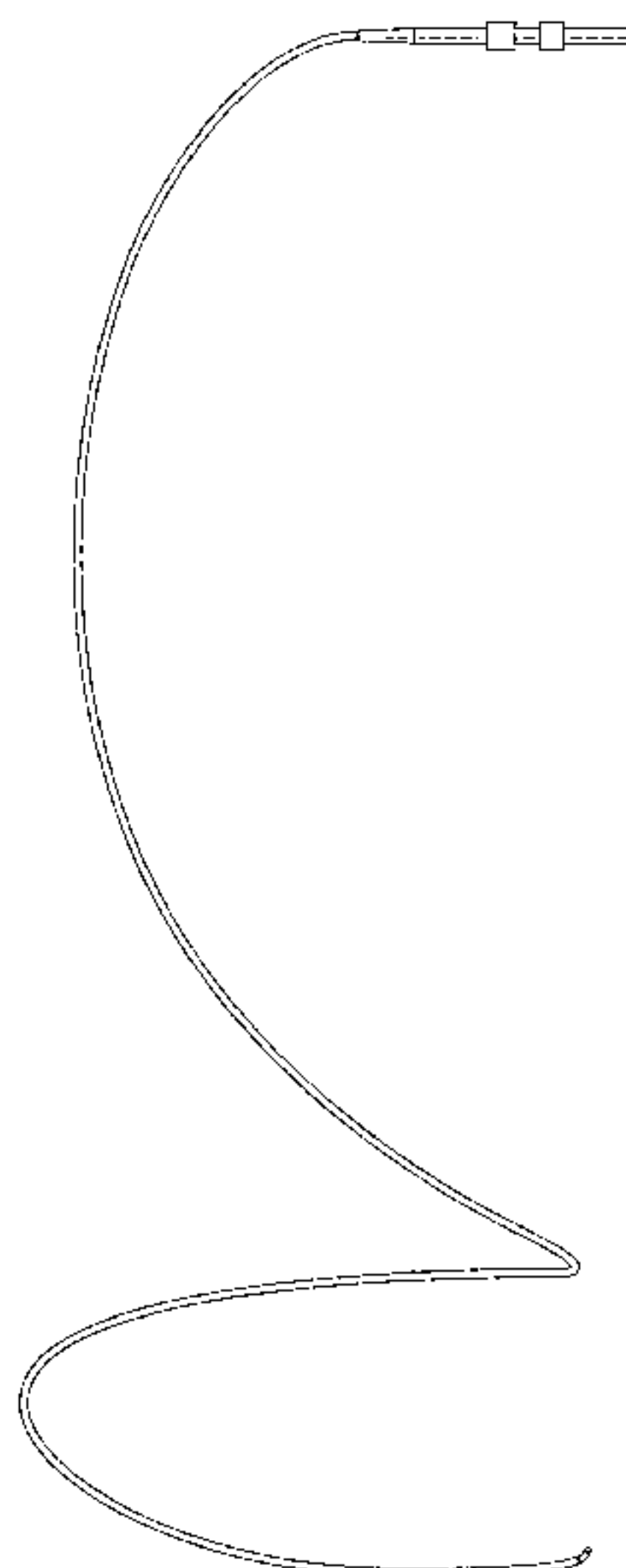
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a catheter showing my new design;
FIG. 2 is a rear view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is an enlarged view of a portion defined by lines 7-7
shown in FIG. 4;
FIG. 8 is an enlarged cross sectional view of a portion
defined by lines 8-8 shown in FIG. 7; and,
FIG. 9 is a reference view showing a state where the catheter
is flattened.

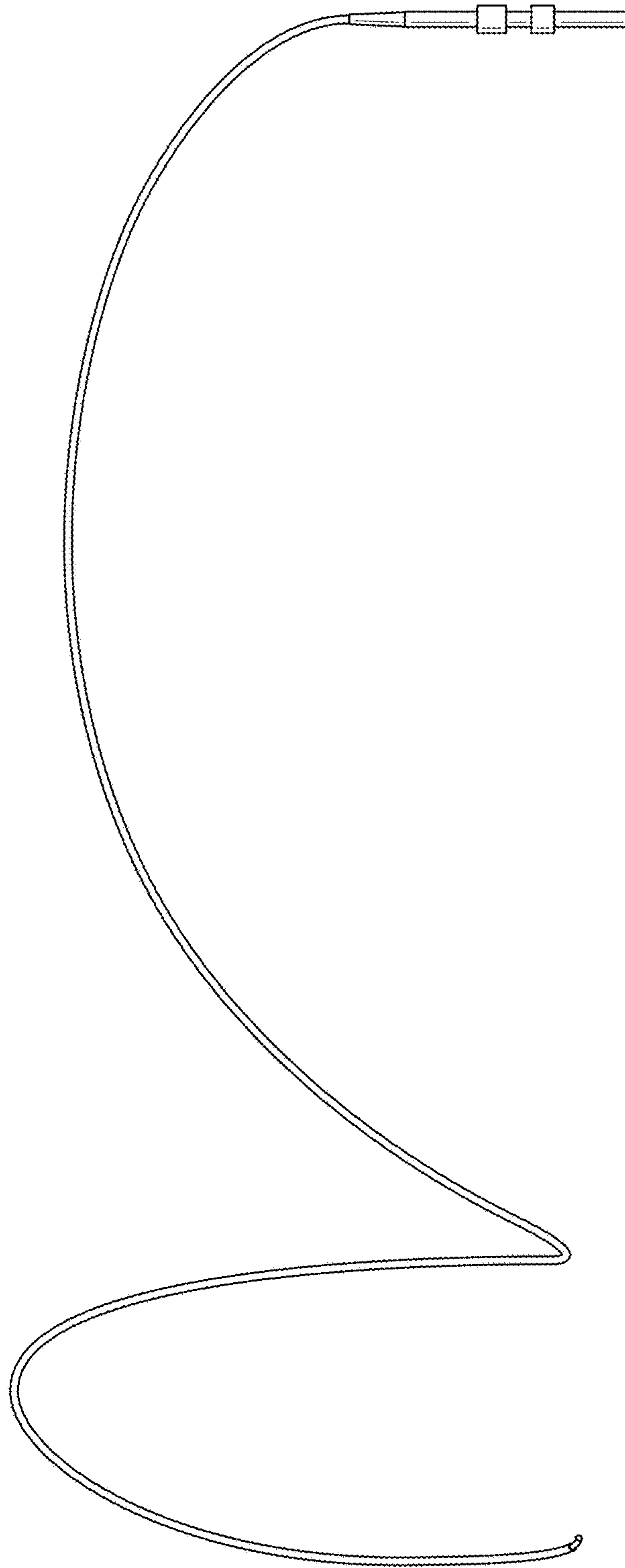

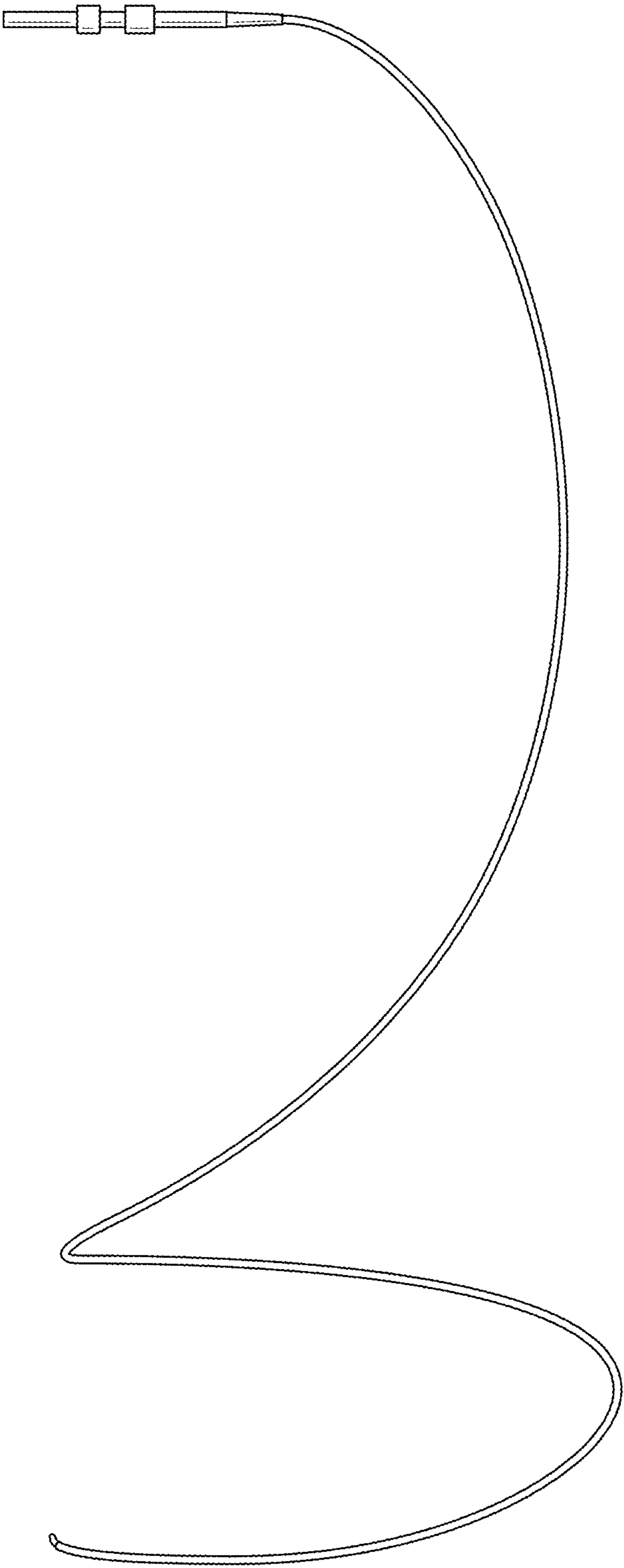

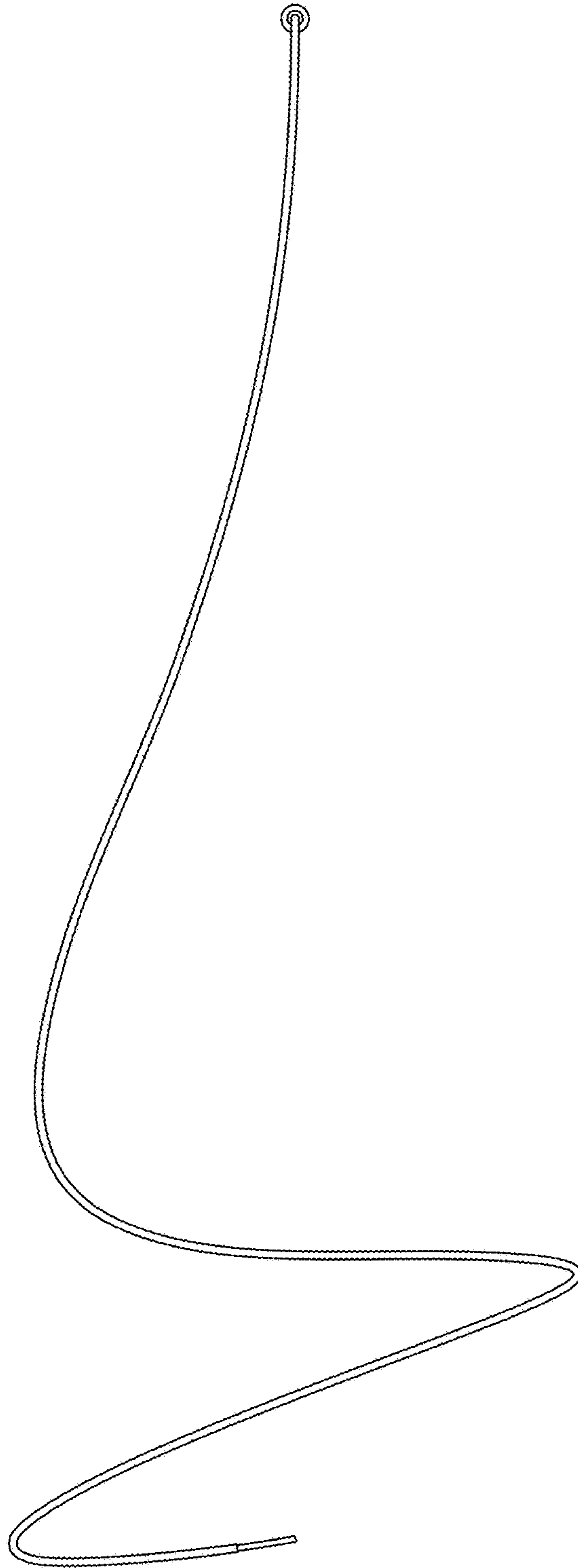

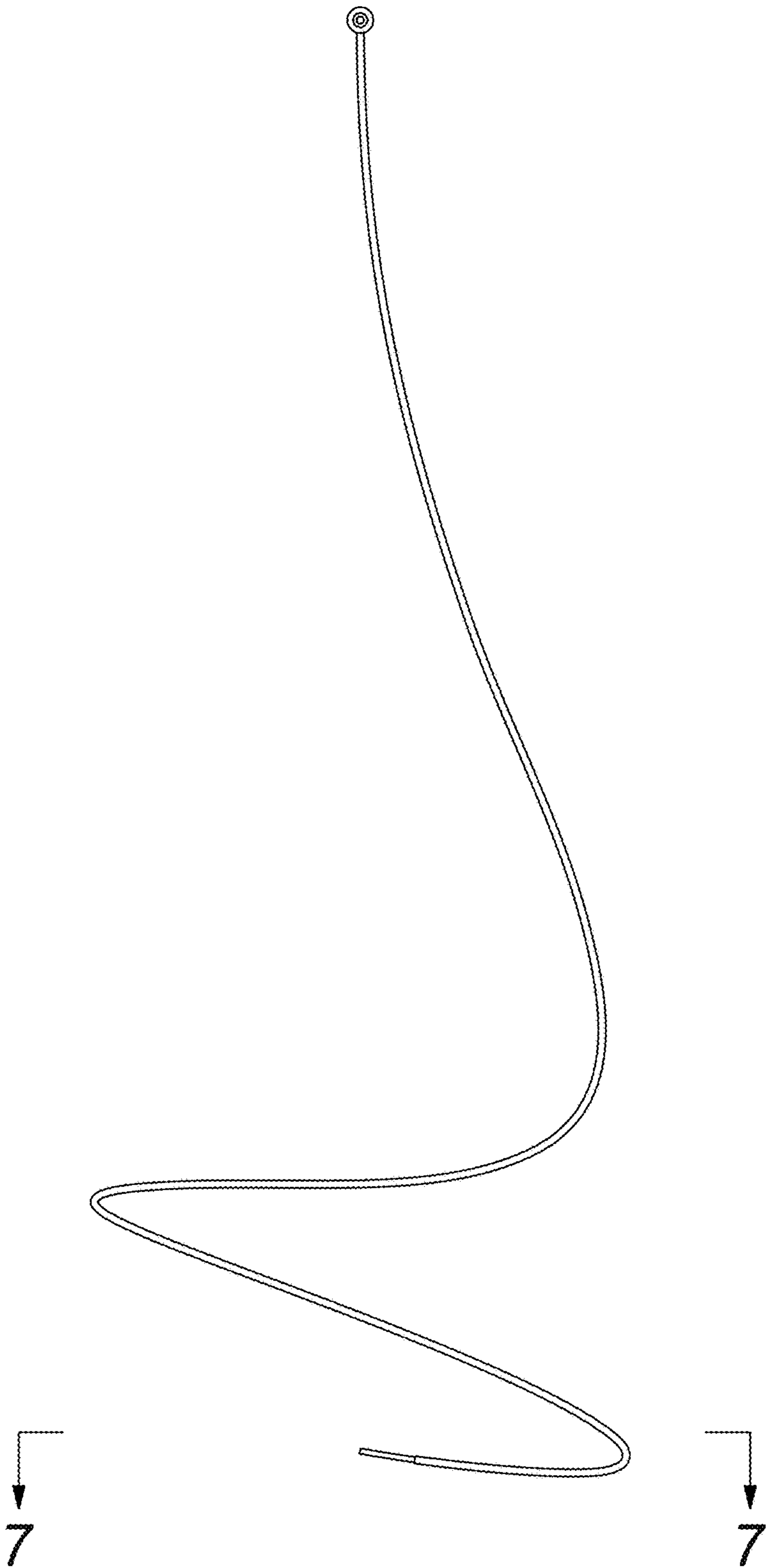

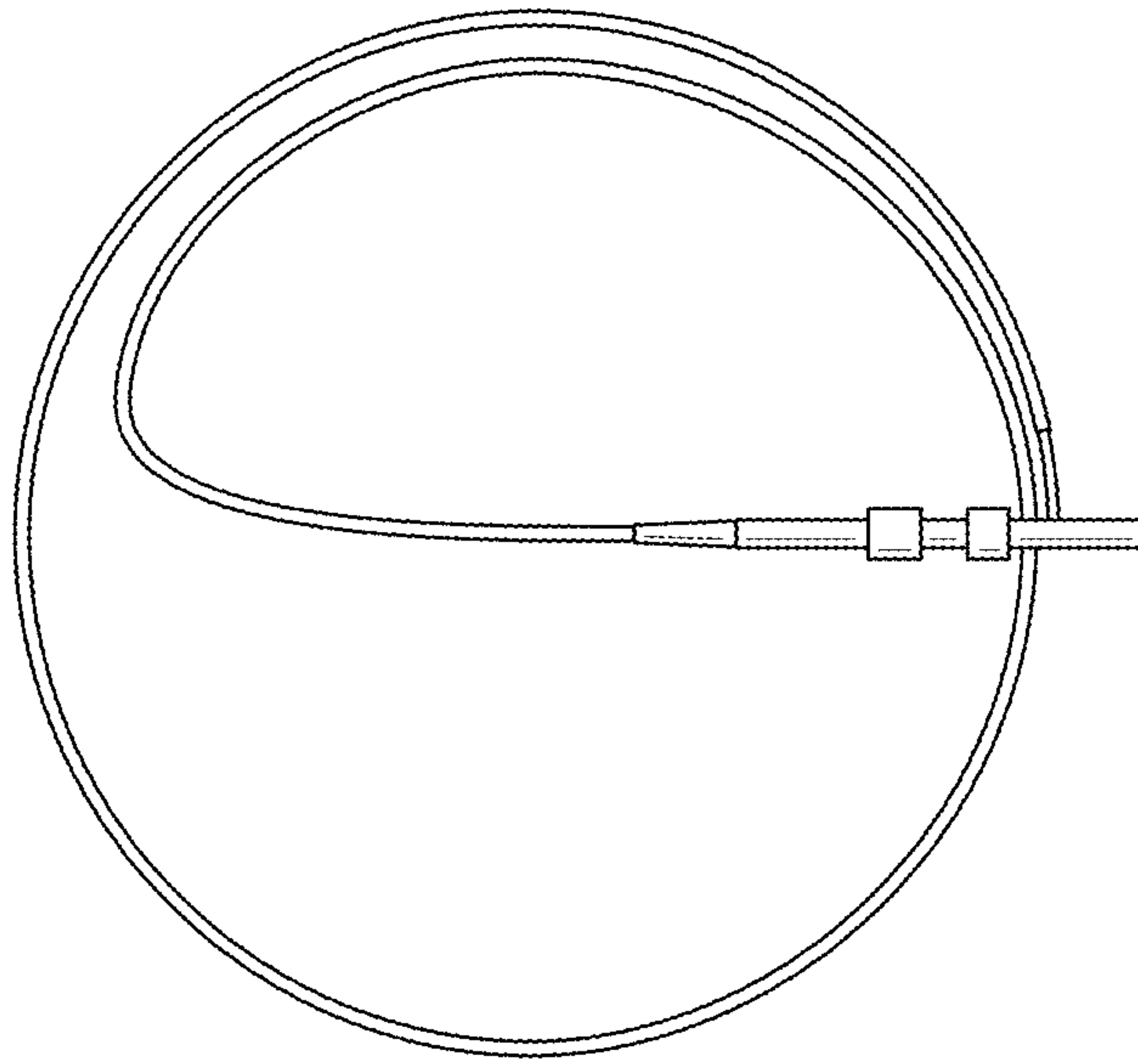

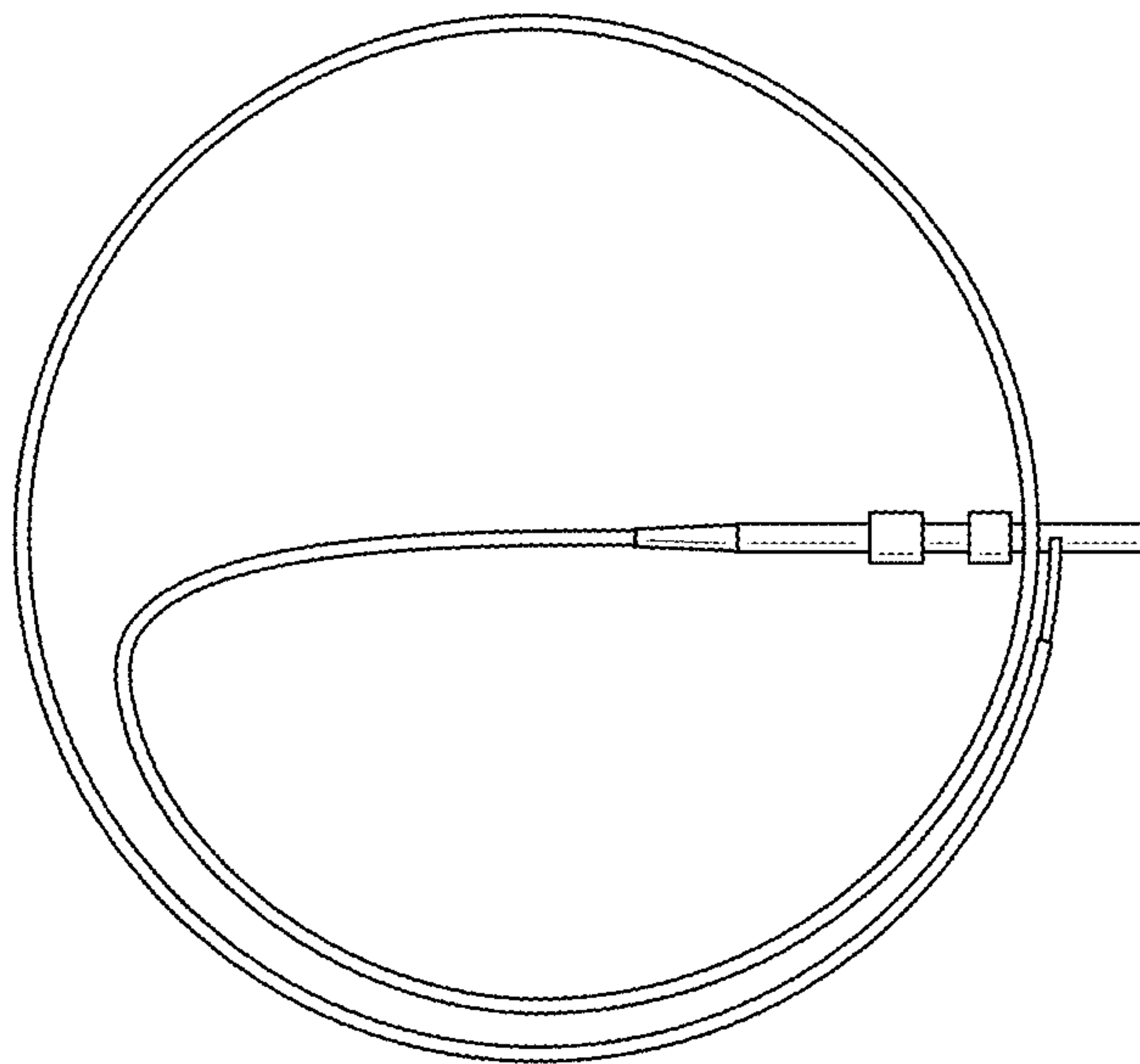

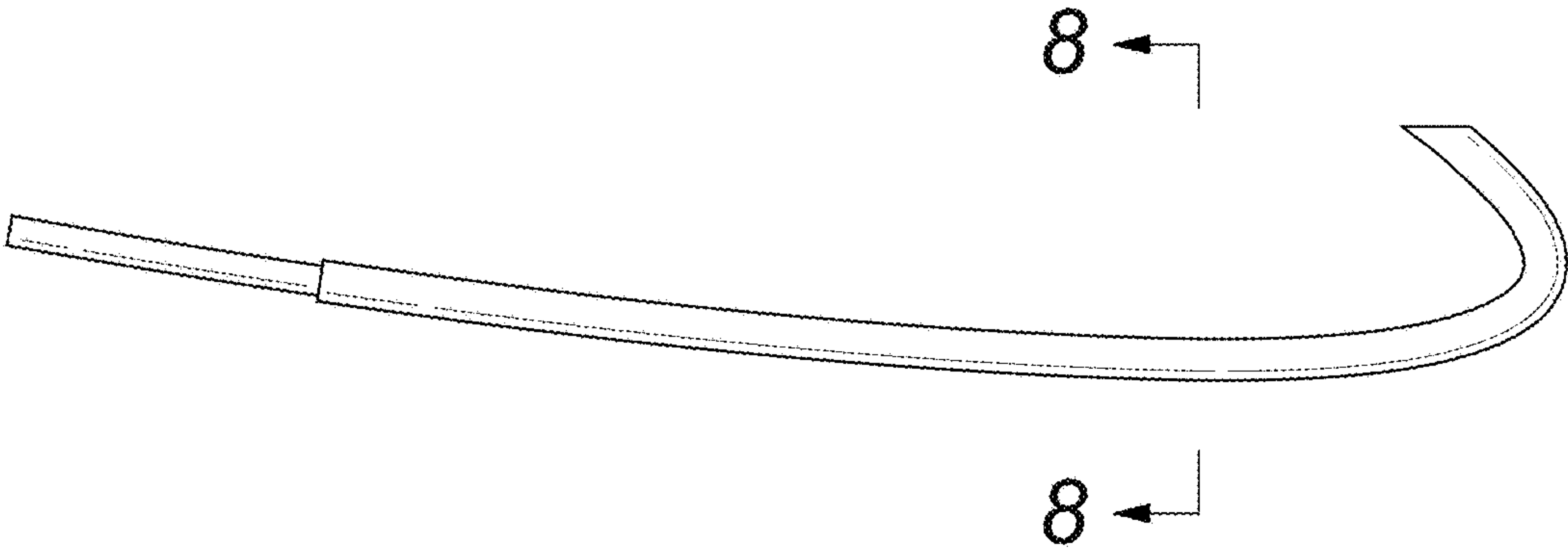

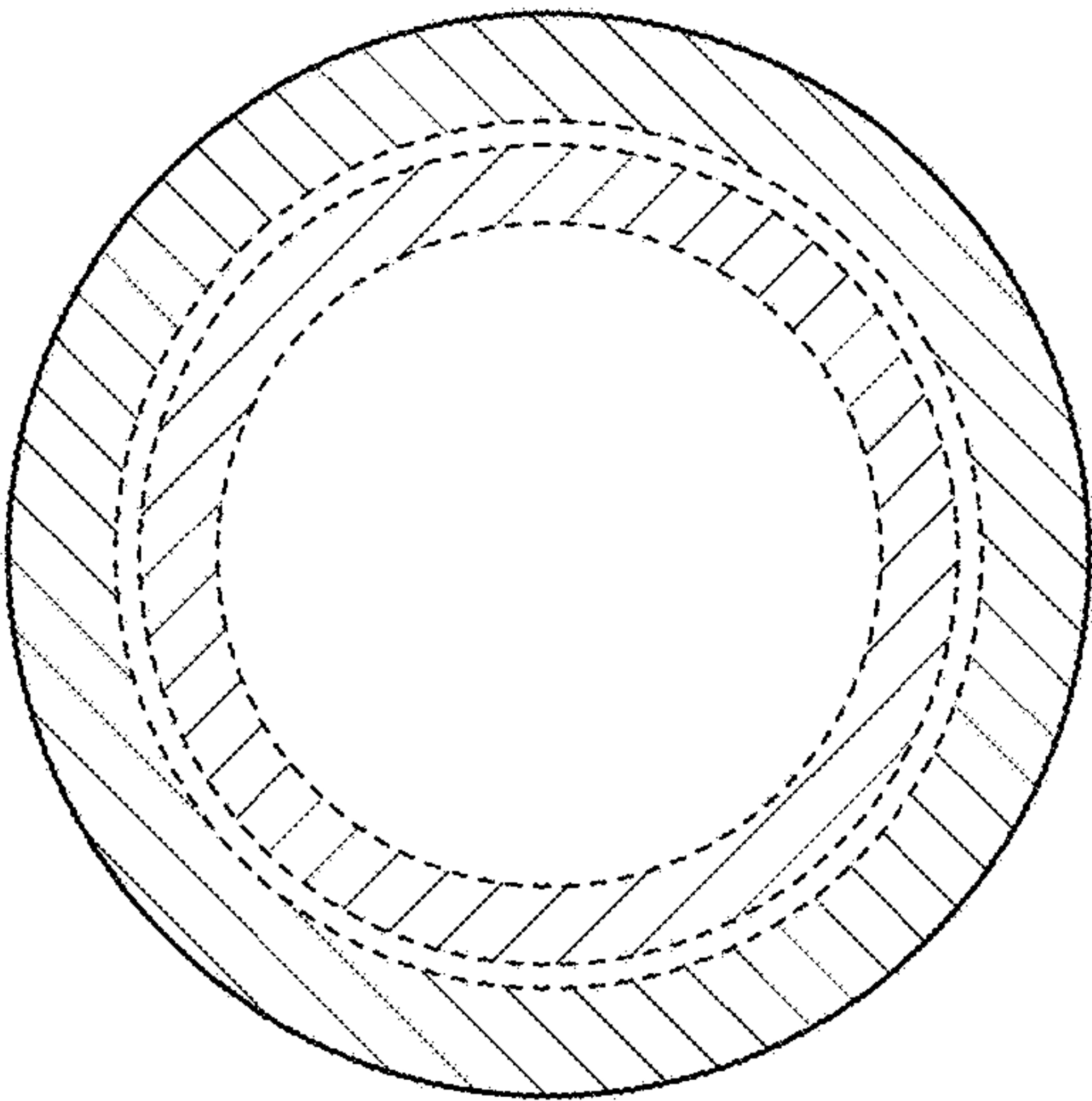

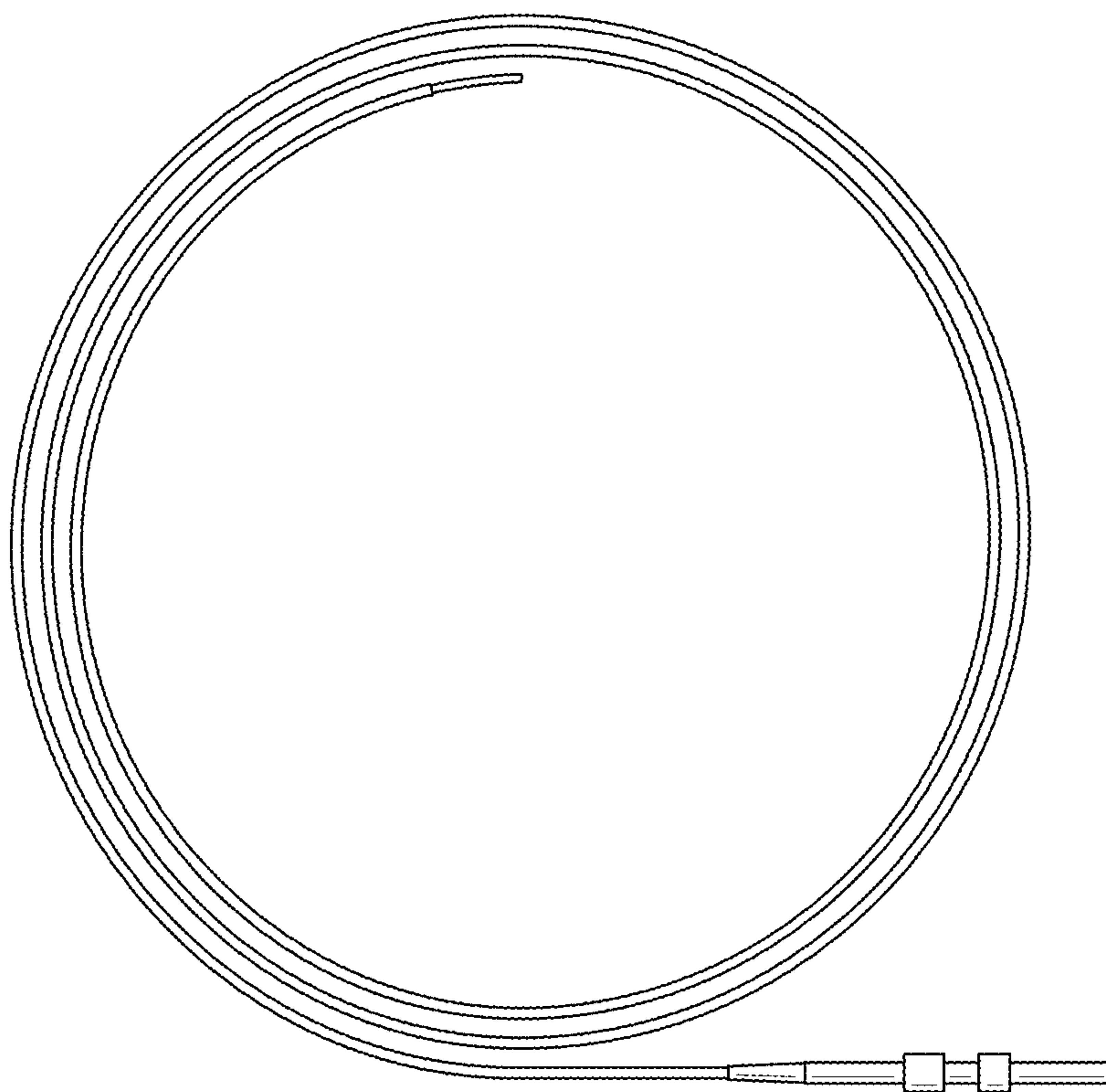
