FIG. 6 is a top perspective view thereof.

The broken line showing of the wireless phone set is included for the purpose of illustrating portions of the article and forms no part of the claimed design.

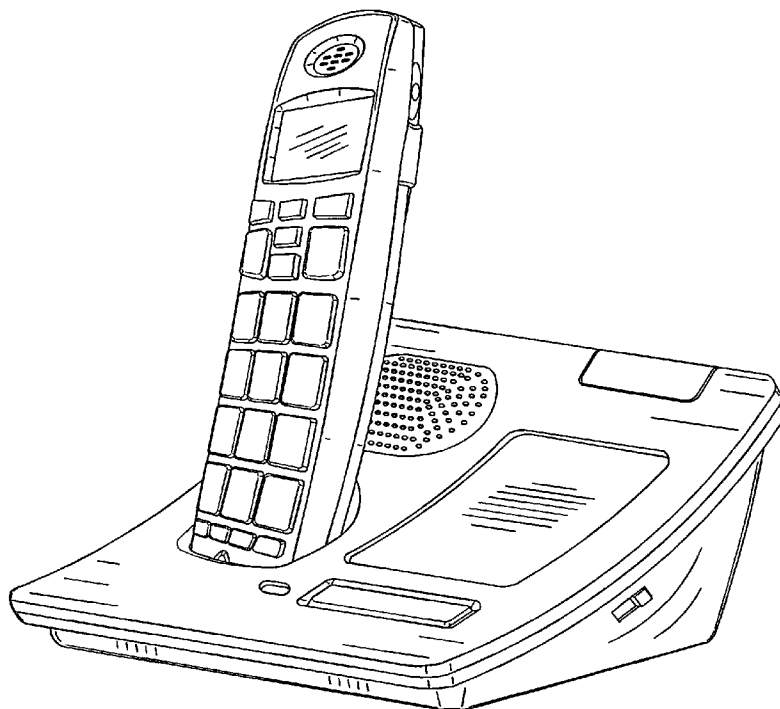

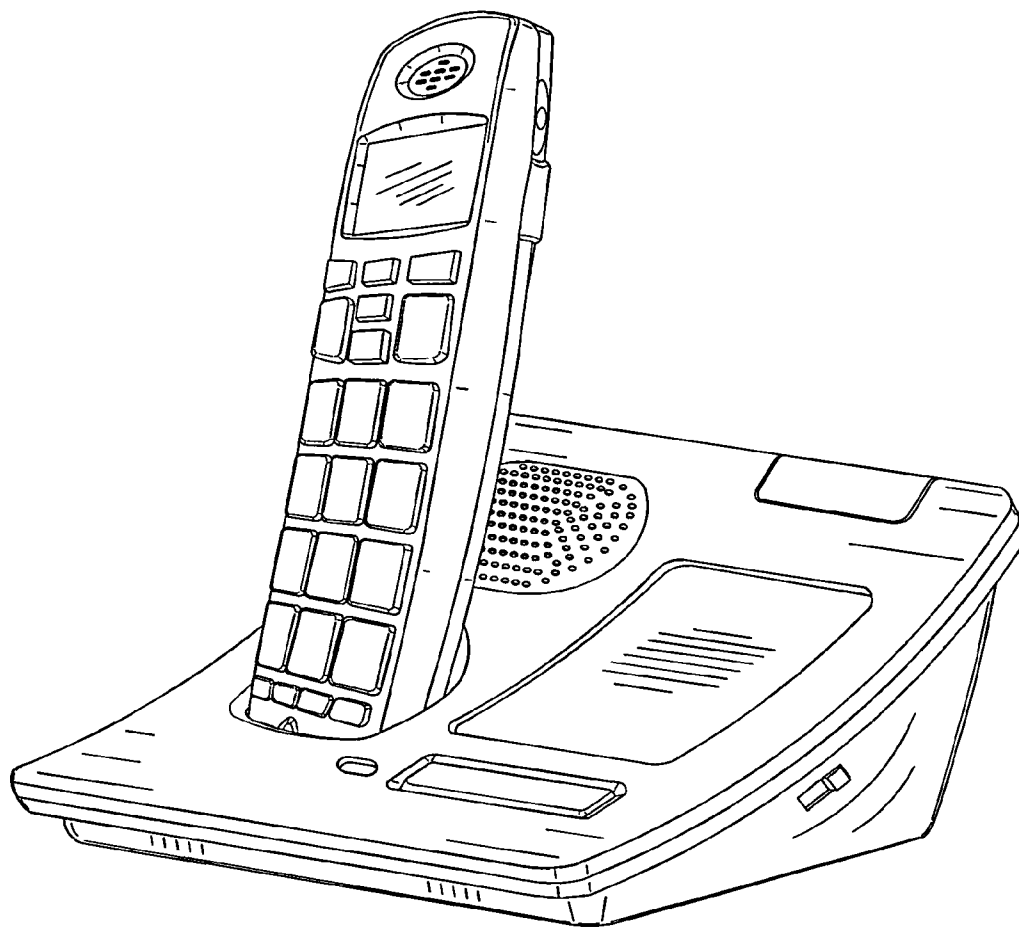

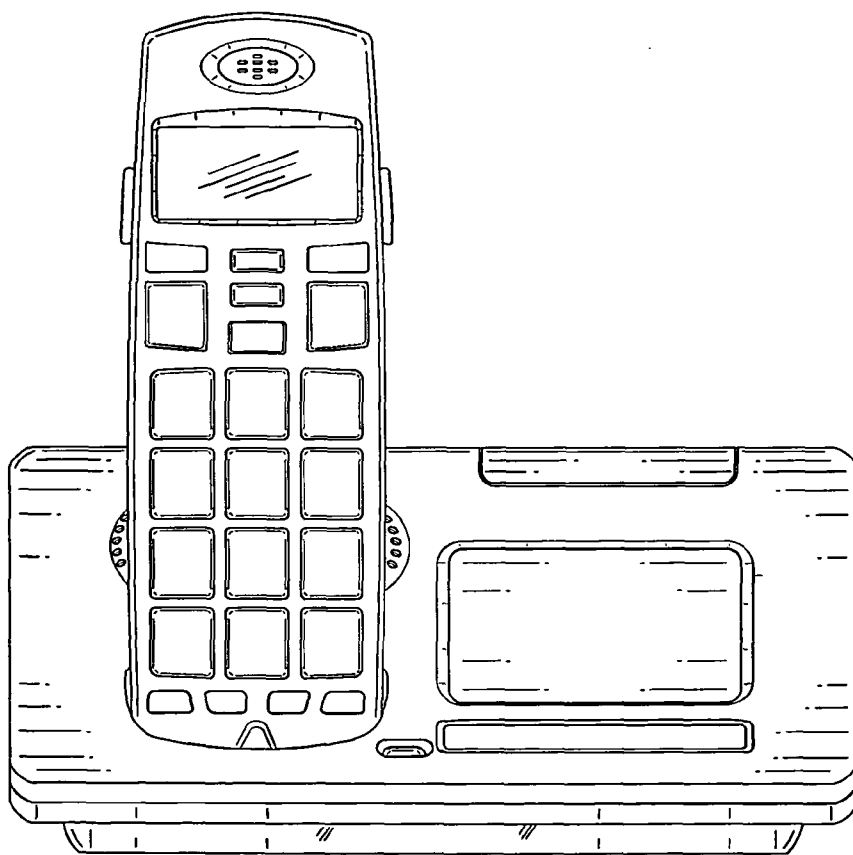

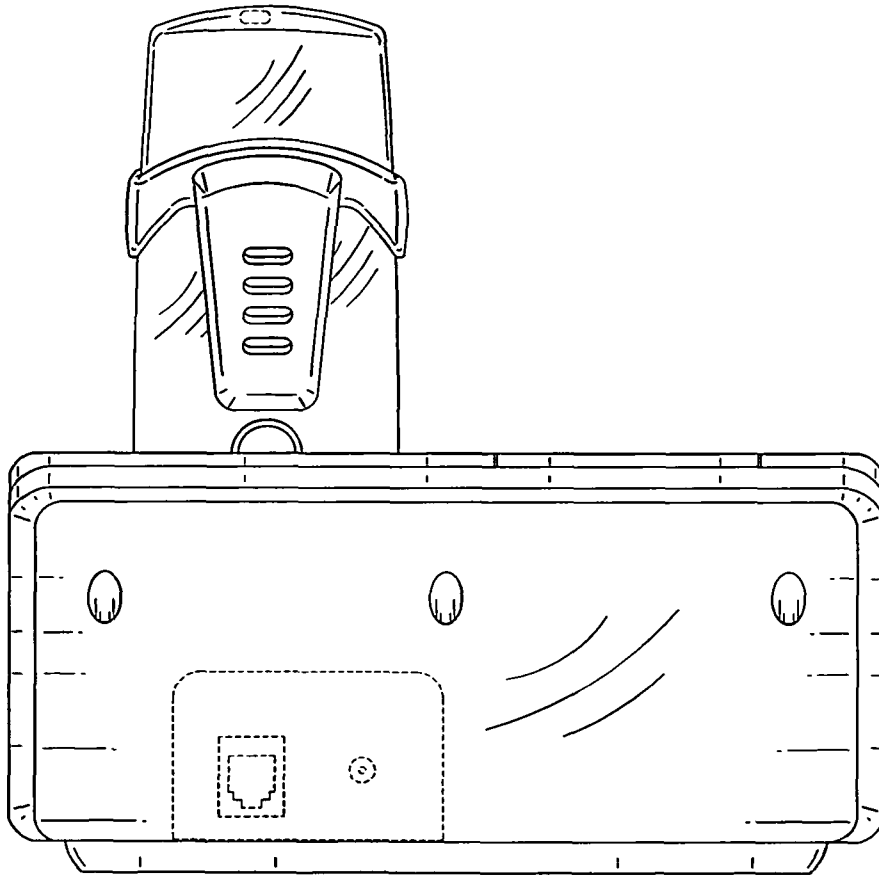

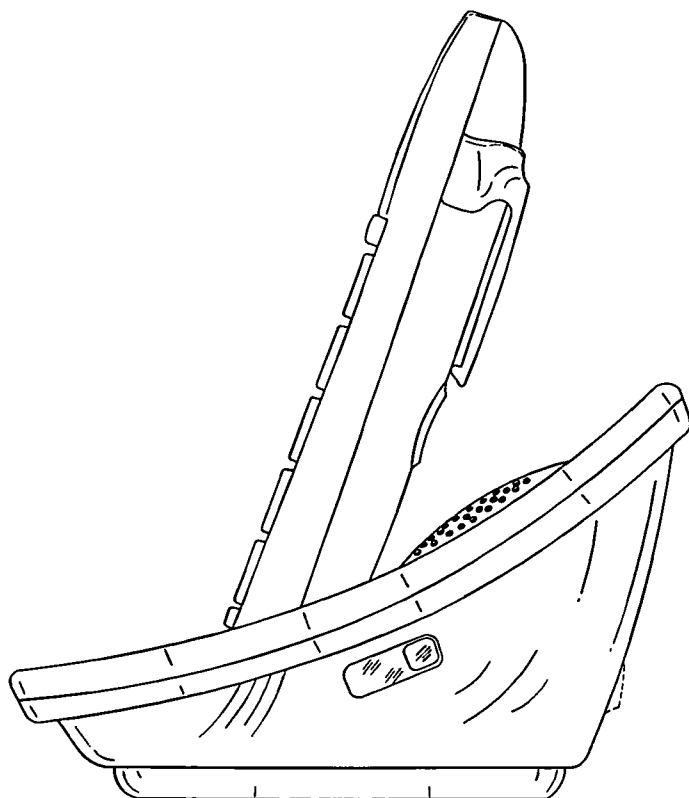

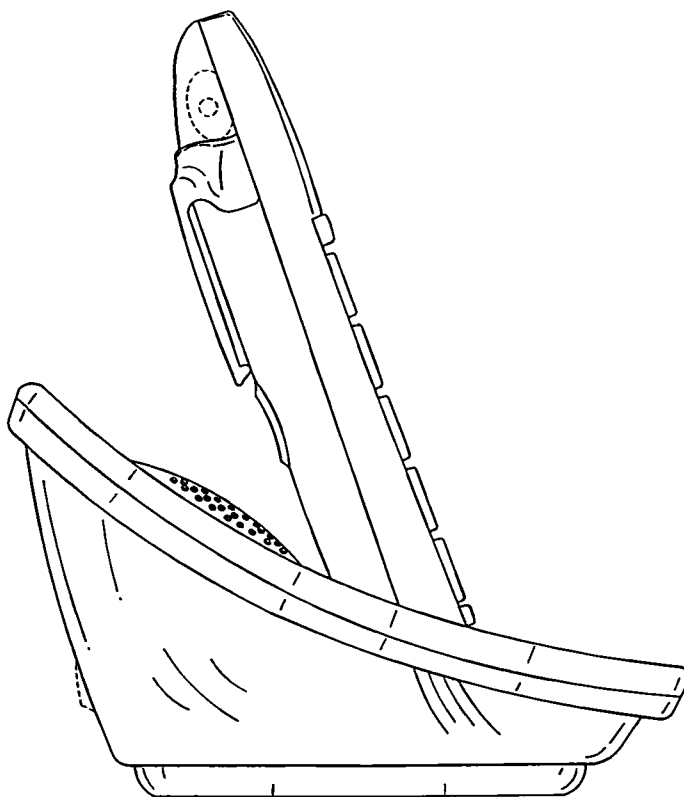

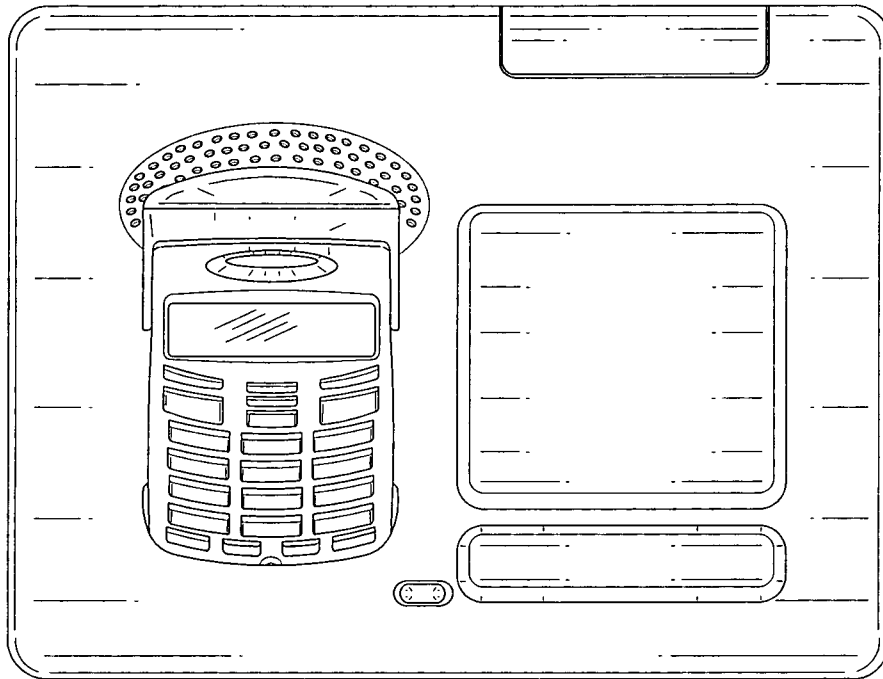
