(57) **CLAIM**

The ornamental design for an object made of glass, artificial gemstone, natural gemstone, as shown and described.

DESCRIPTION

FIG. 1 is a bottom view of the ornamental object made of glass, artificial gemstone, natural gemstone;

FIG. 2 is a top view of the ornamental object made of glass, artificial gemstone, natural gemstone;

FIG. 3 is a front view of the ornamental object made of glass, artificial gemstone, natural gemstone;

FIG. 4 is a rear view of the ornamental object made of glass, artificial gemstone, natural gemstone;

FIG. 5 is a right side view of the ornamental object made of glass, artificial gemstone, natural gemstone;

FIG. 6 is a left side view of the ornamental object made of glass, artificial gemstone, natural gemstone;

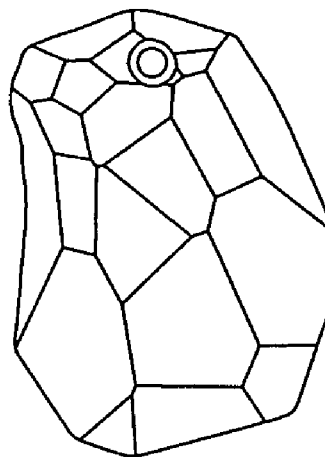
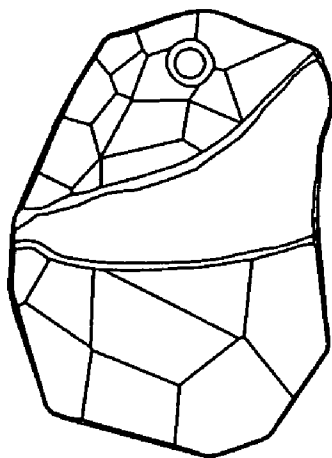

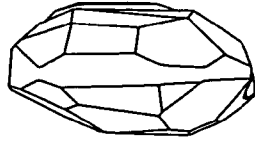

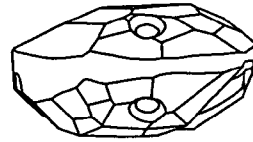

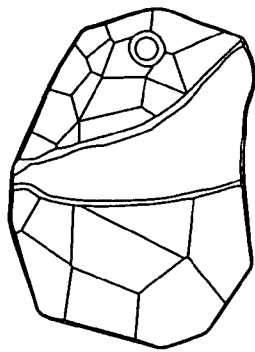

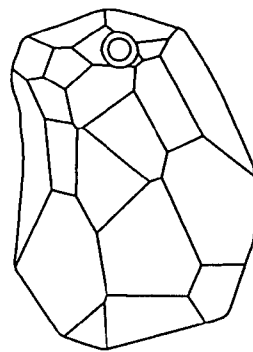

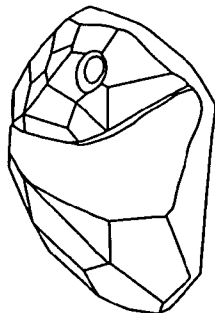
