FIG. 1 is a top perspective view of the air purification disk plate system;

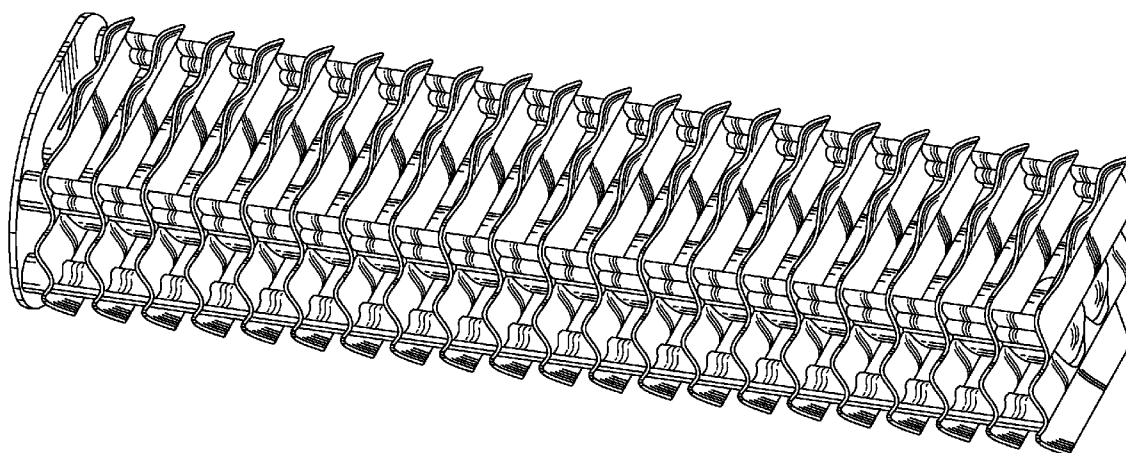
FIG. 2 is a side view of the air purification disk plate system of FIG. 1;

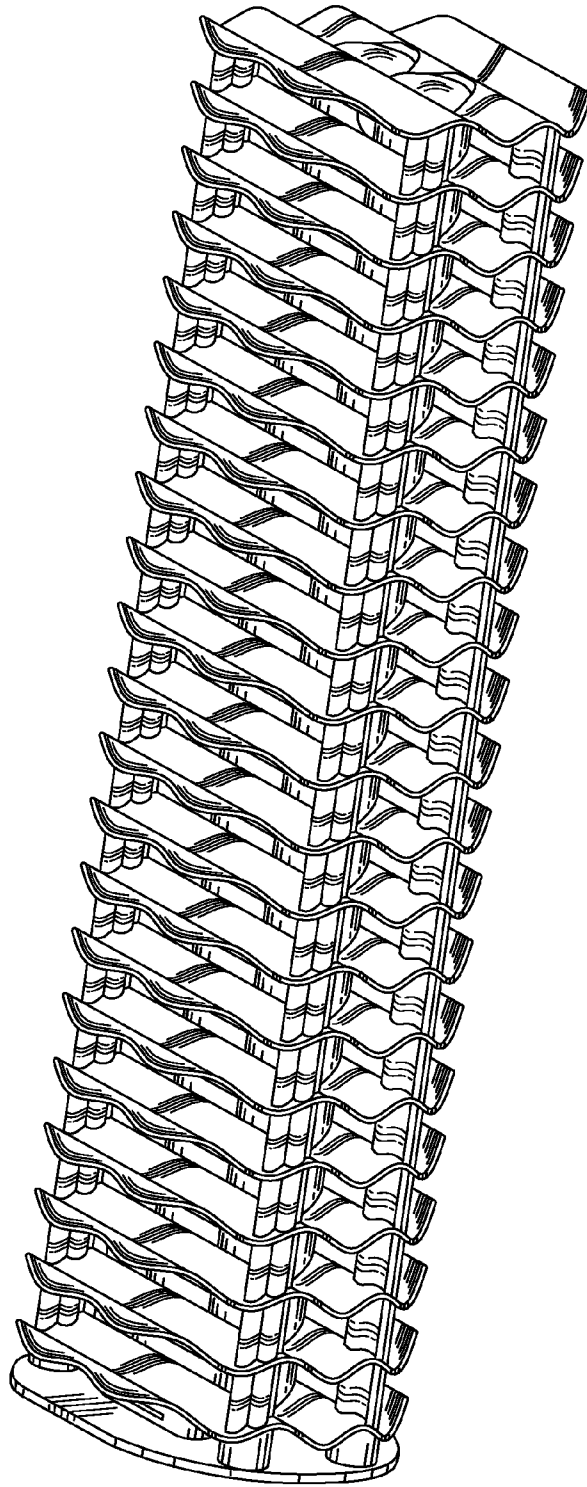

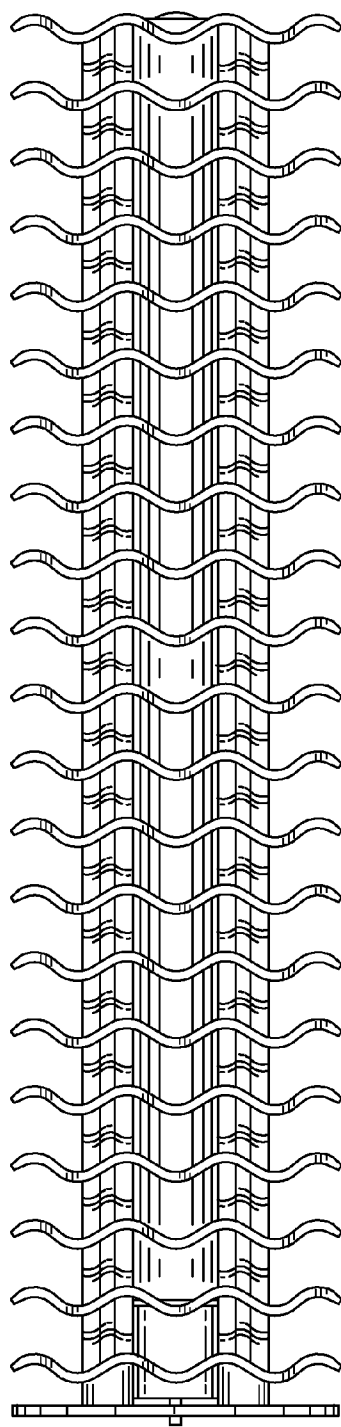

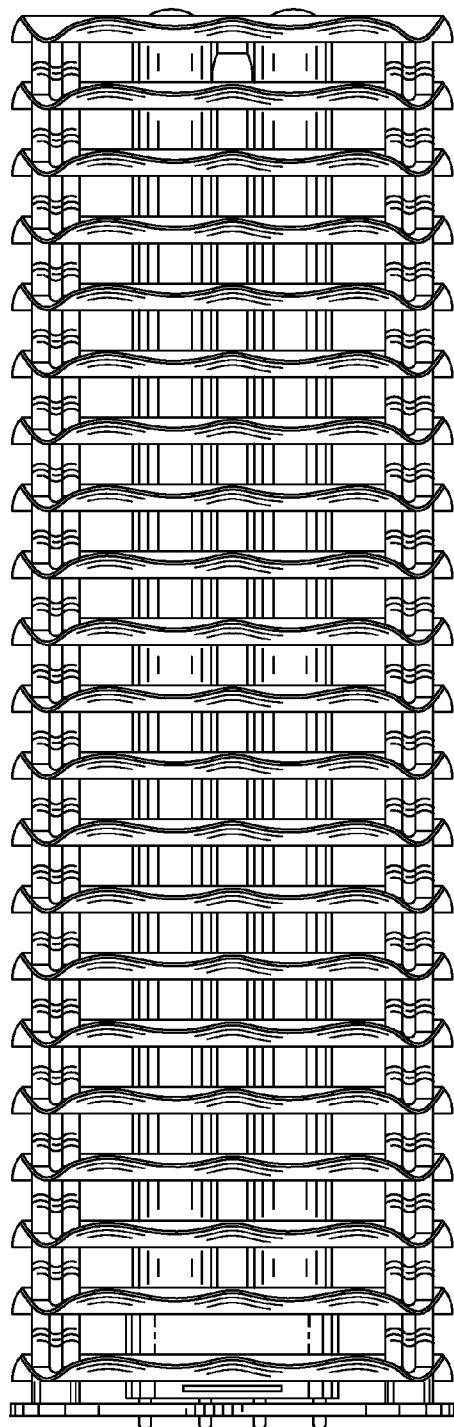

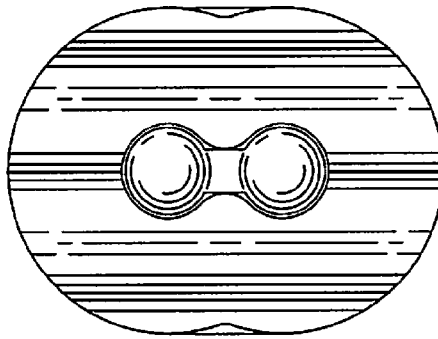

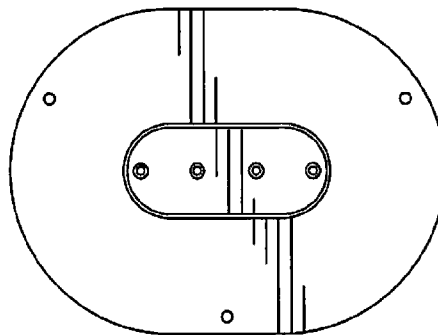
