

The ornamental design for a garment, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a garment showing my new design, showing how it appears across the chest of a wearer; FIG. 2 is a front view thereof; FIG. 3 is a back view thereof; FIG. 4 is a top view thereof; FIG. 5 is a right-side view thereof; FIG. 6 is a left-side view thereof; and, FIG. 7 is a bottom view thereof.

Dashed lines are used to illustrate non-claimed items used for purposes of illustration only. The broken line showing of a wearer in a bra included for the purpose of illustrating environmental structure that forms no part of the claimed design.






