
(57) **CLAIM**

The ornamental design for a storage enclosure, as shown and described.

DESCRIPTION

FIG. 1 is a top right perspective view of a storage enclosure showing the new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof; and, FIG. 6 is a top view thereof. The broken lines depict portions of the storage enclosure, which form no part of the claimed design.












