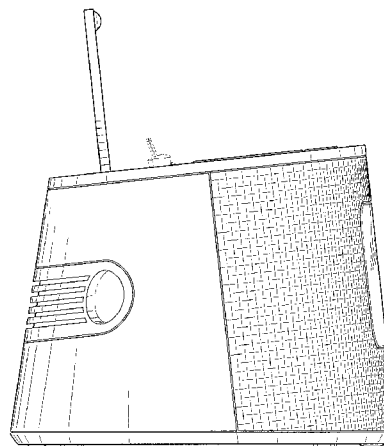
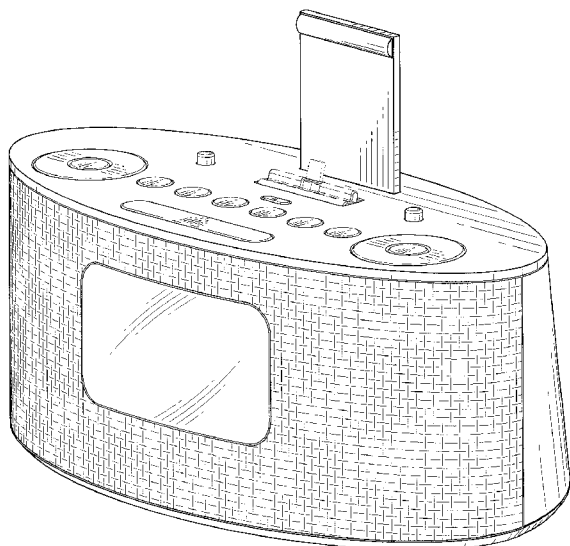
(57) **CLAIM**

The ornamental design for a docking media player clock radio, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, perspective view of a docking media player clock radio showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a top view thereof
FIG. 5 is bottom view thereof;
FIG. 6 is a side view thereof, the opposite side view being a mirror image;
FIG. 7 is a cross-sectional view on line 7-7 in FIG. 2; and,

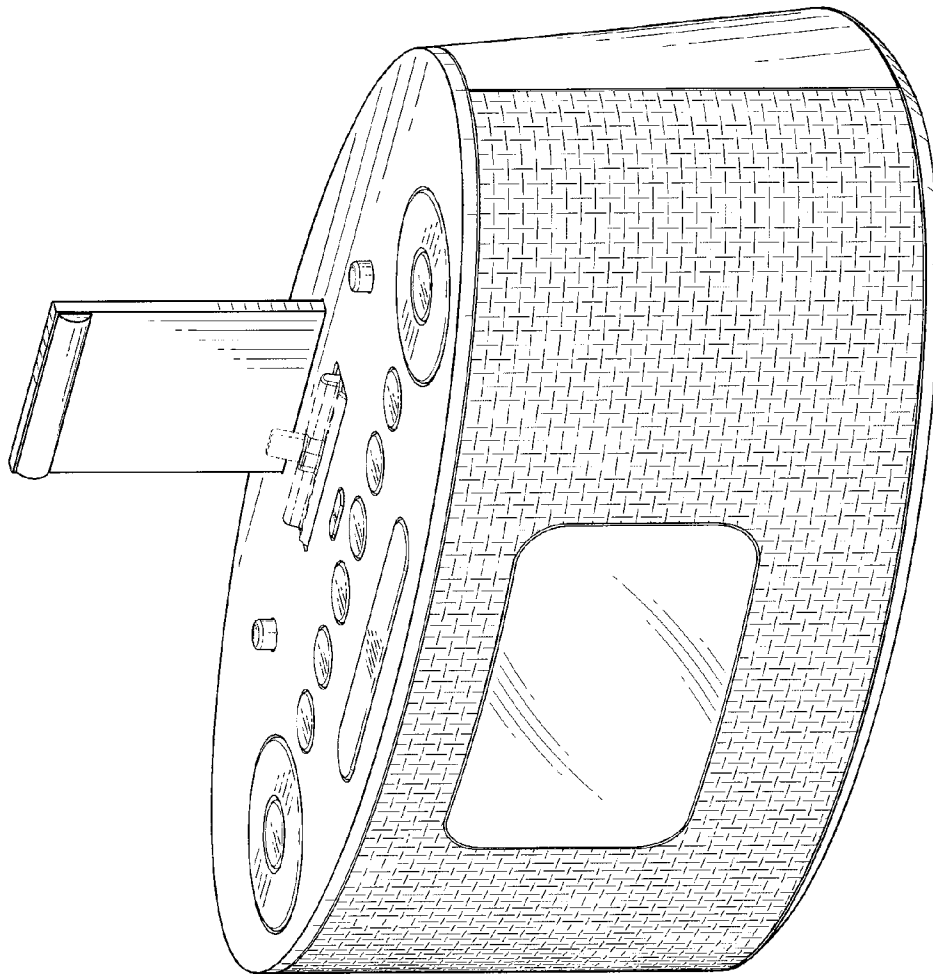

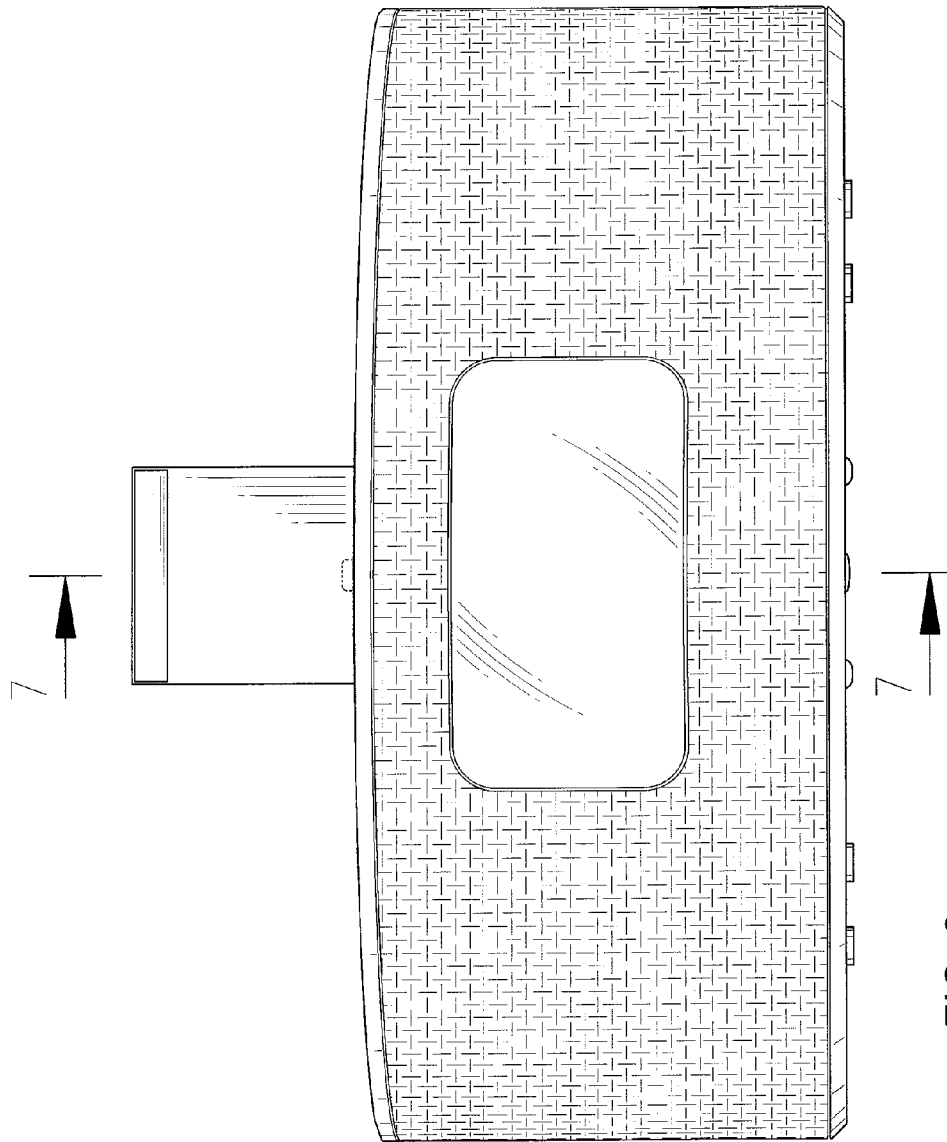

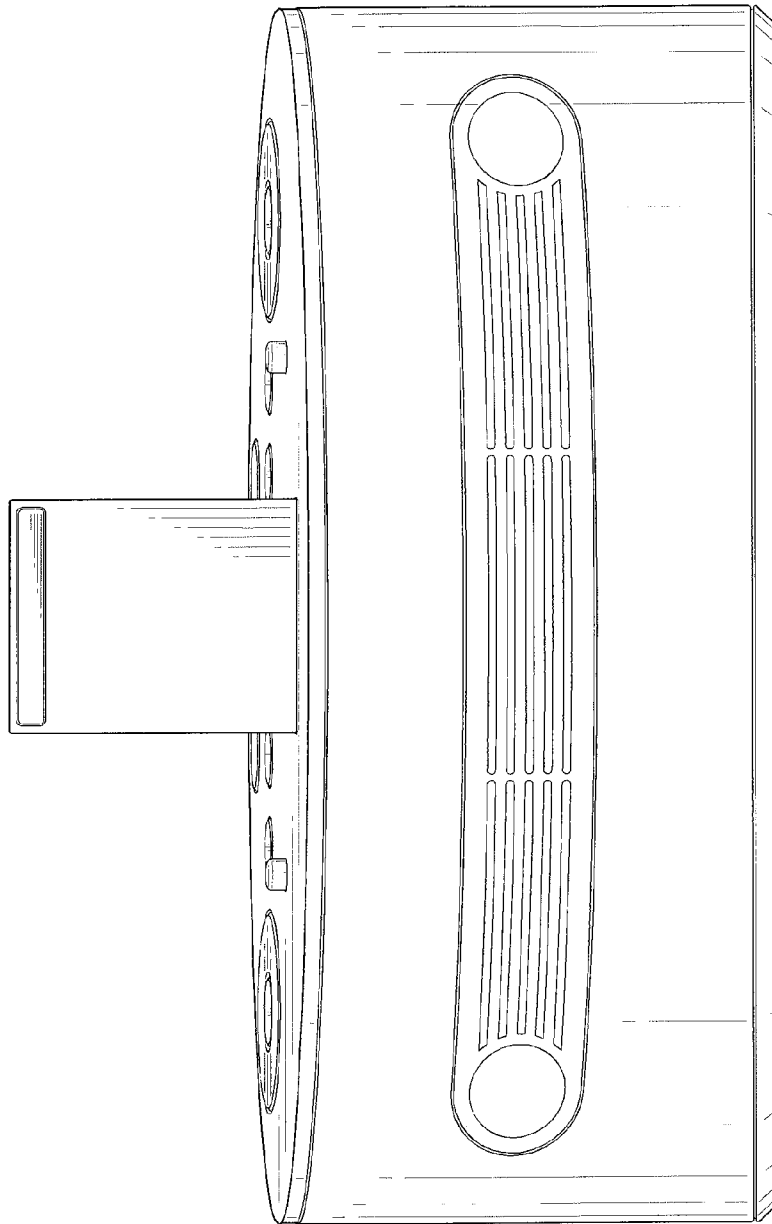

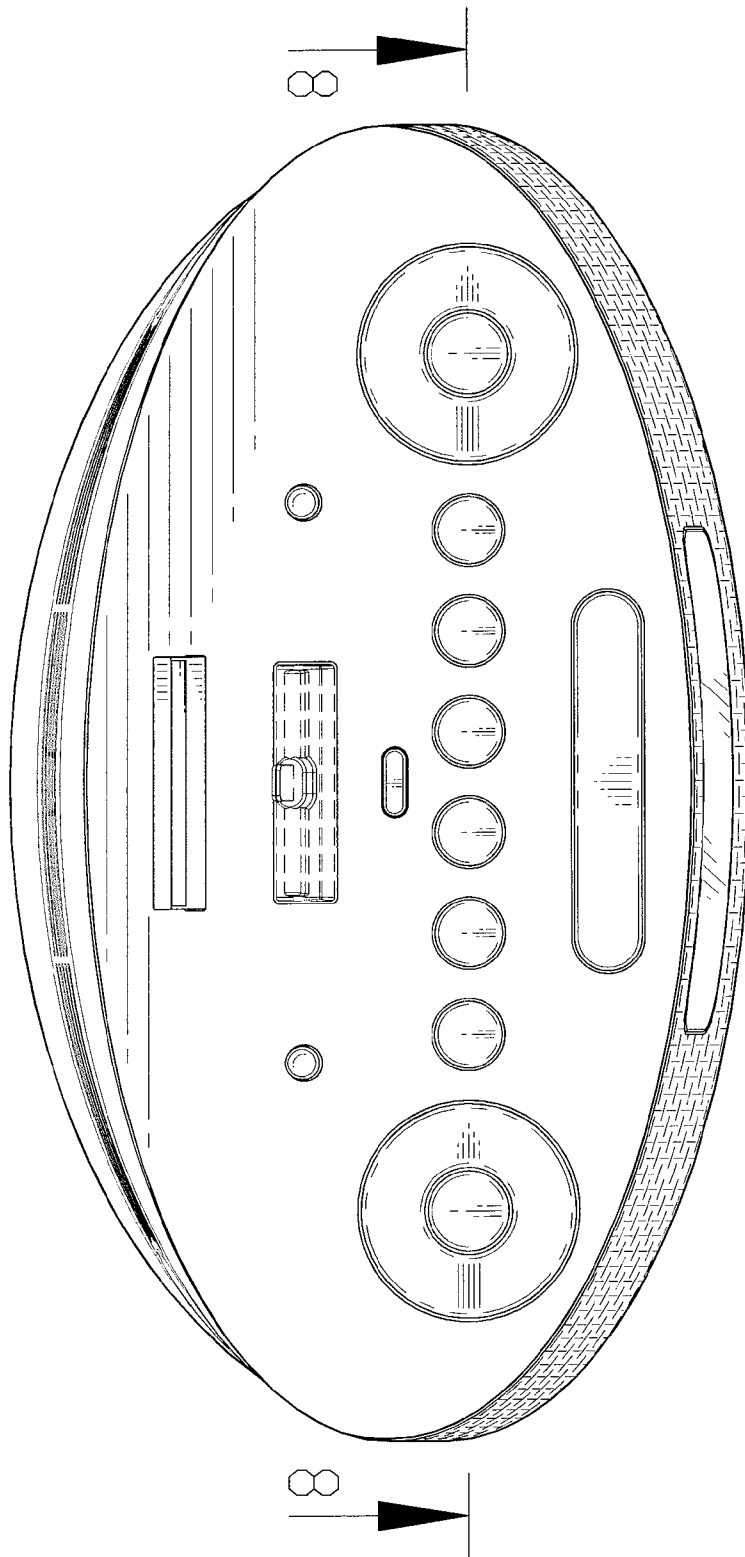

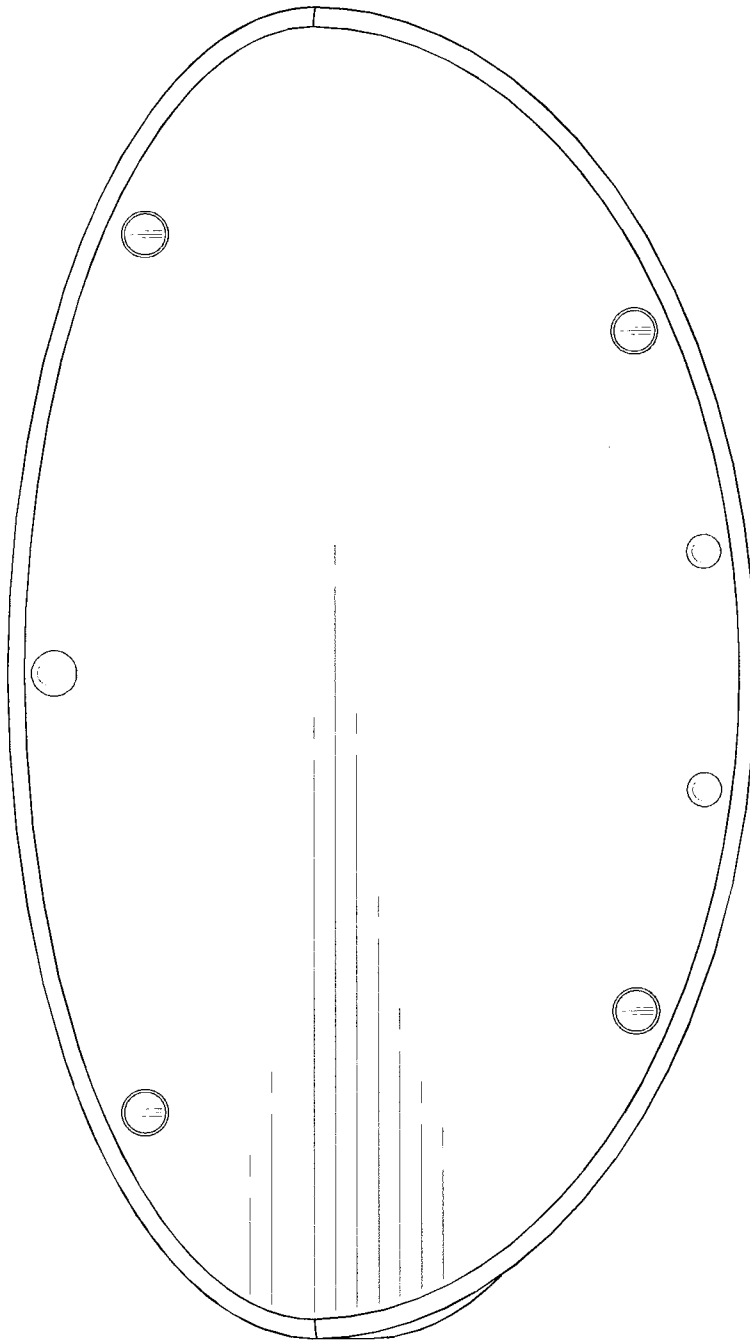

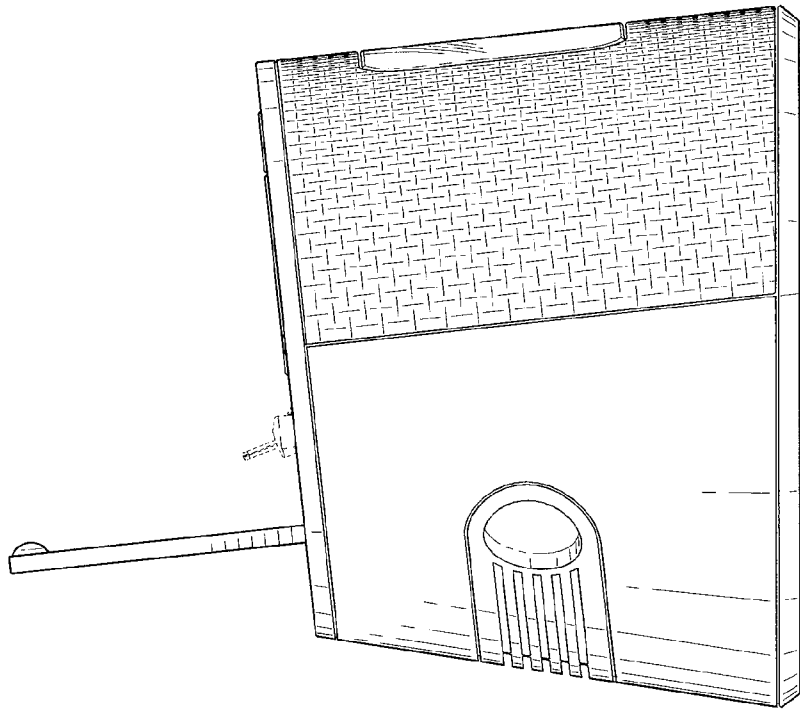

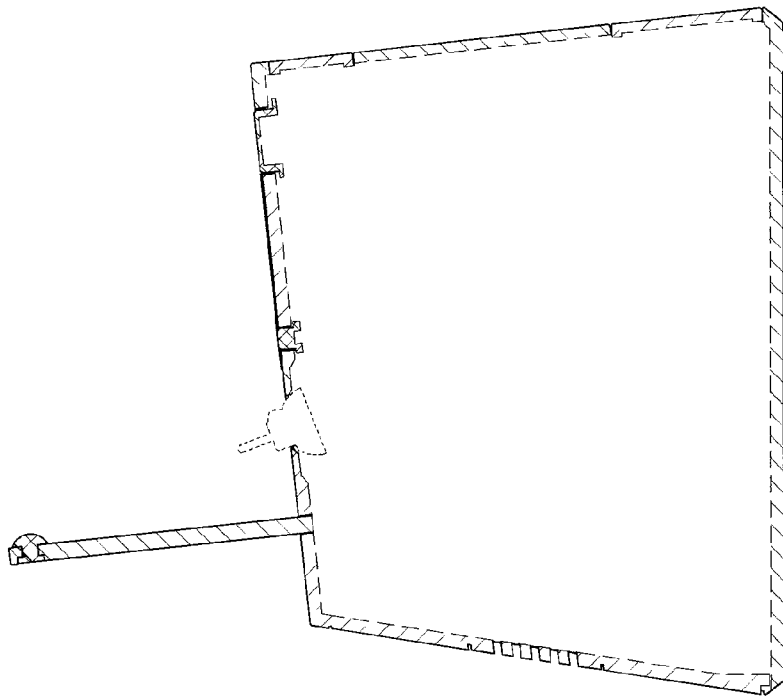

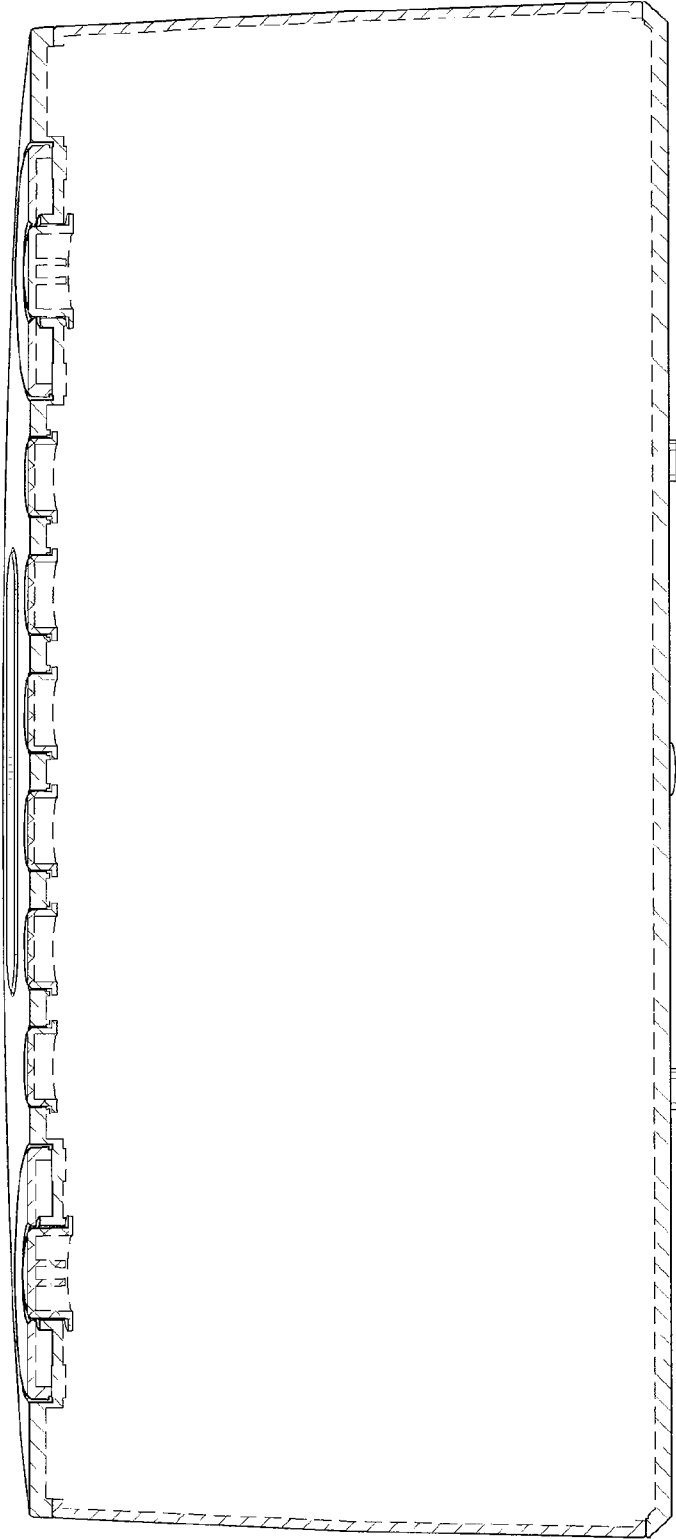
