DESCRIPTION

FIG. 1 is a front elevational view of a urinary funnel for women showing my new design;

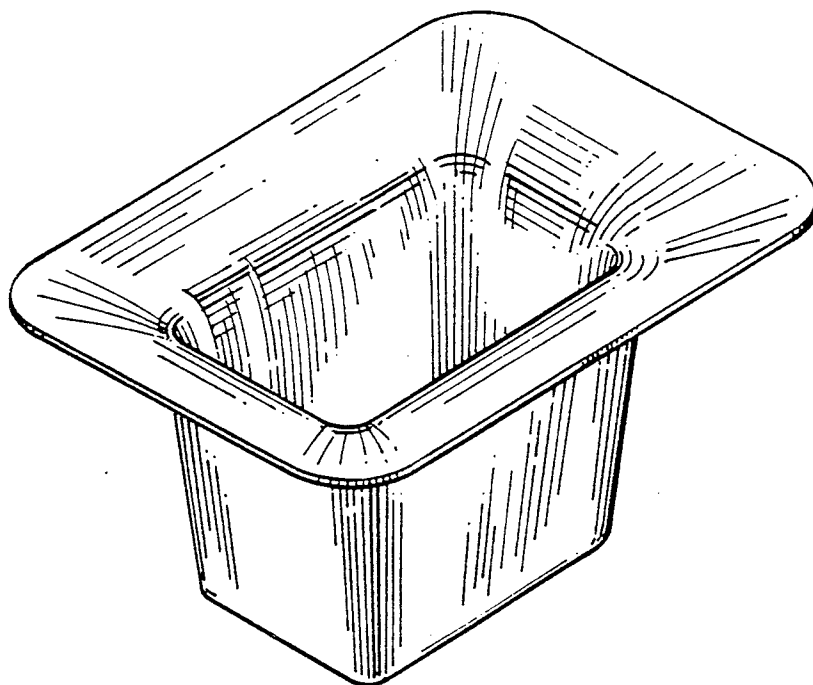
FIG. 2 is a right side elevational view, the left side elevational view being a mirror image thereof;

The broken line showing of a portion of a urine collection receptacle in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.



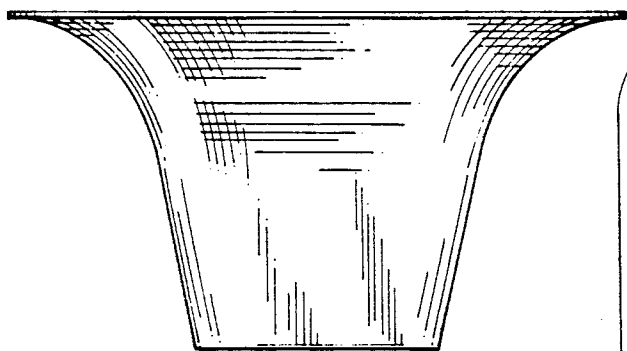

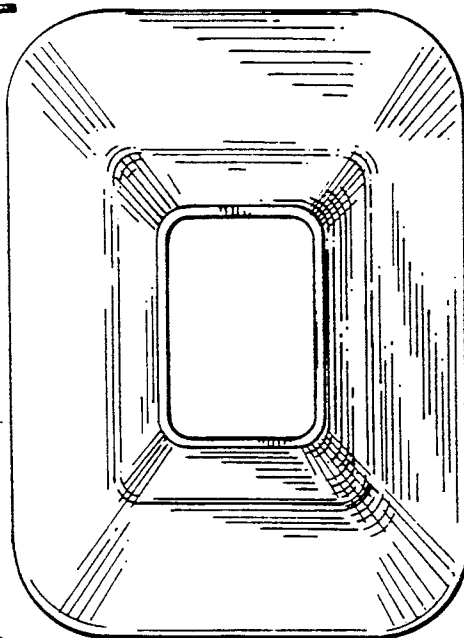

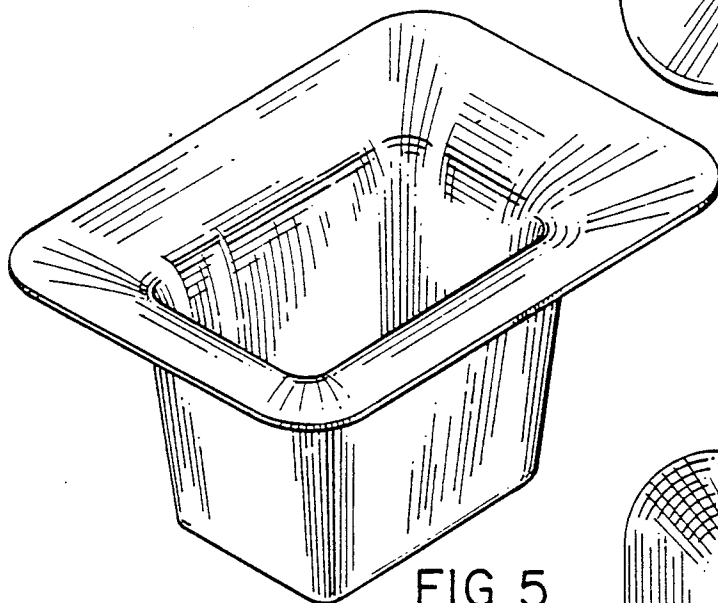

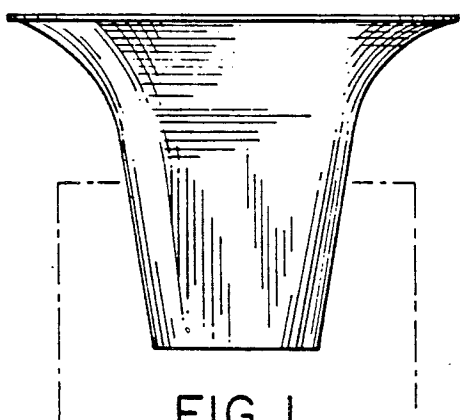

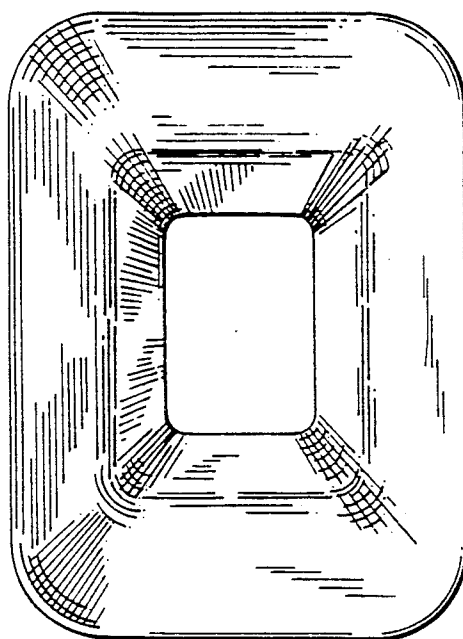
