(57) **CLAIM**

The ornamental design for a pad for forming hair style, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a pad for forming hair style of the present invention.

FIG. 2 is a rear view of the pad for forming hair style of FIG. 1.

FIG. 3 is a top plan view of the pad for forming hair style of FIG. 1.

FIG. 4 is a bottom view of the pad for forming hair style of FIG. 1.

FIG. 5 is a right side view of the pad for forming hair style of FIG. 1.

FIG. 6 is a left side view of the pad for forming hair style of FIG. 1.

FIG. 7 is a first perspective view of the pad for forming hair style of FIG. 1.

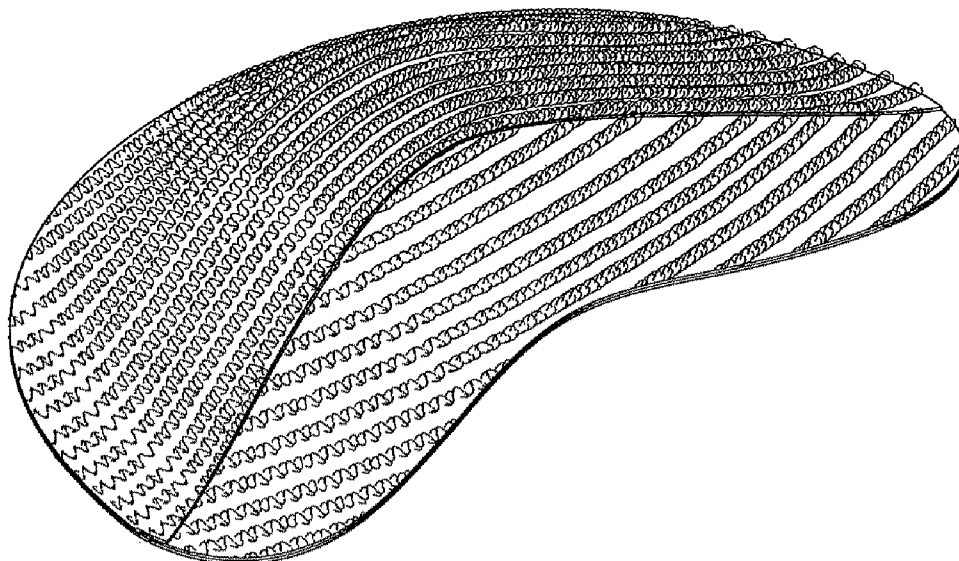
FIG. 8 is a second perspective view of the pad for forming hair style of FIG. 1.

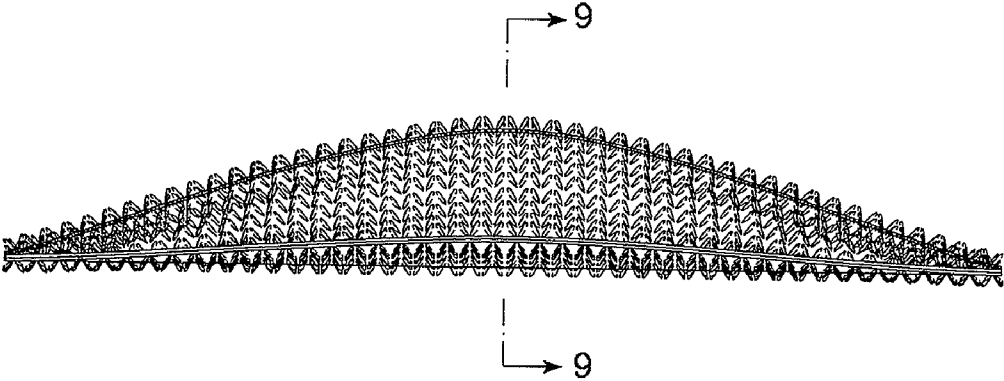

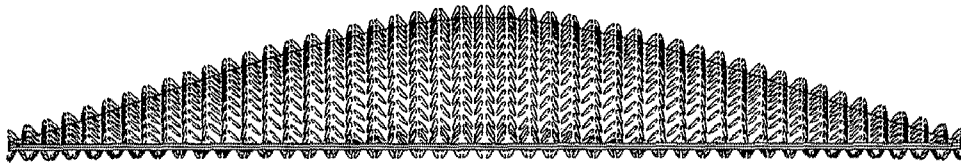

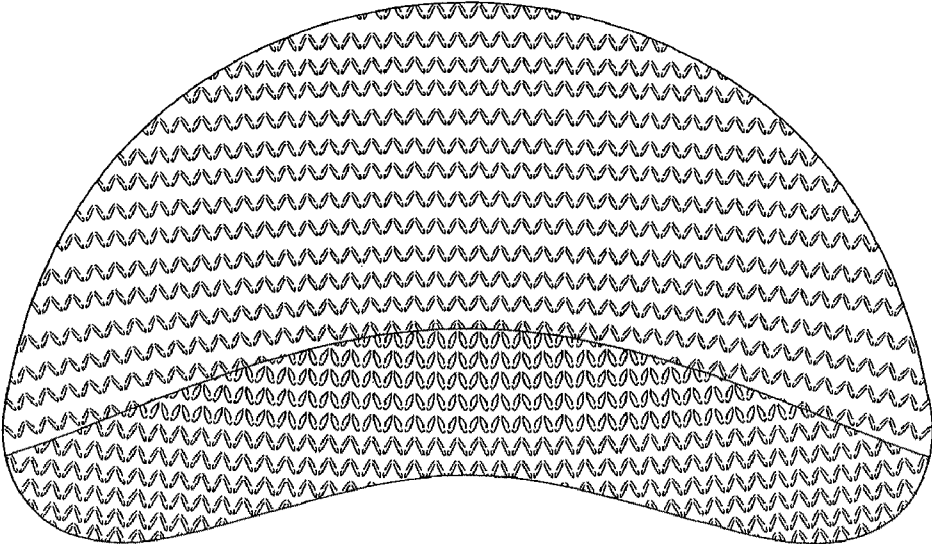

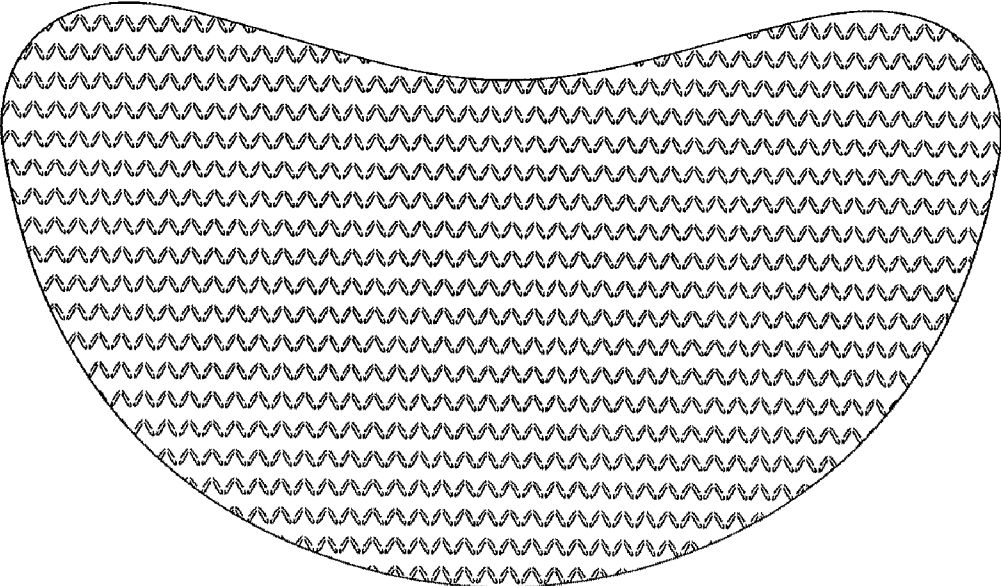

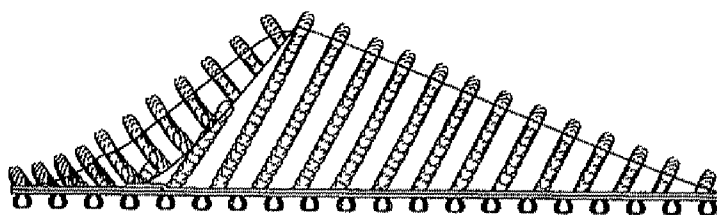

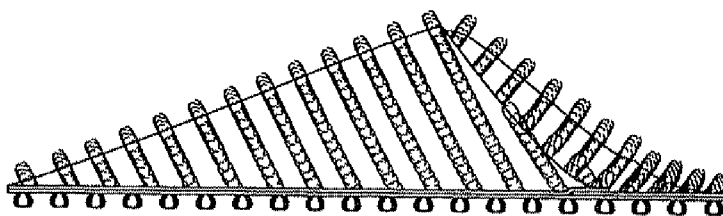

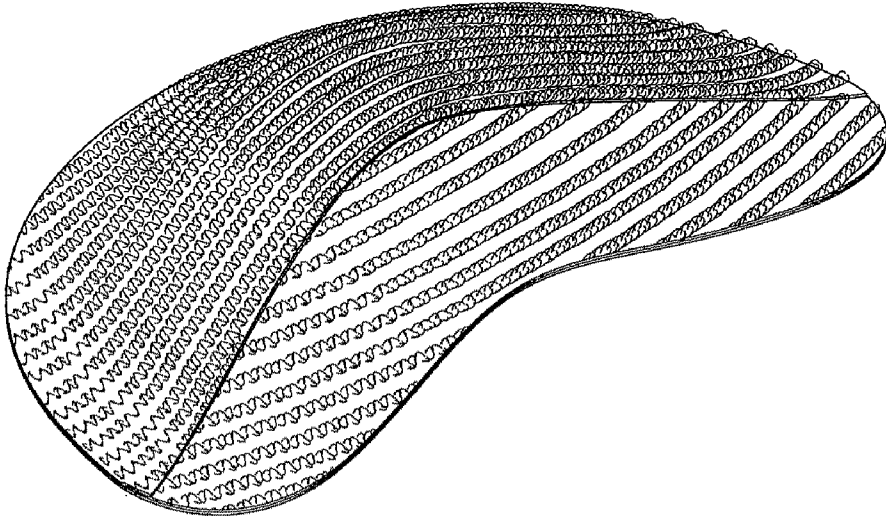

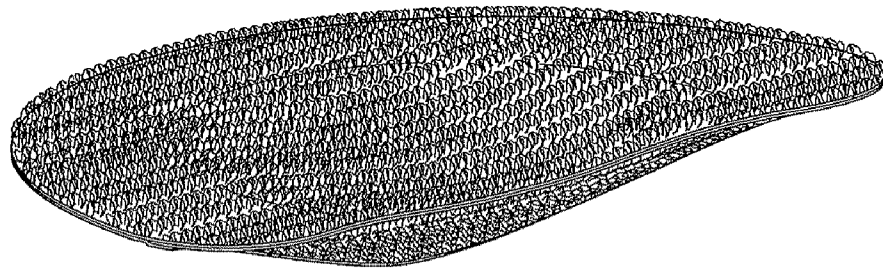
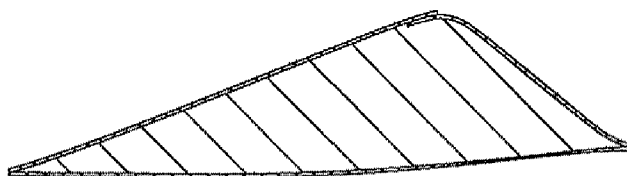

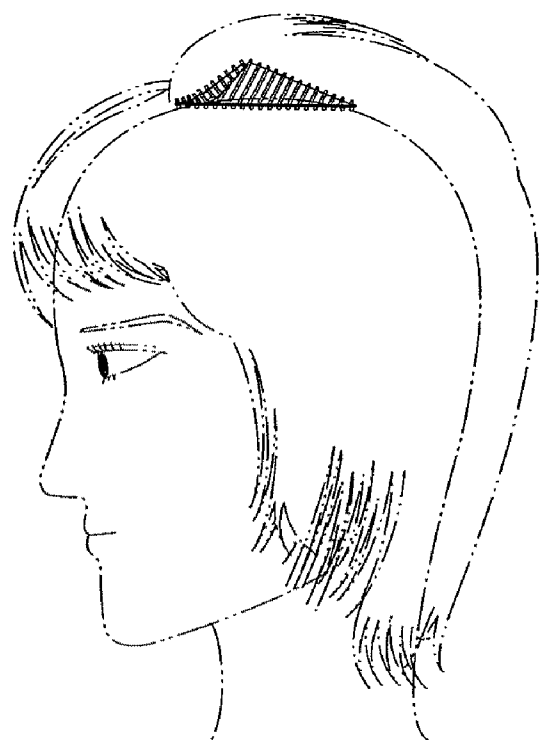
