DESCRIPTION

FIG. 1 is a perspective view of a cutting tool showing our new design;

FIG. 2 is a right side elevational view showing the design for the cutting tool of FIG. 1;

FIG. 3 is a left side elevational view showing the design for the cutting tool of FIG. 1;

FIG. 4 is a front elevational view showing the design for the cutting tool of FIG. 1;

FIG. 5 is a rear elevational view showing the design for the cutting tool of FIG. 1;

FIG. 6 is a top plan view showing the design for the cutting tool of FIG. 1; and,

FIG. 7 is a bottom plan view showing the design for the cutting tool of FIG. 1.















