

#### (54) Title: SYSTEM AND METHOD FOR PROVIDING PERSONALIZED CUSTOMER SUPPORT



(57) Abstract: The present disclosure relates to a system and method for providing personalized customer support. The method comprises receiving information (300) from a customer, evaluating the customer information (302), identifying customer support information relevant to the customer information (304), and presenting the relevant customer support information to the customer. In a preferred arrangement, the method comprises automatically generating a personalized web page (308) containing the customer support information particular to the customer and its business.
