(57) **CLAIM**

We claim, the ornamental design for a male member of nemo buckle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a male member of nemo buckle, showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof;  
FIG. 8 is a cross-sectional view taken along the lines VIII-VIII of FIG. 2; and,  
FIG. 9 is a perspective view thereof engaged with a female member of nemo buckle.  
The broken lines showing a female member in FIG. 9 are included for the purpose of illustrating the invention in use, and form no part of the claimed invention.
















