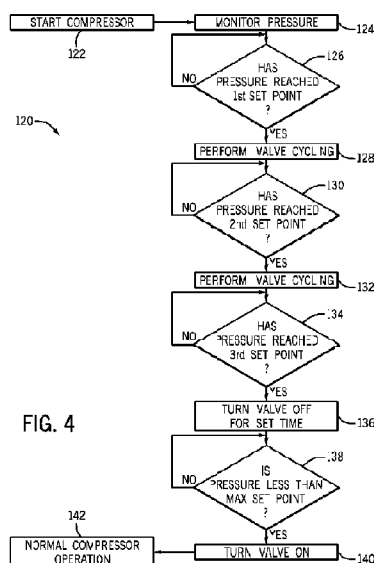

(57) Abstract: The present embodiments provide a control system and method that is able to automatically cycle one or more compressor valves, for example to prevent freeze up. For example, in one embodiment, a system includes a compressor having a compression device configured to increase a pressure of a gas, a valve configured to control flow of the gas from the compression device, and a controller configured to cycle the valve to reduce buildup of contaminants in the compressor.
