The ornamental design for a purse insert, as shown and described.

### DESCRIPTION

FIG. 1 is a front elevational view of an embodiment of my new design for a purse insert, with top zipper open and flaps down; FIG. 2 is a front view of the purse insert with top zipper open and flaps down;

FIG. 3 is a rear view of the purse insert with top zipper open and flaps down;

FIG. 4 is a left side view of the purse insert with top zipper open and flaps down;

FIG. 5 is a right side view of the purse insert with top zipper open and flaps down;

FIG. 6 is a top plan view of the purse insert with top zipper open and flaps down;

FIG. 7 is a bottom plan view of the purse insert with top zipper open and flaps down;

FIG. 8 is a front elevational view of the purse insert with top zipper open and flaps up;

FIG. 9 is a front elevational view of the purse insert with top zipper closed and flaps up;

FIG. 10 is a front view of the purse insert with top zipper closed and flaps up;

FIG. 11 is a rear view of the purse insert with top zipper closed and flaps up;

FIG. 12 is a left side view of the purse insert with top zipper closed and flaps up;

FIG. 13 is a right side view of the purse insert with top zipper closed and flaps up;

FIG. 14 is a top plan view of the purse insert with top zipper

closed and flaps up; and, FIG. 15 is a bottom plan view of the purse insert with top

zipper closed and flaps up.























