(54) Title: EXPRESSION PROFILE OF PROSTATE CANCER

(57) Abstract: The present invention relates to compositions and methods for cancer diagnostics, including but not limited to, cancer markers. In particular, the present invention provides gene expression profiles associated with prostate cancers.
