

(57) **Abstract:** A Balanced Roulette game and Balanced Roulette method for arranging indicia on a Balanced Roulette wheel game surface and on an associated Balanced Roulette wheel having indicia indicating non-house numbers from 1 through 36. A Balanced Super Roulette game and method for arranging indicia on a Balanced Super Roulette wheel game surface and on an associated Balanced Super Roulette wheel having indicia indicating non-house numbers from 1 through 60. Each of the Balanced Roulette and Balanced Super Roulette wheels/game surfaces have indicia (number and color) arranged such that the impact of wheel Bias that affects bettor payouts for multi-number bets is reduced.
