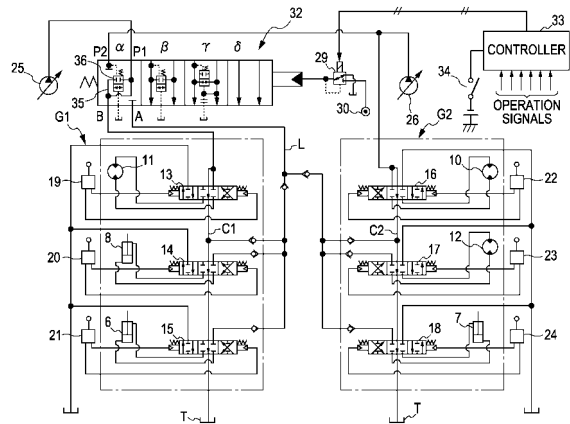

(54) **Working machine**

(57) A working machine includes a hydraulic control apparatus. In a straight travel valve (32) of the hydraulic control apparatus, a communication path (35) and a control valve (36) that opens and closes the communication path (35) are provided. During a combined operation of travelling operation and working operation, a working pressure (41) and a travelling pressure (42) are taken in as pilot pressures on either side of the control valve (36). During a small travelling operation in which the travelling operation amount is small, the communication path (35) is unconditionally closed. During a large travelling operation in which the travelling operation amount is large, if the working pressure (41) is higher than the travelling pressure (42), the communication path (35) is open, and if the working pressure (41) is lower than the travelling pressure (42), the communication path (35) is closed.
