(57) **CLAIM**

The ornamental design for a cellular phone, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the cellular phone showing my new design;  
 FIG. 2 is a front view thereof;  
 FIG. 3 is a rear view thereof;  
 FIG. 4 is a left side view thereof;  
 FIG. 5 is a right side view thereof;  
 FIG. 6 is a top view thereof;  
 FIG. 7 is a bottom view thereof;  
 FIGS. 8 and 9 are right side views showing the rotated status of the front folder in an opened position;  
 FIG. 10-13 are front views showing the front folder rotated at various angles while in a closed position; and,  
 FIG. 14 is a front view thereof in an opened position.  
 The broken line showings of portions of the cell phone in the views are for illustrative purposes only and form no part of the claimed design.

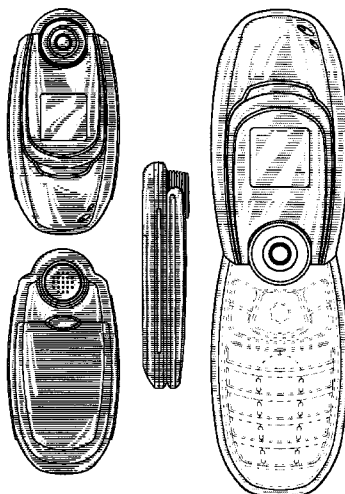

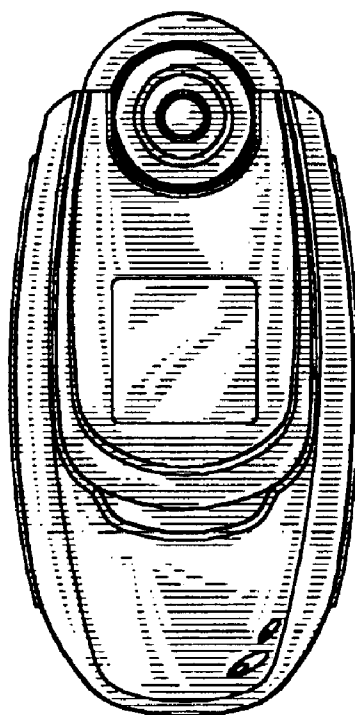

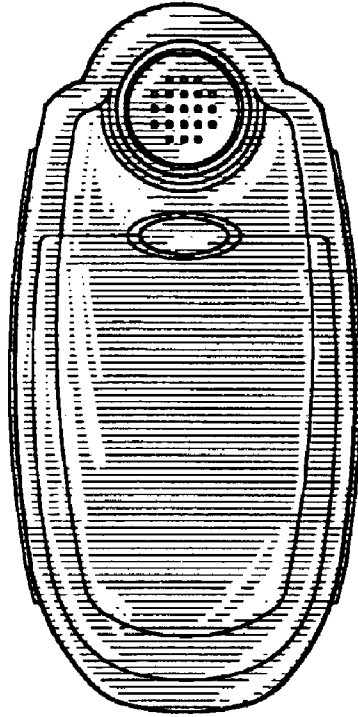

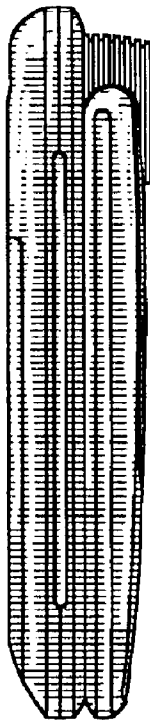

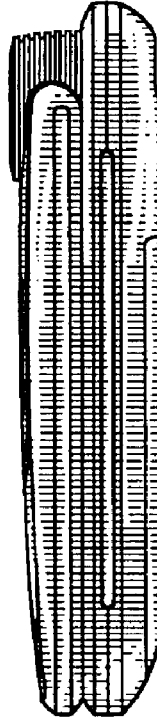

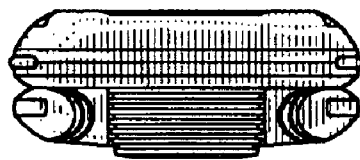

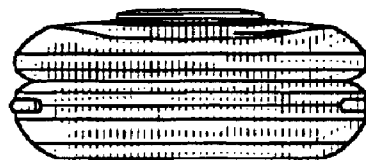

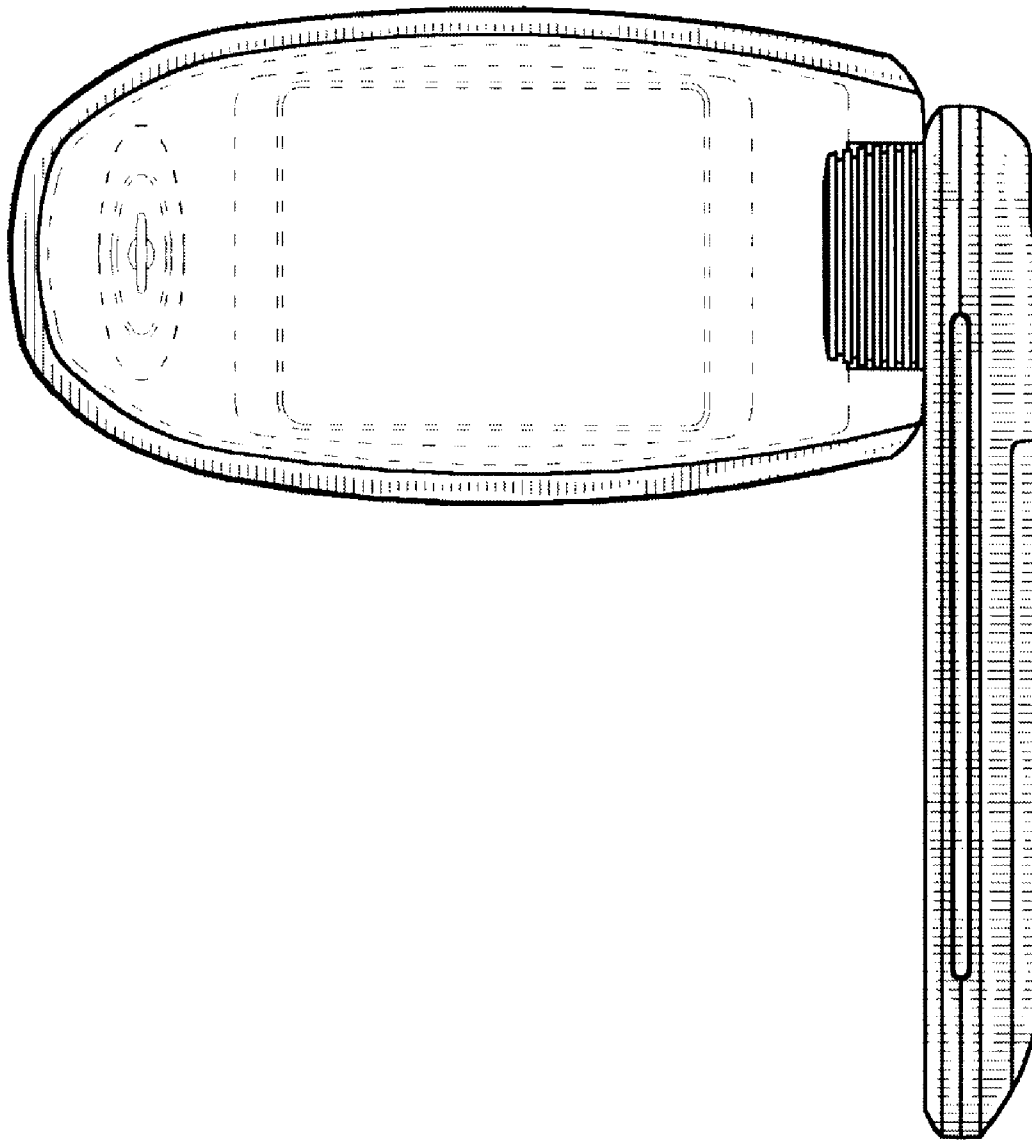

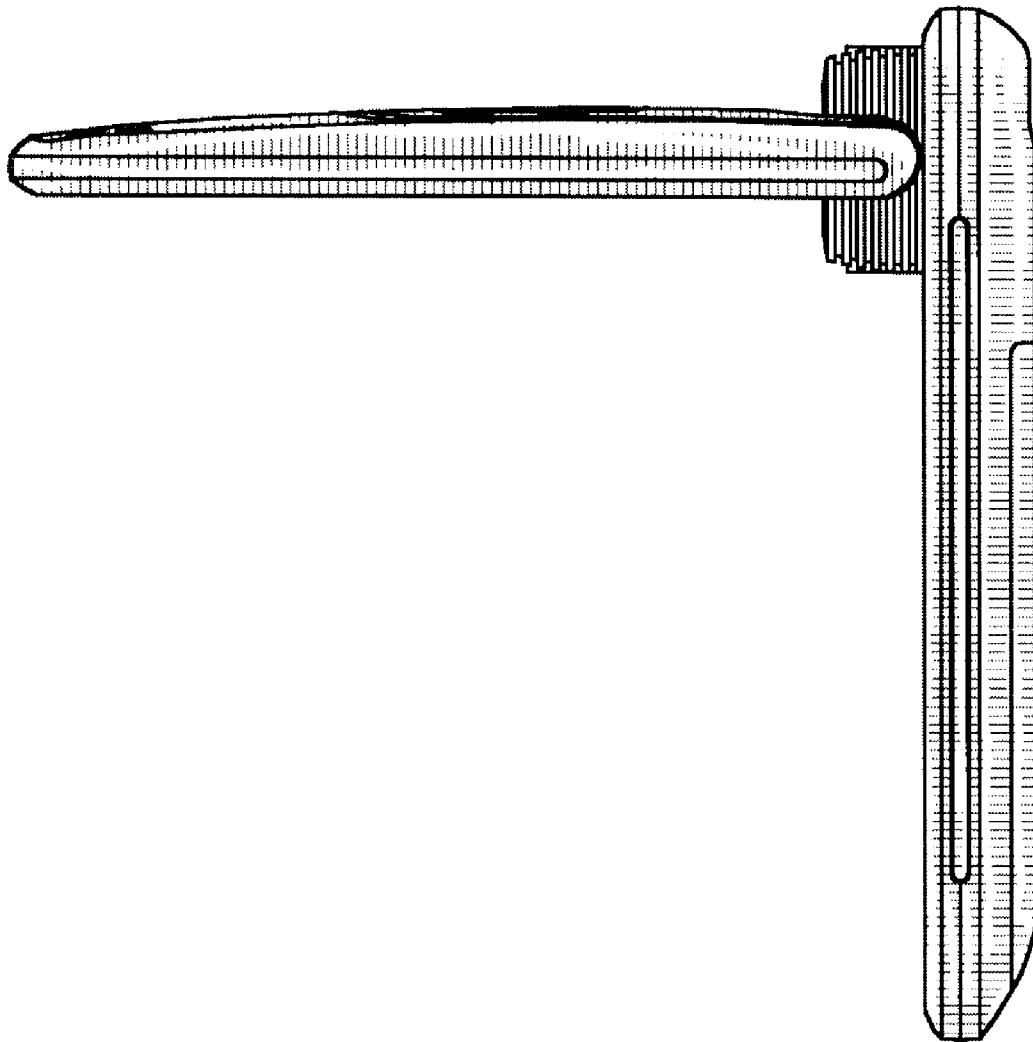

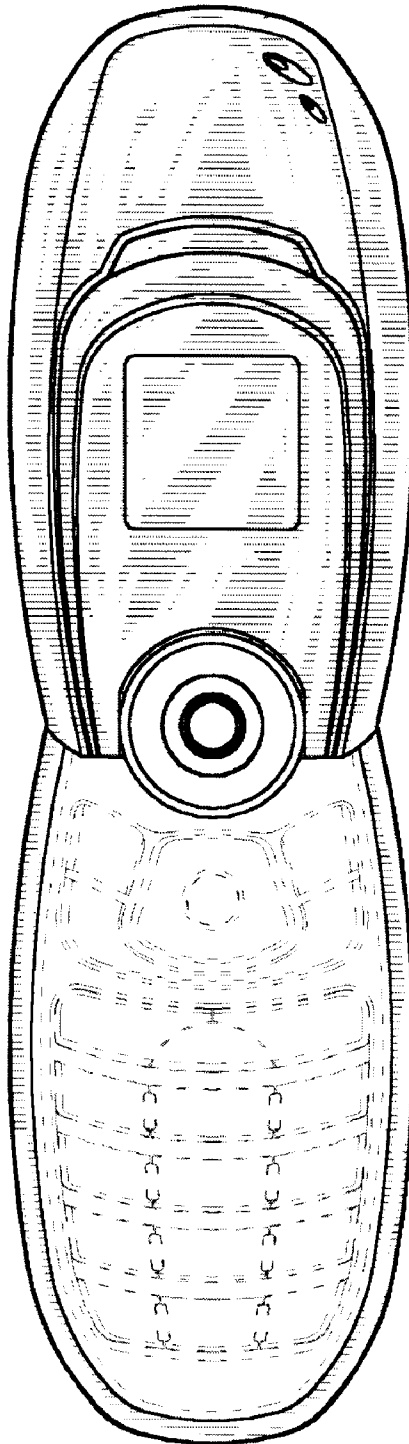

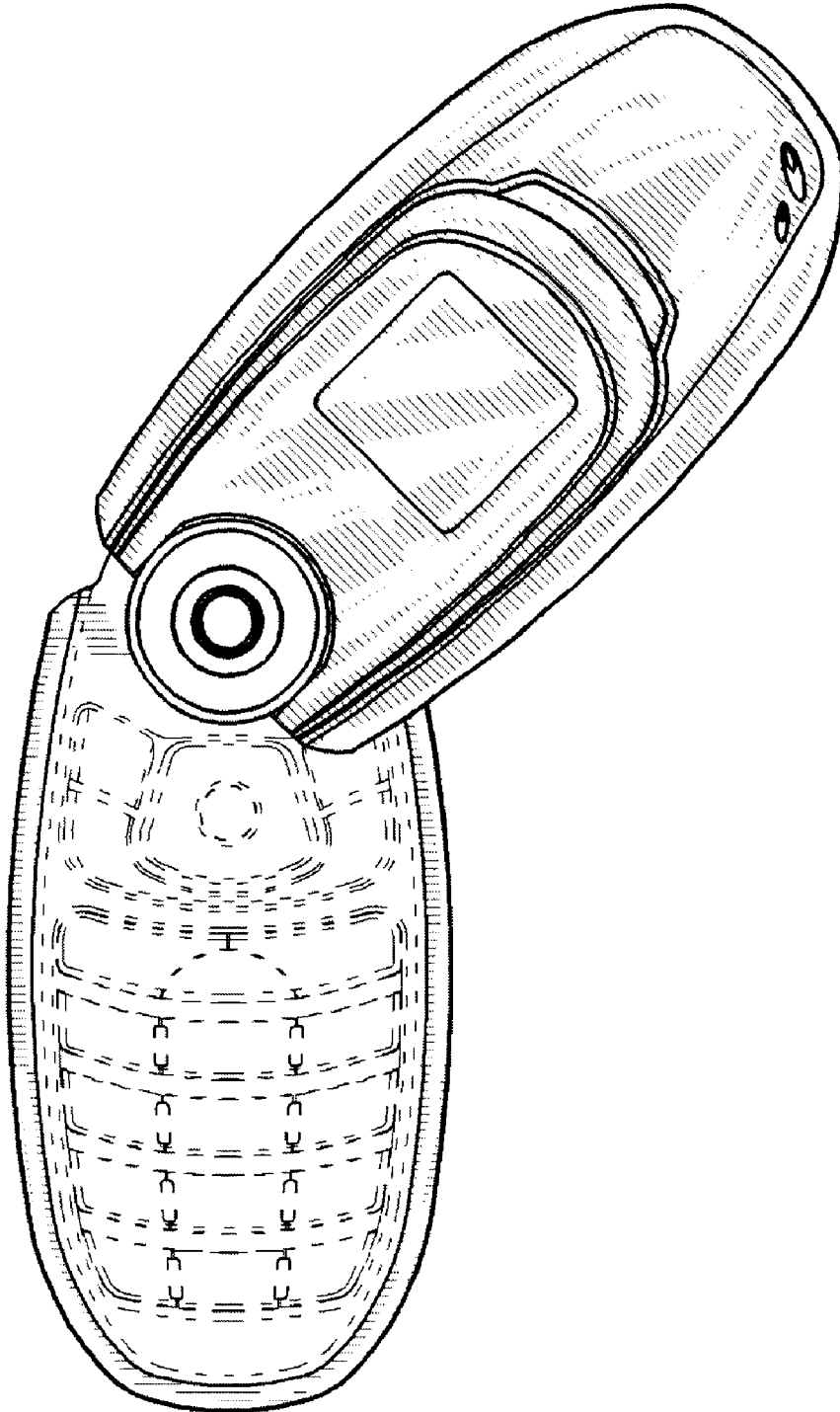

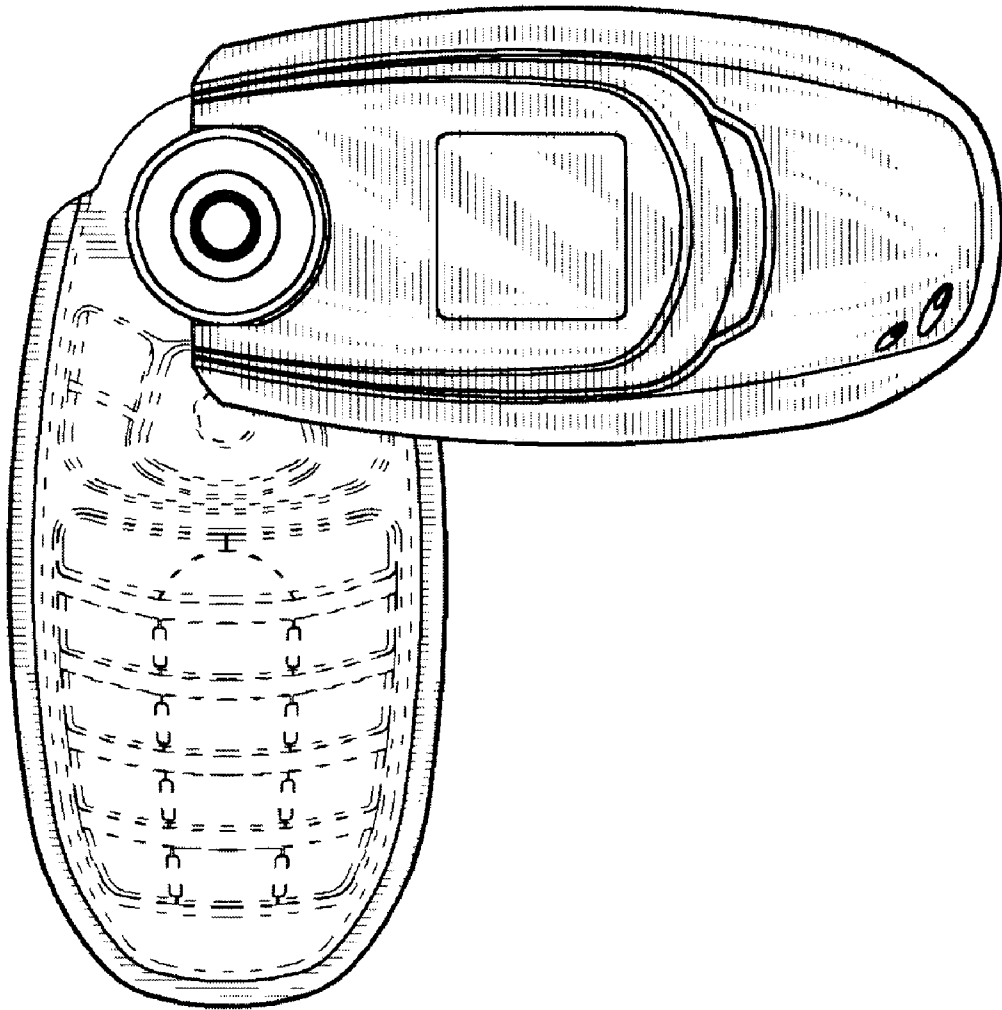

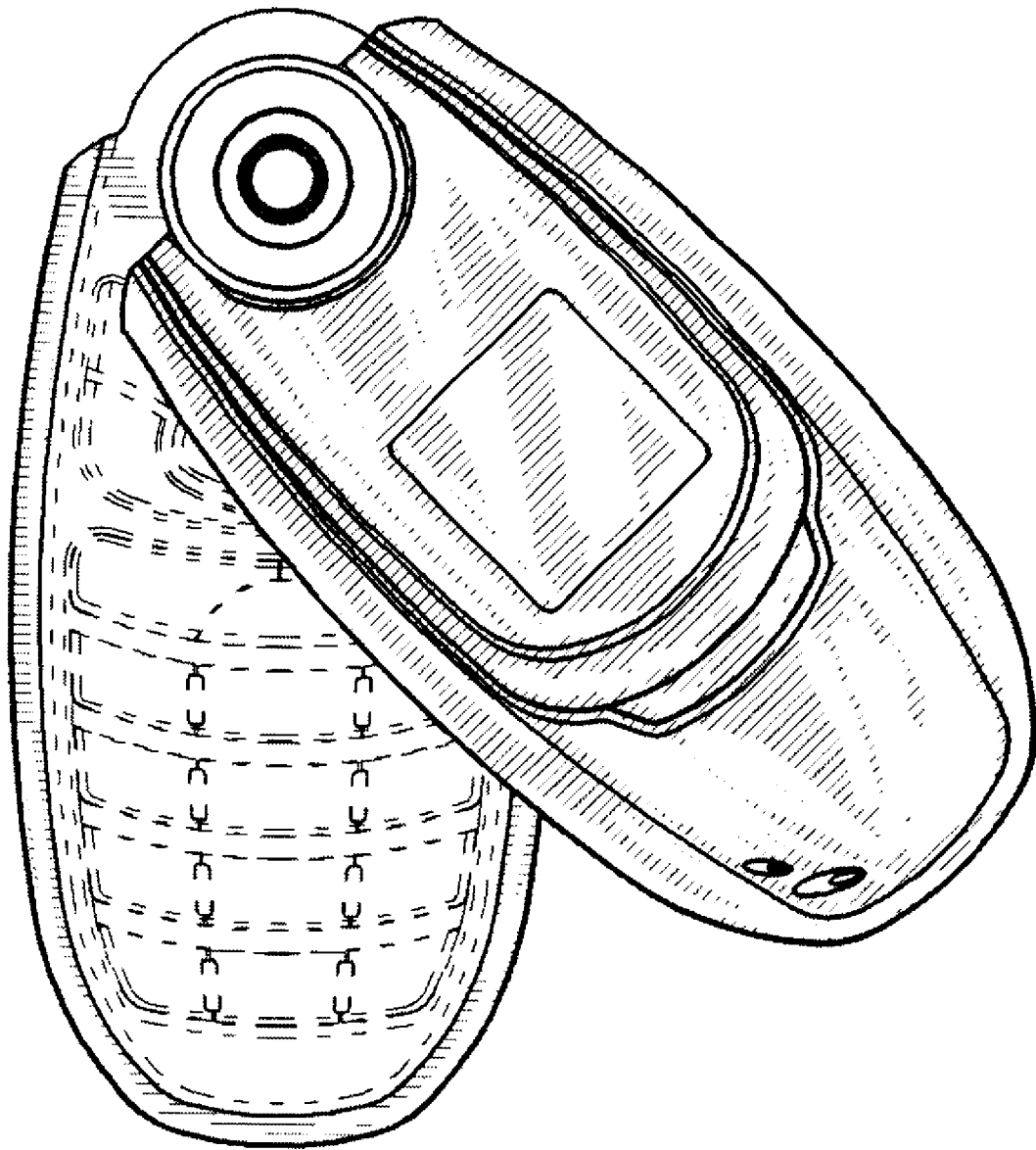
