The ornamental design for a generated image for a portable telephone, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of generated image for a portable telephone having indicated image design displayed thereon showing our new design;

FIG. 4 is a left side elevational view thereof;

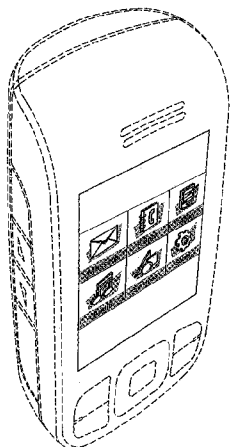
FIG. 5 is a right side elevational view thereof;

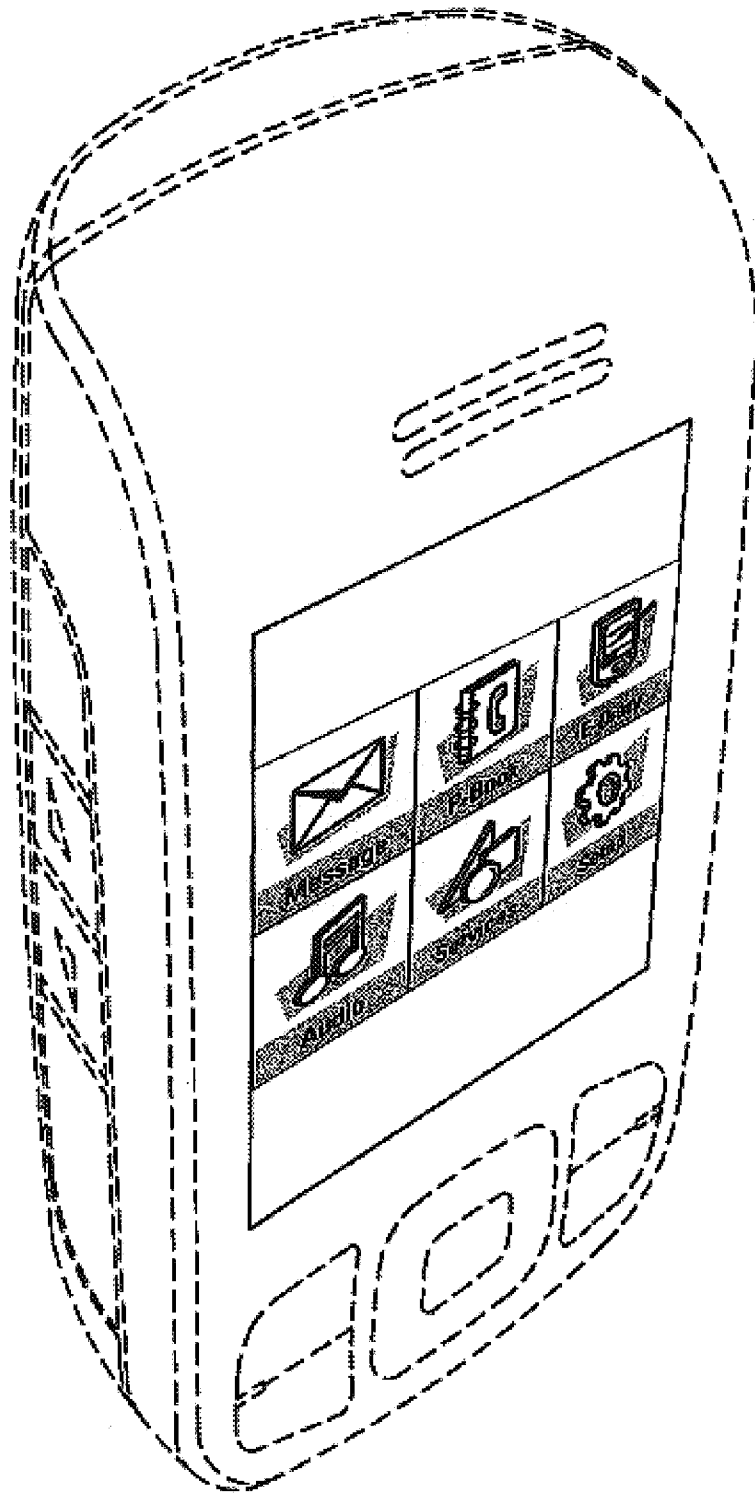

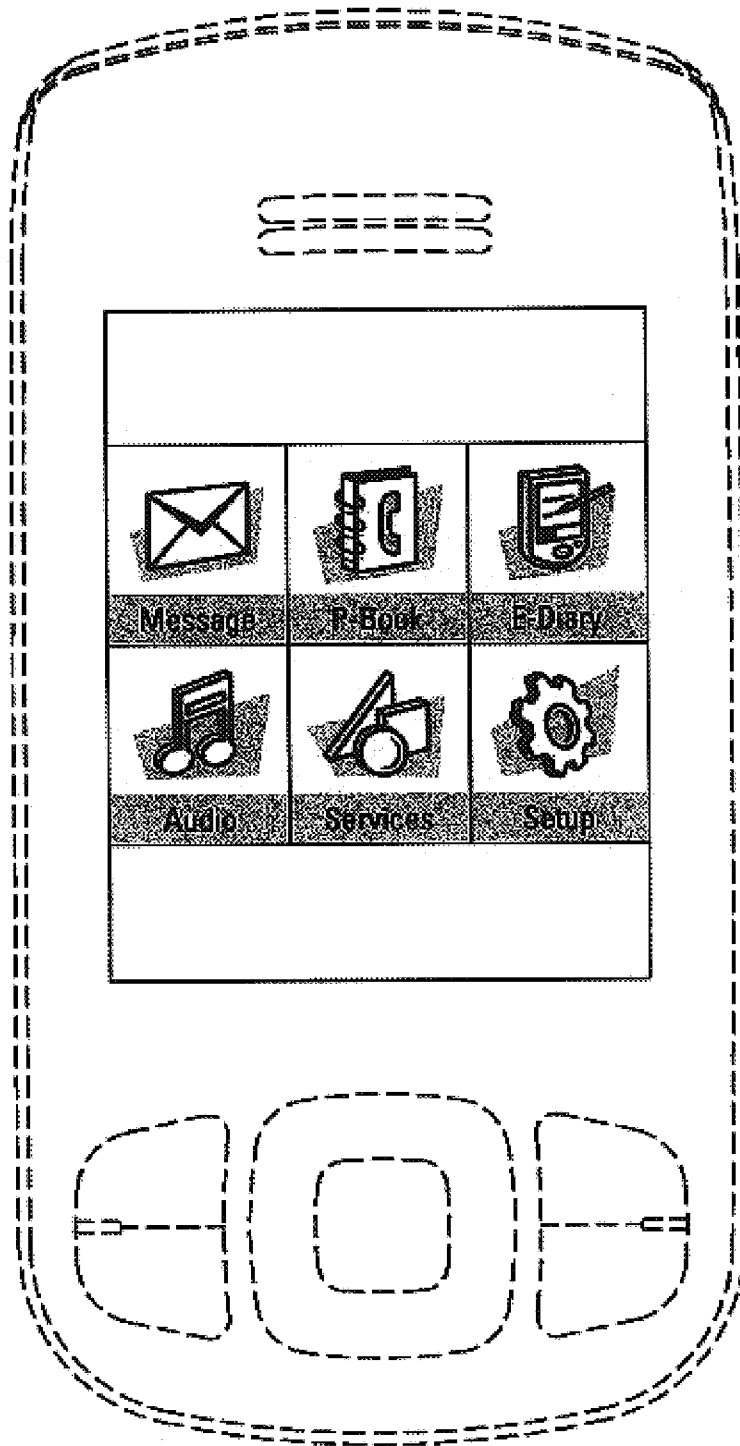

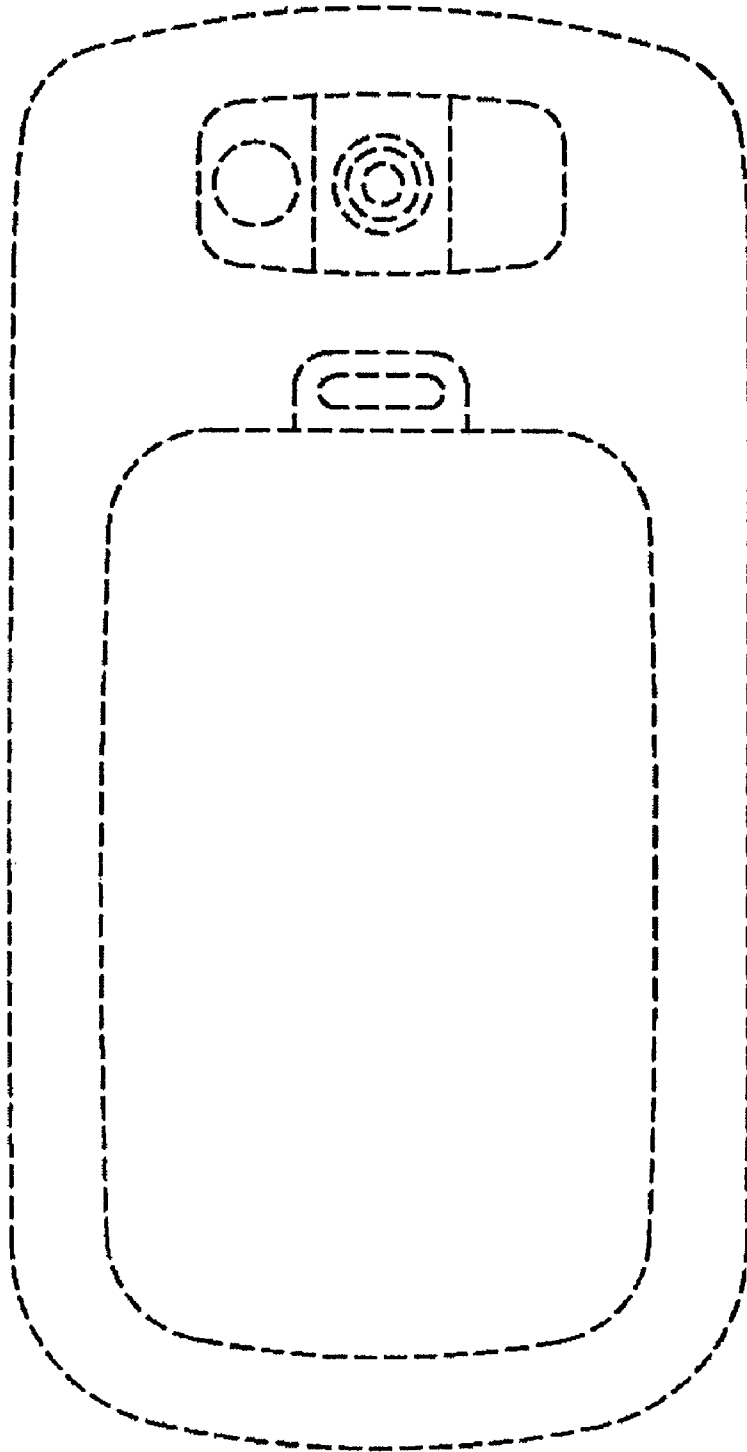

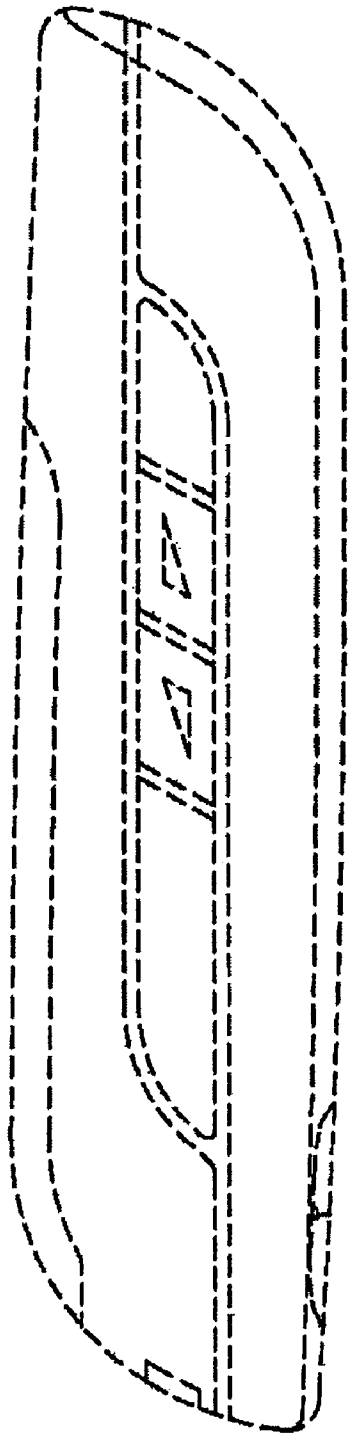

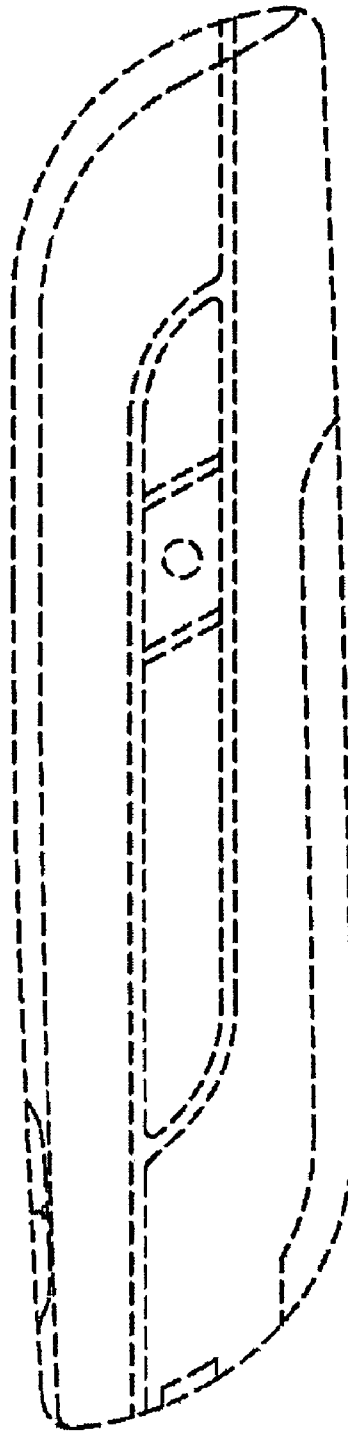

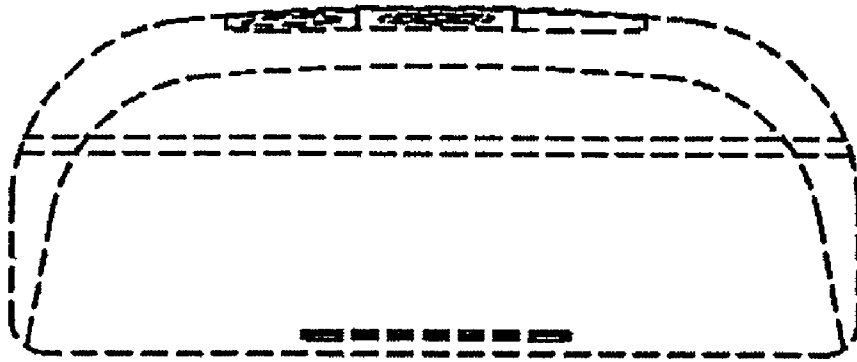

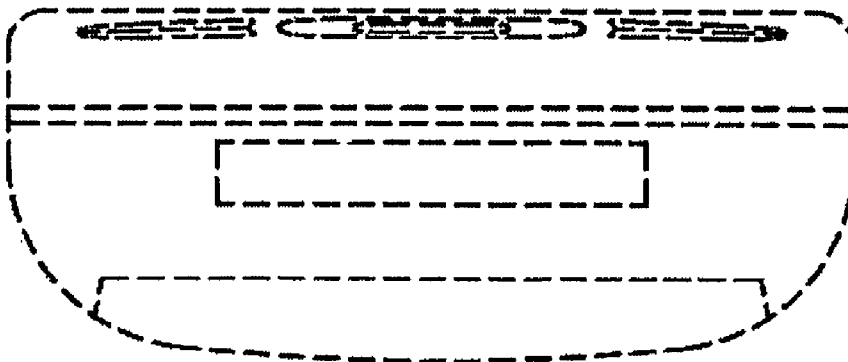
