**DESCRIPTION**

FIG. 1 is a Front and left perspective view of a bag with a lid open showing my new design;

FIG. 8 is a Bottom plan view of the bag illustrated in FIG. 1 with the lid open;


FIG. 9 is a Cross-section view of the bag illustrated in FIG. 1 with the lid open;



















