FIG. 5 is a right elevational view thereof;

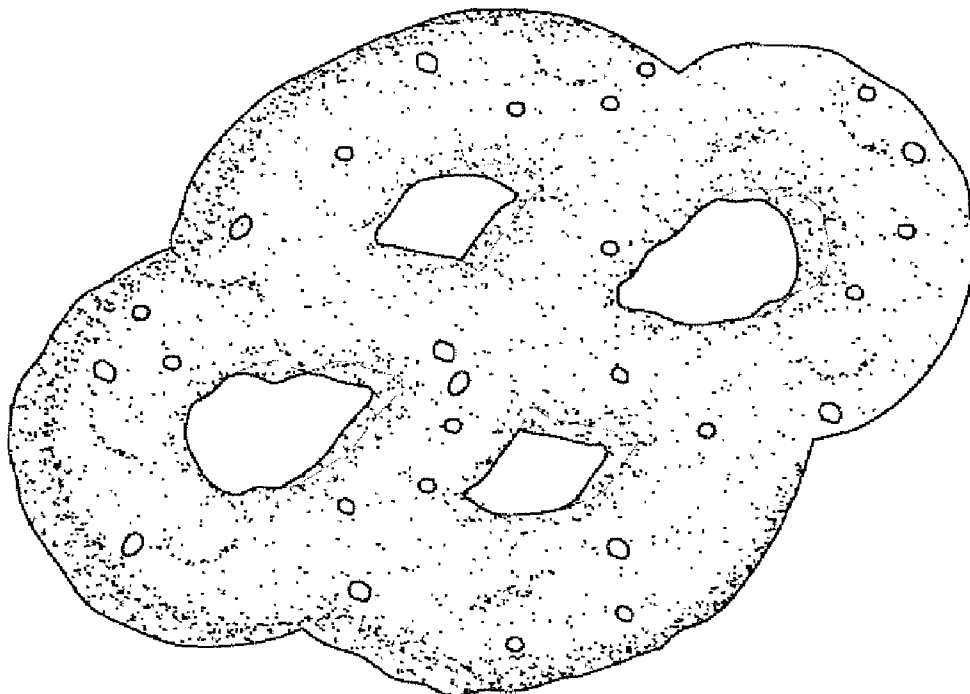
FIG. 6 is a left elevational view thereof; and,

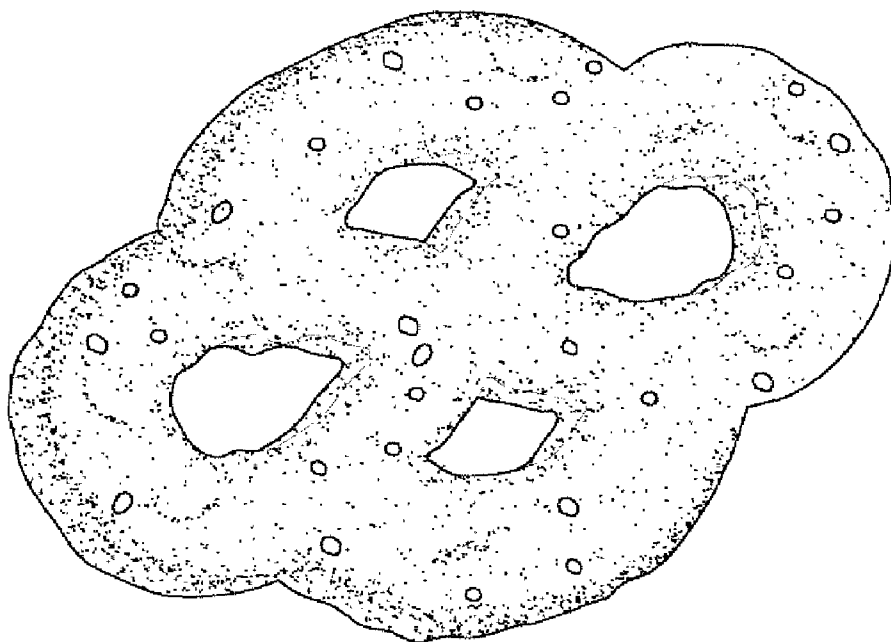
FIG. 7 is a bottom view thereof.

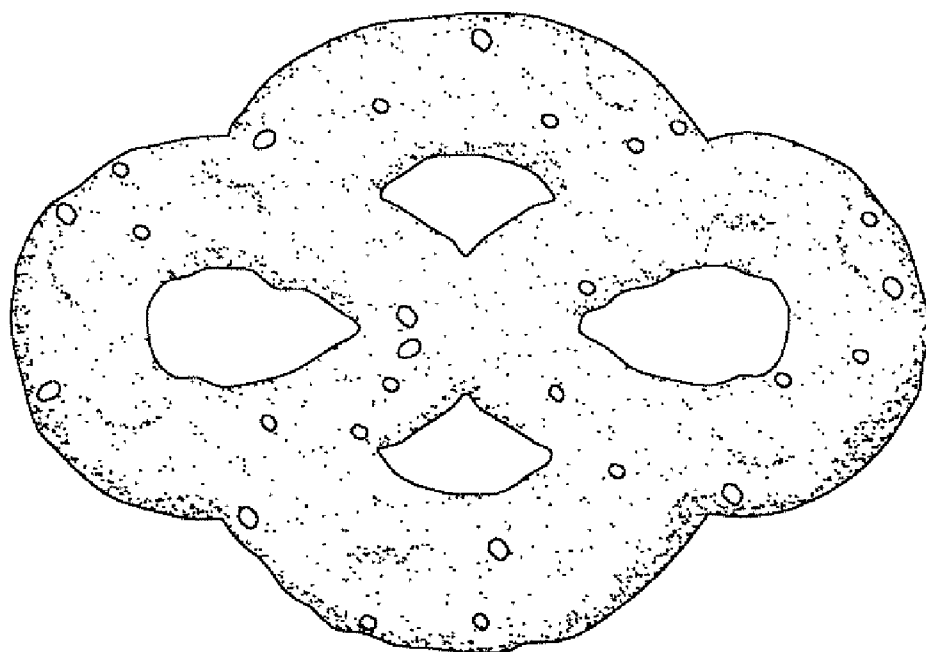

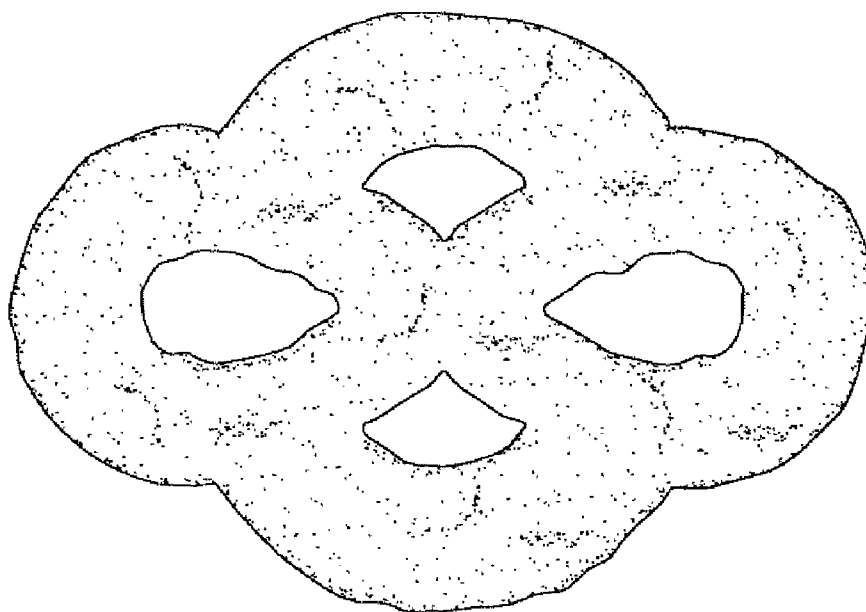
