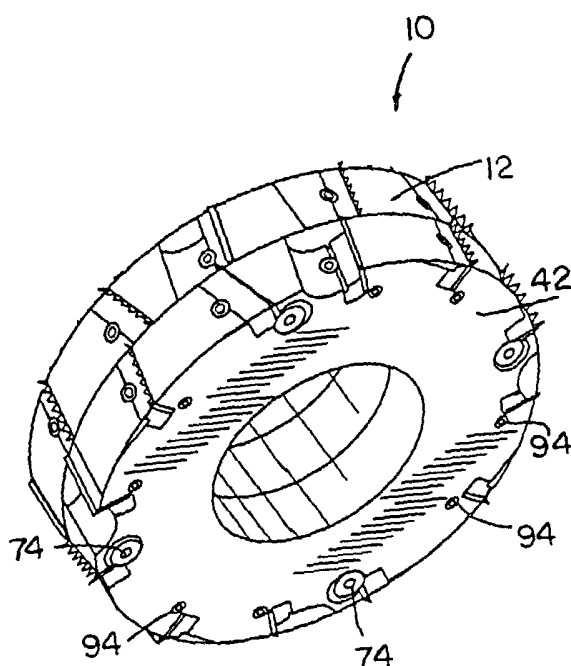

(57) Abstract: A plurality of cutter tools (12) are arranged to provide a cutter assembly (10), each cutter tool (12) being configured to hold replaceable cutter blades (14). The cutter blades (14) cooperate to cut a groove in a rubber material.
