(57) Abstract: The present invention concerns a dynamic mixture obtained by combining, in the presence of water, at least one  
diamine derivative, comprising at least one benzylamine moiety, with at least one active aldehyde or ketone. The invention's mix-  
ture is capable of releasing in a controlled and prolonged manner said active compound, in particular perfuming ingredients, in the  
surrounding environment.
