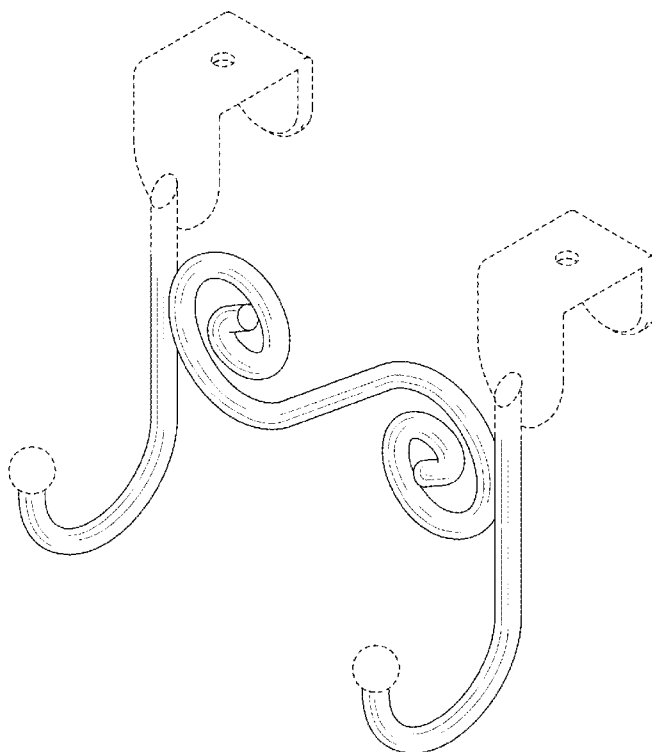
(57) **CLAIM**

What is claimed is the ornamental design for a double hook,
as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a double hook showing a new
design;
FIG. 2 is a top view of the double hook of FIG. 1;
FIG. 3 is a front view of the double hook of FIG. 1;
FIG. 4 is a side view of the double hook of FIG. 1;
FIG. 5 is a bottom view of the double hook of FIG. 1; and,
FIG. 6 is a rear view of the double hook of FIG. 1.
The components of the display shown in broken lines illus-
trate portions of the double hook form no part of the claimed
design.

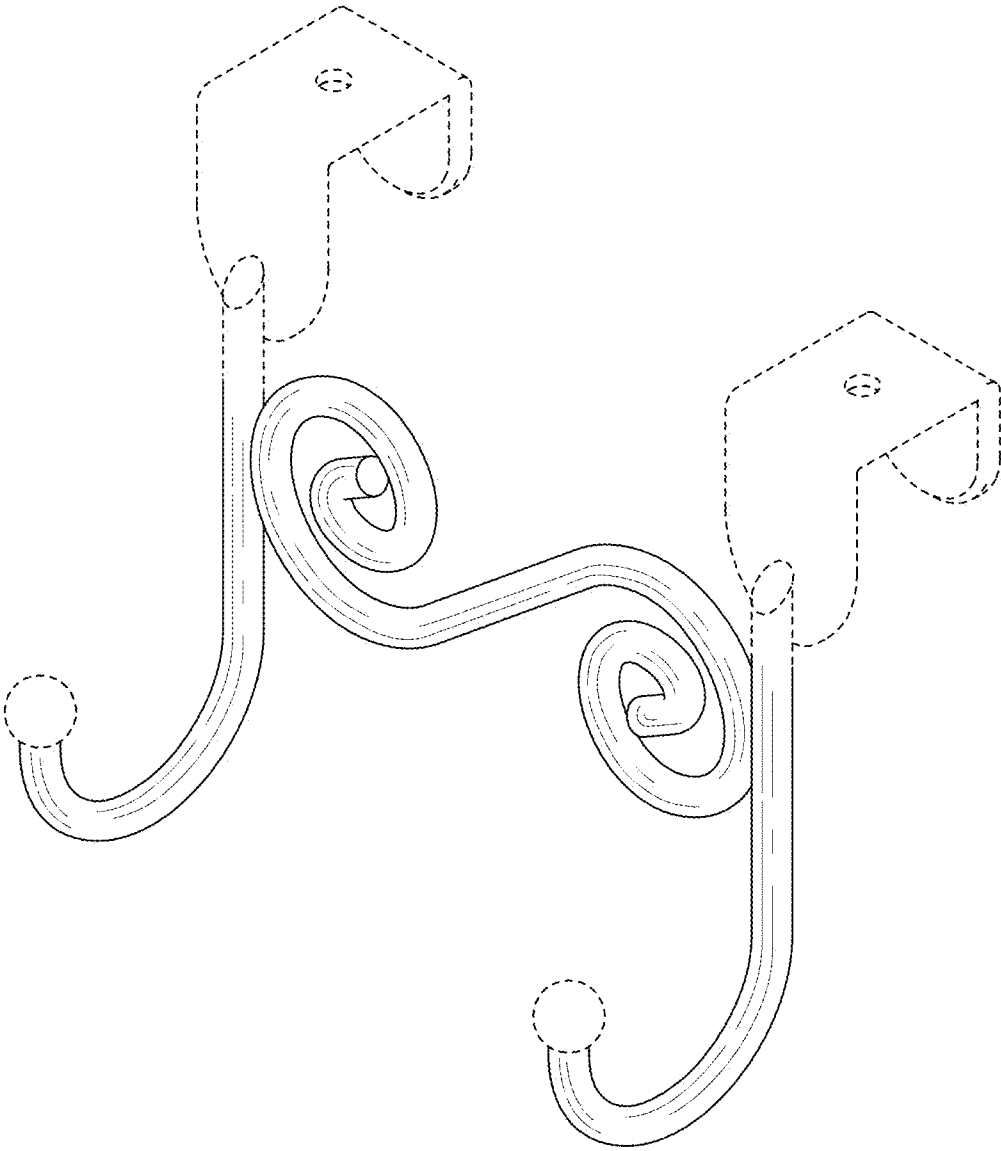

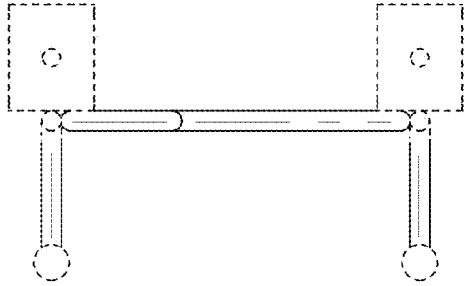

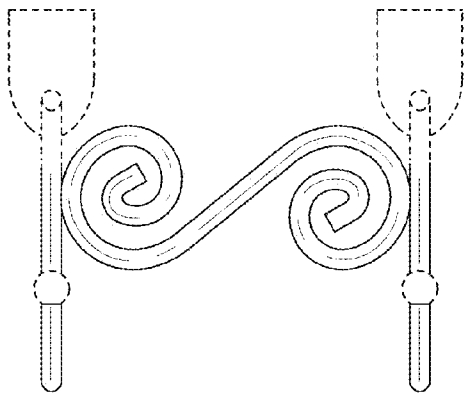

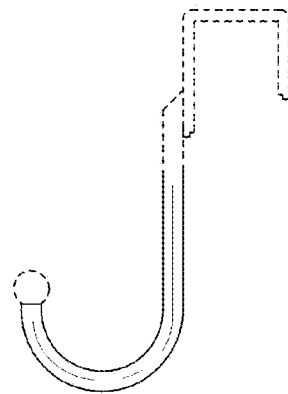

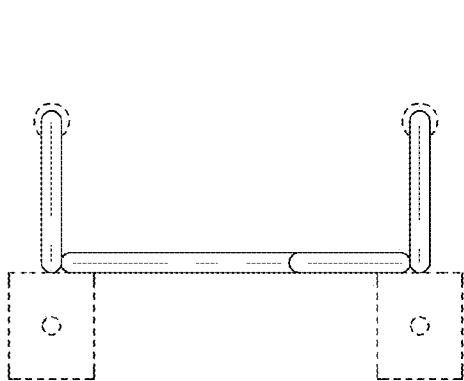

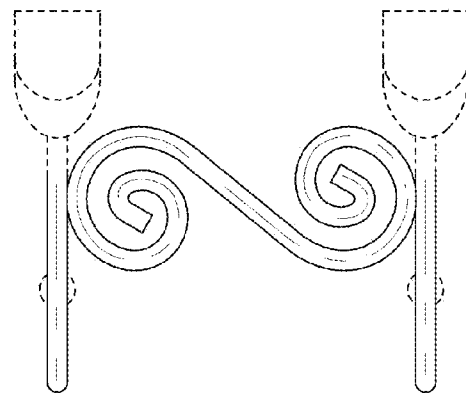
