(54) Title: ADHESIVE SOLUTION FOR APPLICATION TO THE SKIN

(57) Abstract: This invention relates to an adhesive solution for removably attaching items to the skin comprising :- (i) a solids content comprising a vinyl pyrrolidone copolymer, and either a plasticiser, and a separate wetting agent, or a compound that acts as both plasticiser and wetting agent (ii) water as a first solvent; and (iii) an alcohol as a second solvent wherein the amount of alcohol does not exceed 20 wt% of the whole solution, and the glass transition temperature (T_g) of the copolymer composition (i) is below 40°C.
