(57) **CLAIM**

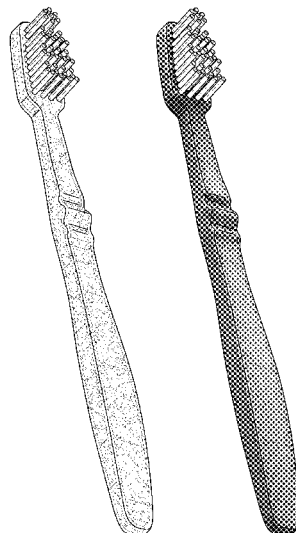
I claim the ornamental design for a toothbrush, as shown and described.

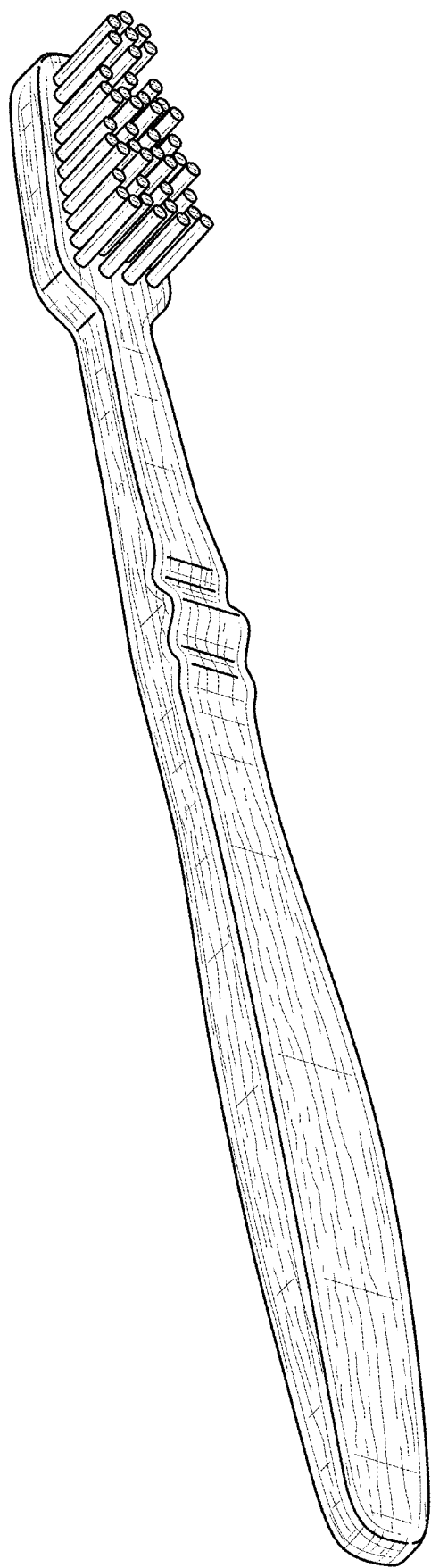

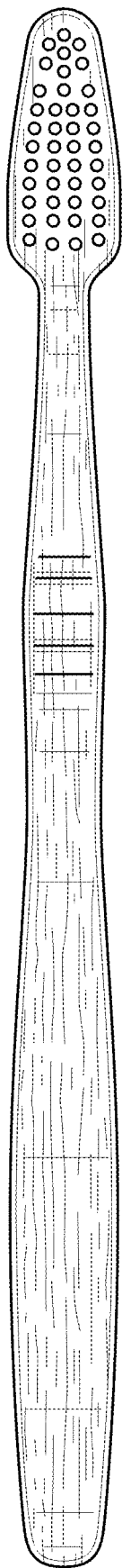

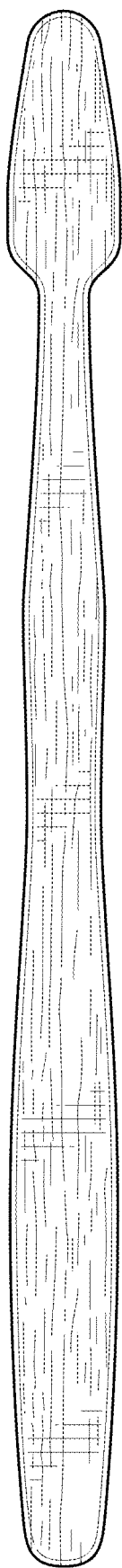

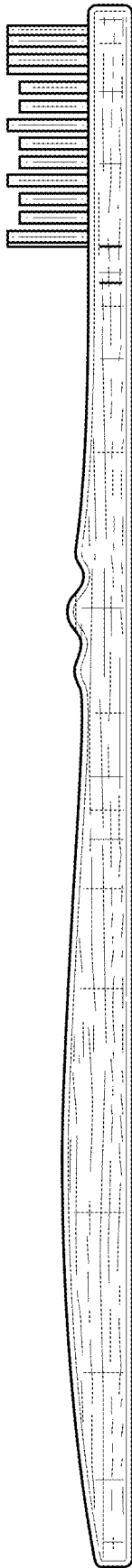

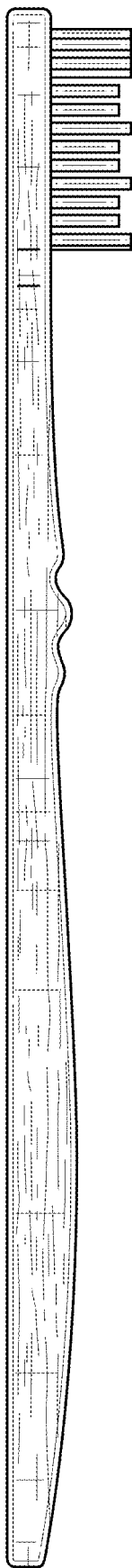

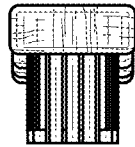

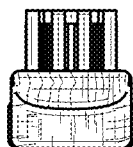

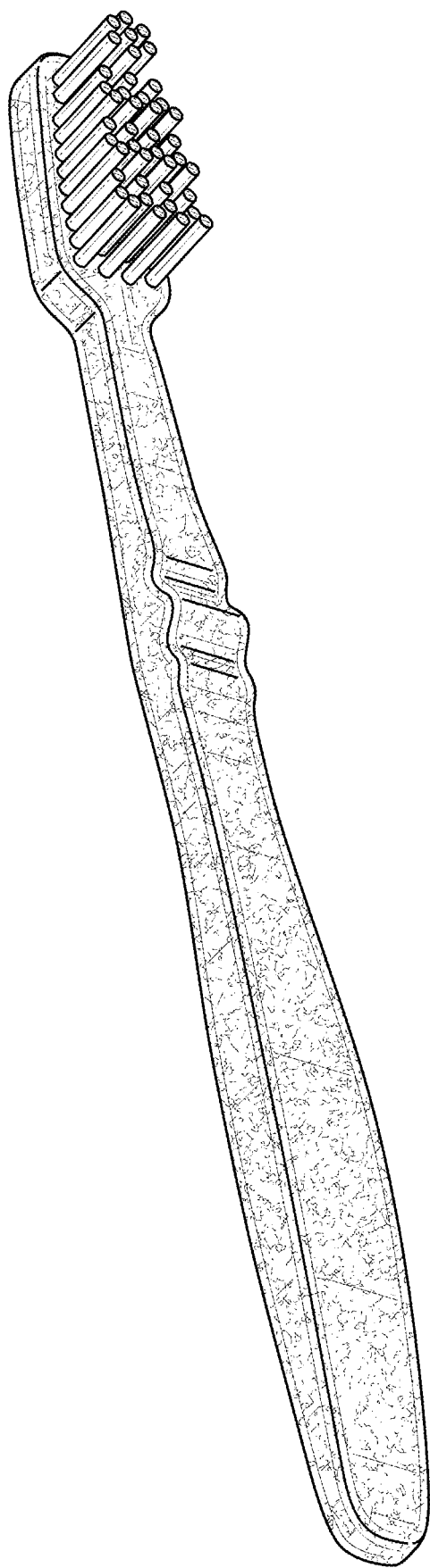

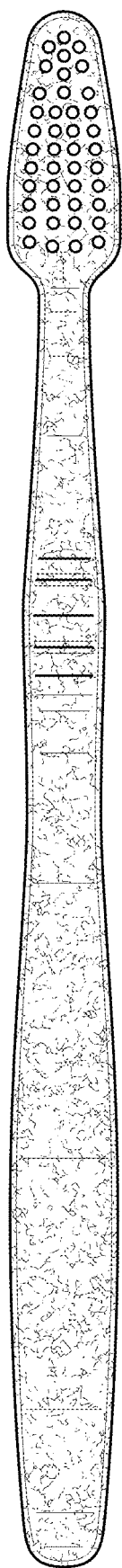

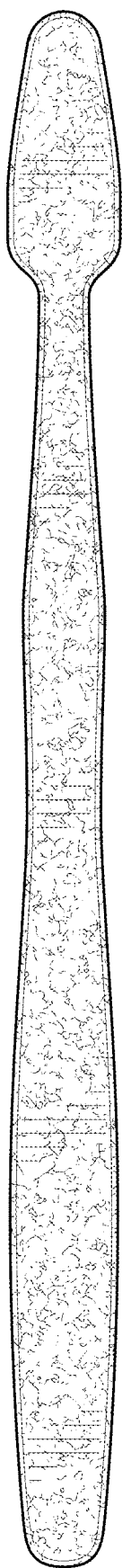

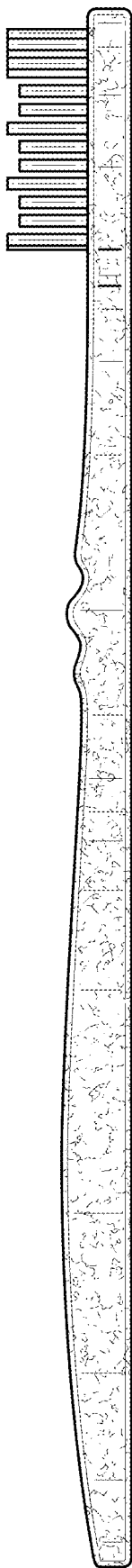

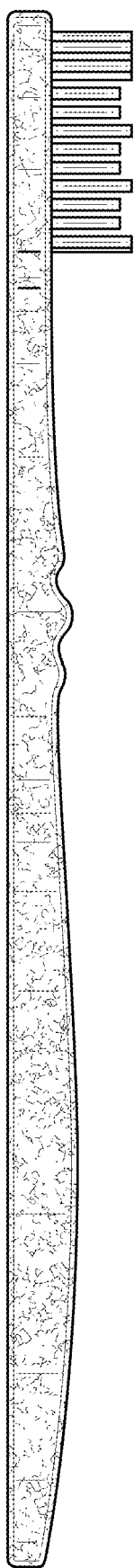

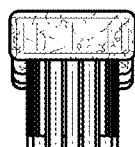

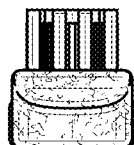

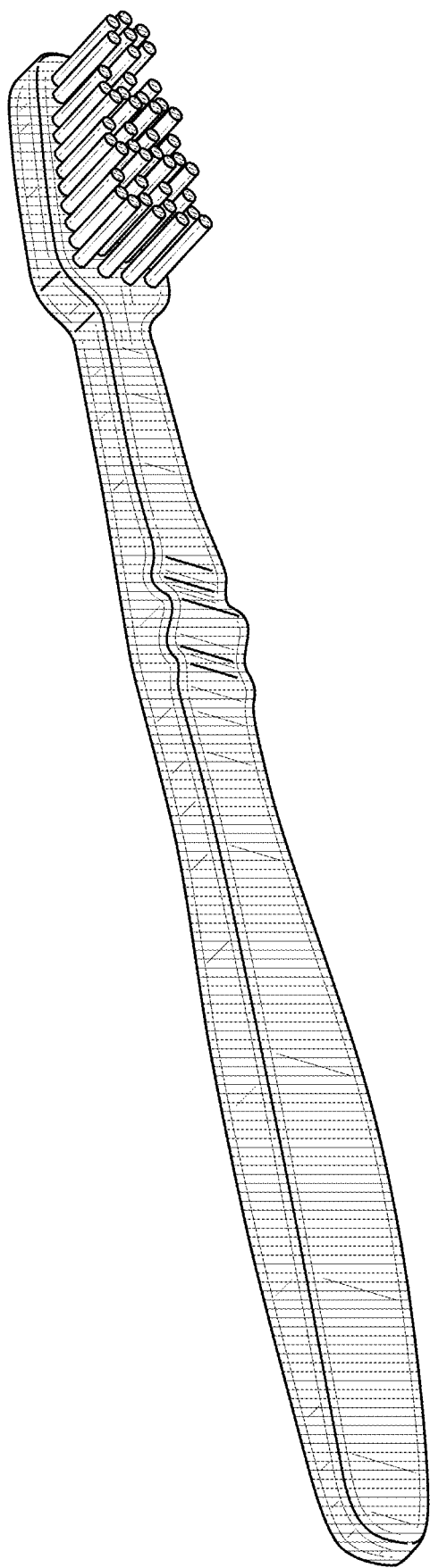

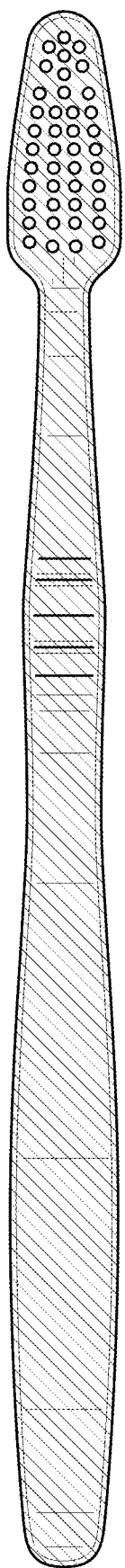

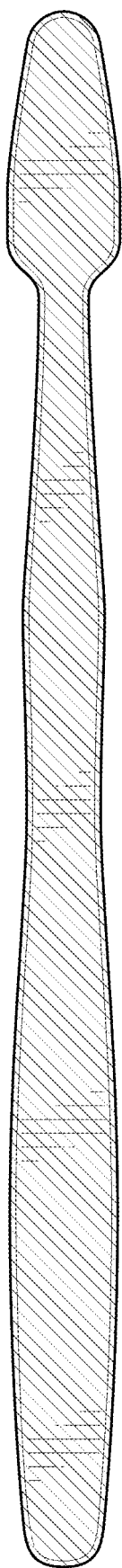

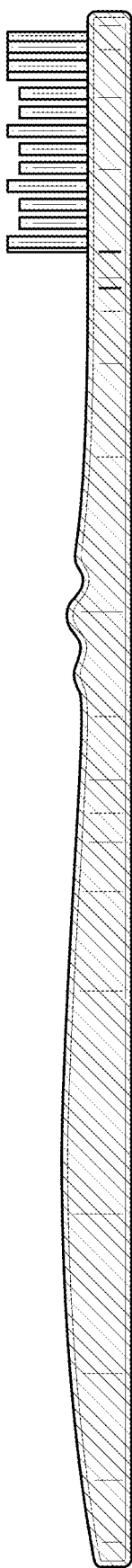

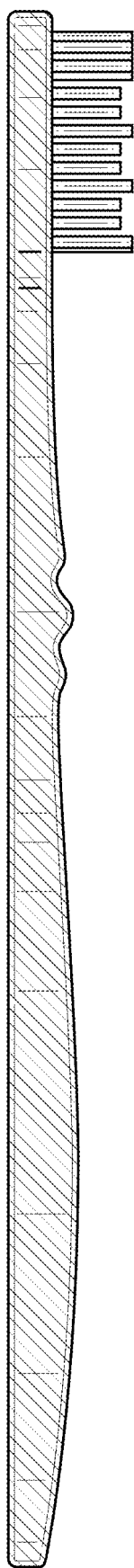

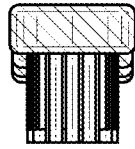

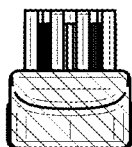

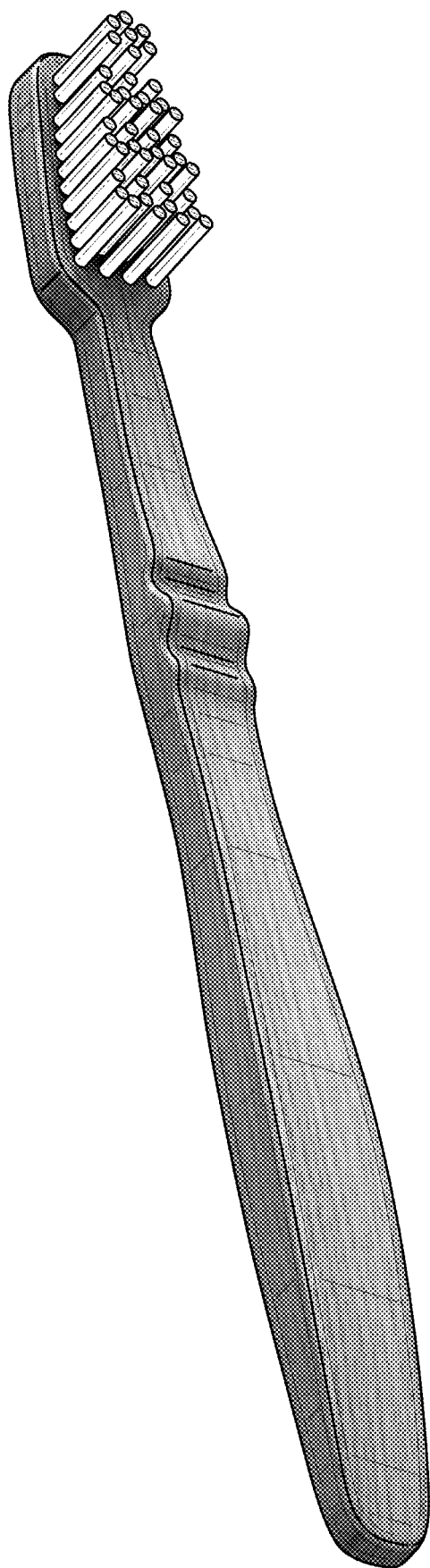

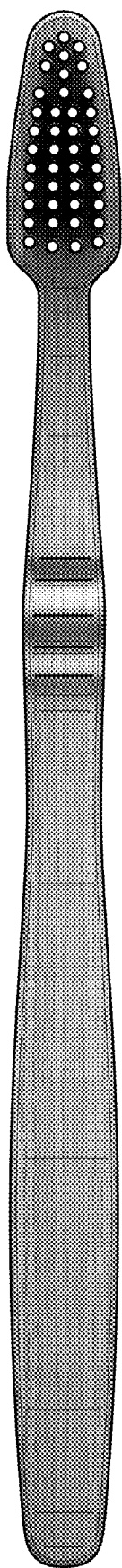

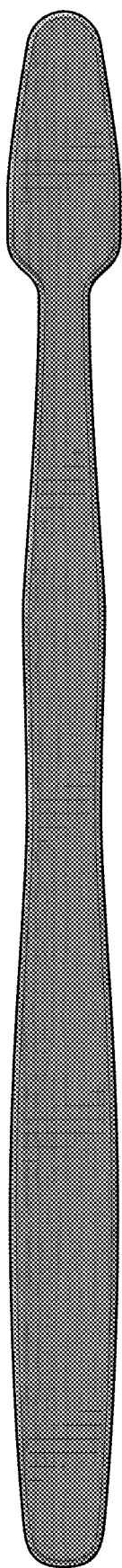

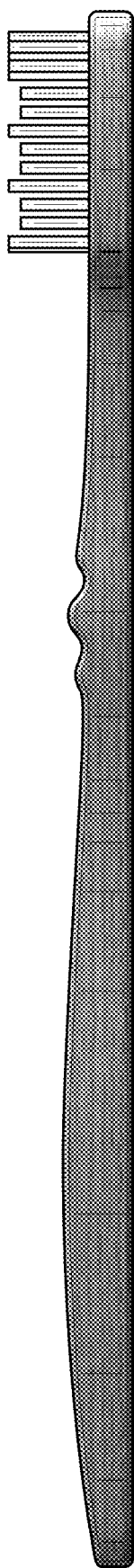

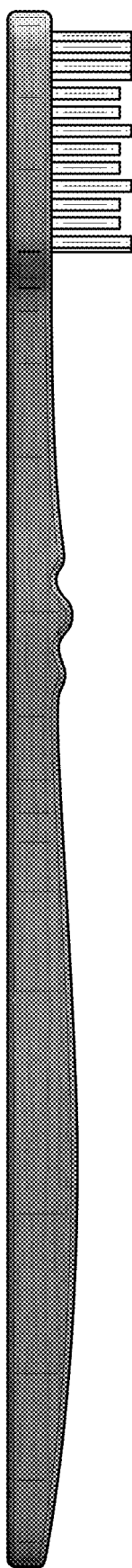

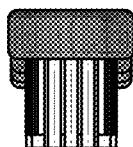

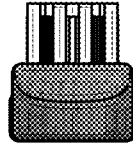

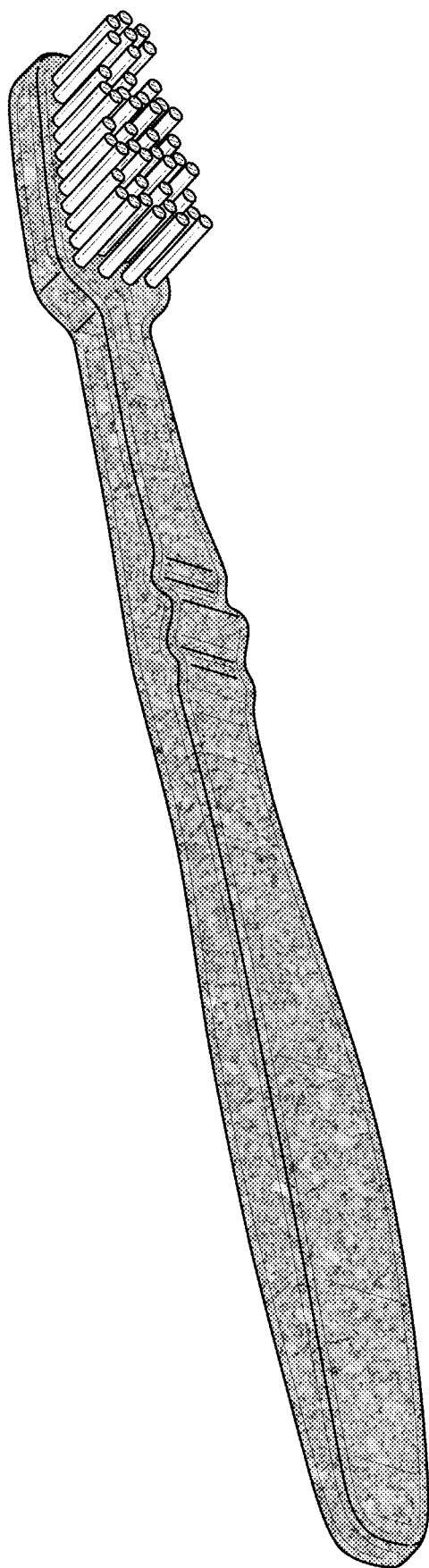

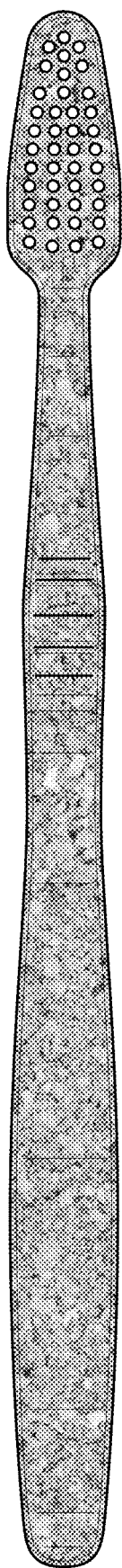

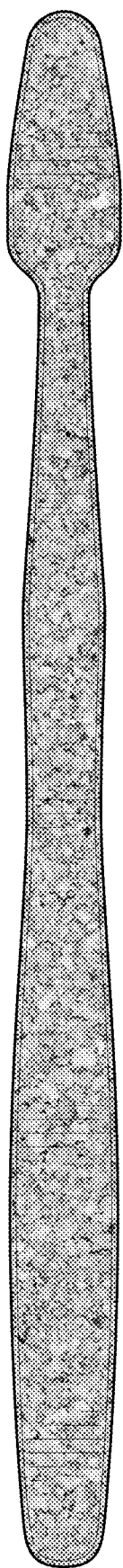

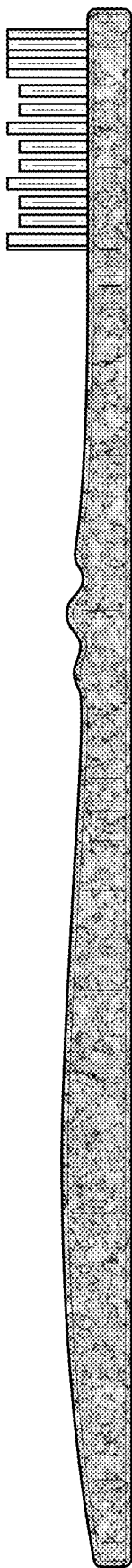

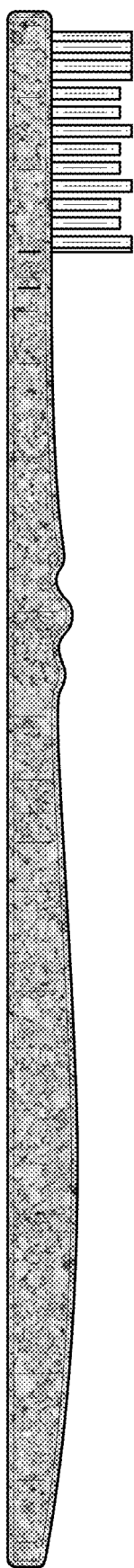

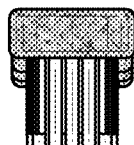

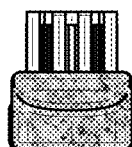
