
FIG. 1 is a front perspective view of a set of eyeglass components showing an embodiment of our new design;

FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;  
FIG. 5 is a top plan view thereof; and  
FIG. 6 is a bottom plan view thereof.  
FIG. 7 is a close-up left front perspective view of the embodiment of FIG. 1, the close-up right front perspective view being a mirror image thereof;  
FIG. 8 is a close-up left top plan view of the embodiment of FIG. 5, the close-up right top plan view being a mirror image thereof; and,  
FIG. 9 is a close-up left bottom plan view of the embodiment of FIG. 6, the close-up right bottom plan view being a mirror image thereof.  
The dash-dash broken lines in the Figures show portions of the eyeglass which form no part of the claimed design.


















