[57] CLAIM

The ornamental design for a portable radiotelephone, as shown and described.

DESCRIPTION

FIG. 1 is a left side, top and front perspective view of a portable radiotelephone showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a sectional view taken on line VIII—VIII in FIG. 6; and, FIG. 9 is a front top and left side perspective view thereof showing handset separated from stand it being understood that the broken lines are for illustrative purposes only and form no part of the claimed design.


















