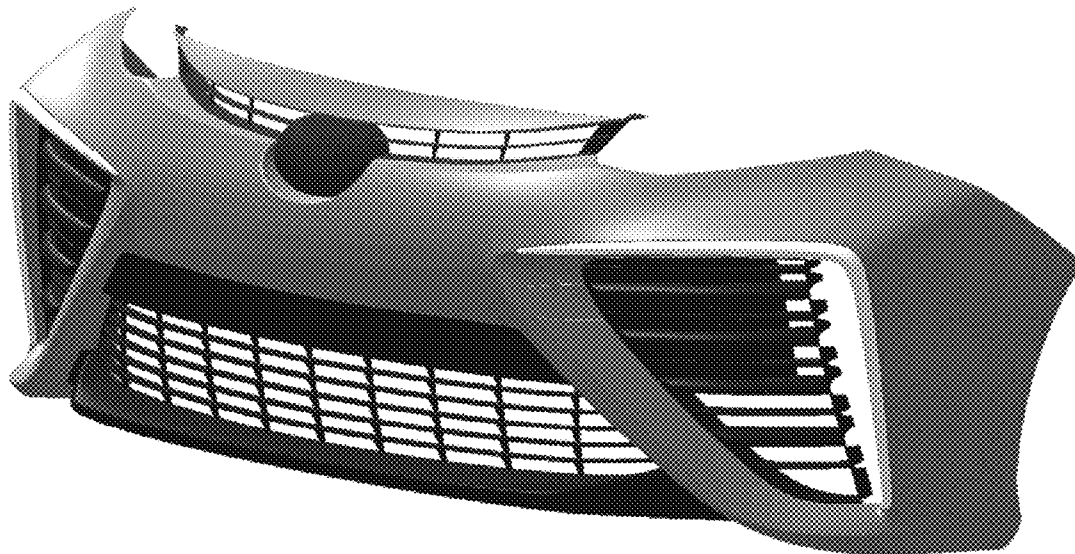
CLAIM

DESCRIPTION

FIG. 1 is a perspective view of a bumper for an automobile showing our new design;

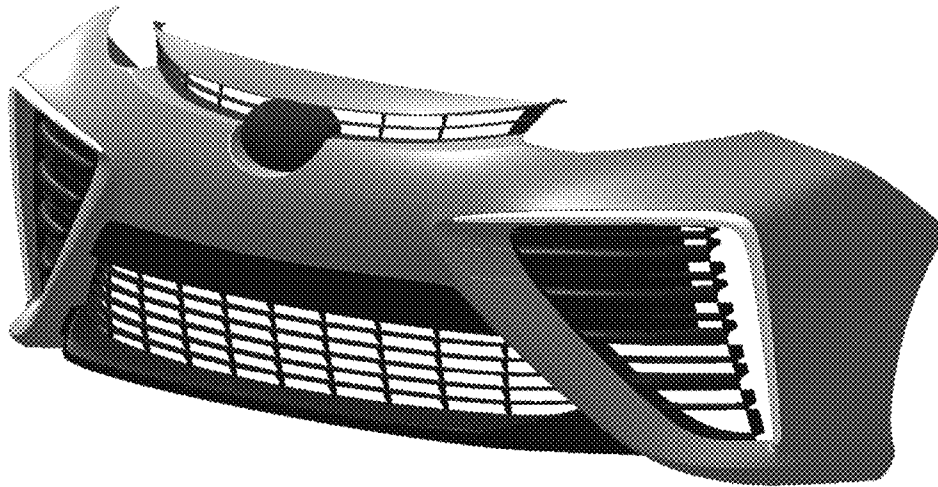

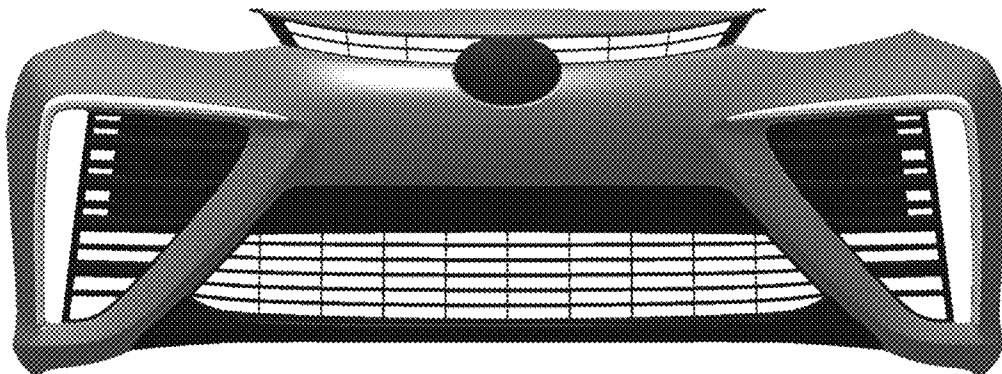

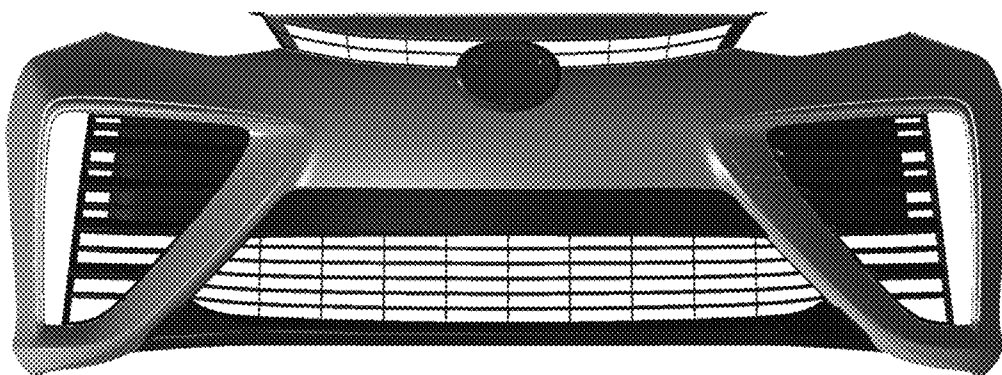

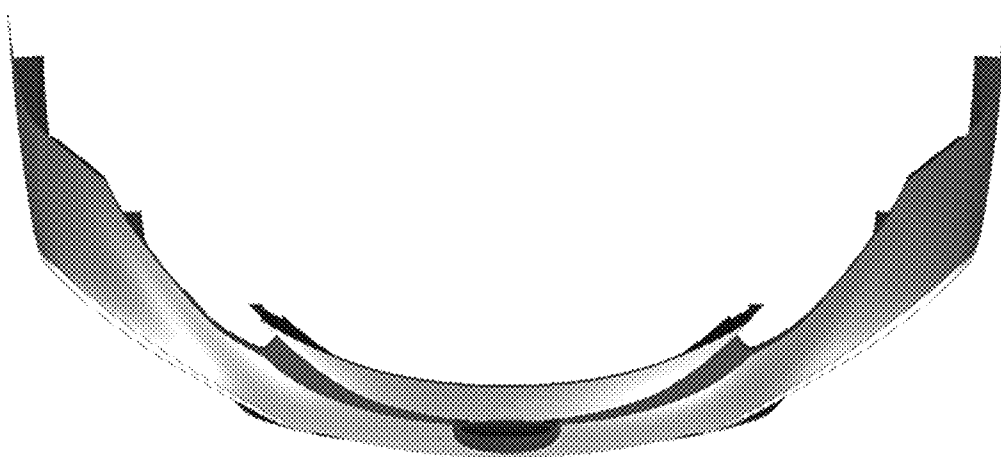

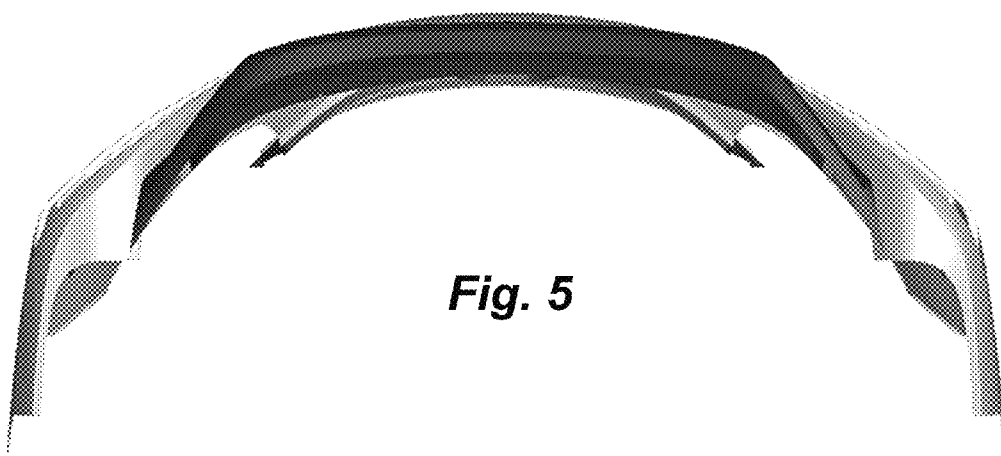

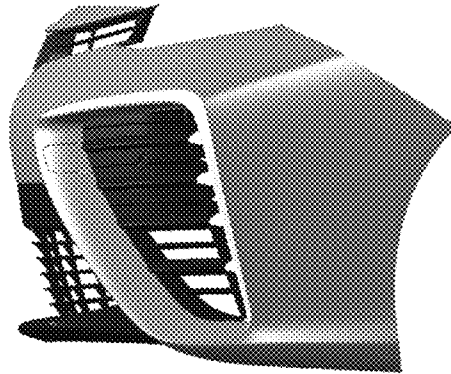

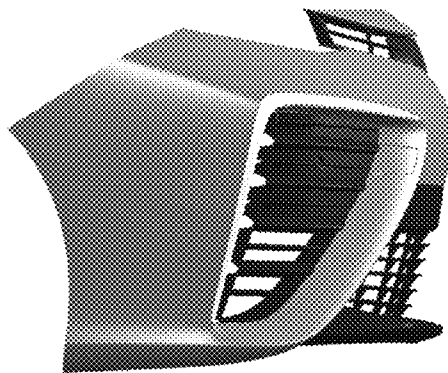
