**DESCRIPTION**

FIG. 1 is a front, top perspective view of a squeeze tube design showing my new design.

FIG. 2 is a front view of a squeeze tube.

FIG. 3 is a rear view of a squeeze tube.

FIG. 4 is a left side view of a squeeze tube.

FIG. 5 is a right side view of a squeeze tube.

FIG. 6 is a top view of a squeeze tube.

FIG. 7 is a bottom view of a squeeze tube.

FIG. 8 is a rear, bottom perspective view of a squeeze tube.

FIG. 9 is an enlarged view of a squeeze tube taken from the circle part in FIG. 6; and,

FIG. 10 is an enlarged view of a squeeze tube taken from the circle part in FIG. 7.




















