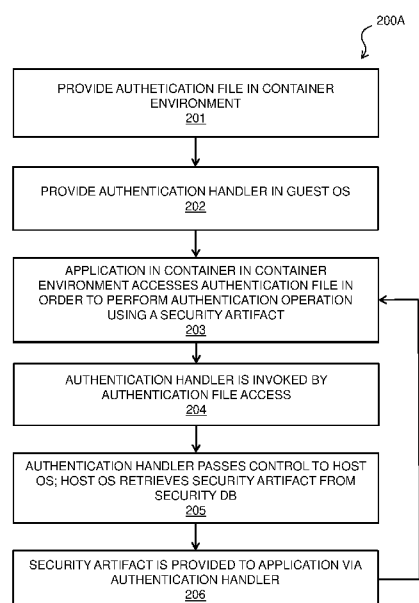

(57) Abstract: Techniques for integrated authentication for a container-based environment are described herein. An aspect includes accessing, by an application that is running in a container in a container environment that is hosted by a hypervisor on a host system, an authentication module that is located in the container environment. Another aspect includes invoking an authentication handler in the container environment based on the accessing of the authentication module. Another aspect includes passing control to the hypervisor from the authentication handler. Another aspect includes retrieving a security artifact from a security database of the host system by the hypervisor. Another aspect includes providing the retrieved security artifact to the application via the authentication handler. Another aspect includes performing an authentication operation by the application using the security artifact.

INTEGRATED AUTHENTICATION FOR CONTAINER-BASED ENVIRONMENT

BACKGROUND

[0001] The present invention generally relates to computer systems, and more specifically, to integrated authentication for a container-based environment.

[0002] In a cloud computing environment, computing is delivered as a service rather than a product, whereby shared resources, software, and information are provided to computers and other devices as a metered service over a network, such as the Internet. In such an environment, computation, software, data access, and storage services are provided to users that do not require knowledge of the physical location and configuration of the system that delivers the services.

[0003] A physical computer that is part of a virtualized computer environment can be referred to as a host. The virtualized computer environment, such as may be implemented in a physical cloud computing node of a cloud computing environment, can include a host operating system (OS) and one or more guest OSes. The host operating system can include a common base portion that supports a set of virtualized container environments that run on the physical computer. The common base portion may be referred to as a hypervisor. Each container environment can run a guest operating system and can support a number of containers. Each container can support one or more applications.

SUMMARY

[0004] Embodiments of the present invention are directed to for integrated authentication for a container-based environment. A non-limiting example computer-implemented method includes accessing, by an application that is running in a container in a container environment that is hosted by a hypervisor on a host system, an authentication module that is located in the container environment. The method also includes invoking an authentication handler in the container environment based on the accessing of the authentication module. The method also includes passing

control to the hypervisor from the authentication handler. The method also includes retrieving a security artifact from a security database of the host system by the hypervisor. The method also includes providing the retrieved security artifact to the application via the authentication handler. The method also includes performing an authentication operation by the application using the security artifact.

[0005] Other embodiments of the present invention implement features of the above-described method in computer systems and computer program products.

[0006] Additional technical features and benefits are realized through the techniques of the present invention. Embodiments and aspects of the invention are described in detail herein and are considered a part of the claimed subject matter. For a better understanding, refer to the detailed description and to the drawings.

BRIEF DESCRIPTION OF THE DRAWINGS

DETAILED DESCRIPTION

[0015] One or more embodiments of the present invention provide integrated authentication for a container-based environment. In order to perform authentication operations in a virtualized container environment, duplication of public and private certificate security artifacts (e.g., certificates and/or private keys) can be required. The duplicated security artifacts can be copied into well-known directories and file locations inside the guest OS, so that a guest OS and associated containers in the virtualized container environment can use those security artifacts for certificate verification and authentication. During the provision of the virtual environment, copies of any certificates can be injected into the virtual environment, and the virtual environment can place the certificates at the appropriate directory locations. However, for a cloud system that includes multiple instances of a guest OS, the security artifacts may be copied separately into each instance, which may require active management of the copied security artifacts in order to ensure that the copied security artifacts remain current throughout operation of the cloud system. Such security artifact management may be relatively complex, particularly for a virtualized container environment in an immutable appliance form.

[0016] Embodiments of integrated authentication for a container-based environment can integrate authentication operations for a virtualized container environment including a guest OS directly with underlying host OS security database (DB) that stores security artifacts without needing to duplicate the security artifacts in the virtualized container environment. The authentication operations can include, but are not limited to, transport security layer/secure socket layer (TLS/SSL) connections, lightweight directory access protocol (LDAP) connections, and hypertext transfer protocol secure (HTTPS) proxy server connections. The guest OS and host OS can each be any appropriate OS; in some embodiments of the invention, the host OS can be z/OS®, and the guest OS can be Linux®.

[0017] Embodiments of integrated authentication for a container-based environment can include an authentication module including an authentication file, or authentication file system, and an authentication handler. The authentication file or authentication file system can include a mapping of security artifacts, including but not limited to certificates and key rings (e.g., a resource access control facility, or RACF, keyring) that is provided as a placeholder at any appropriate directory locations in the guest OS. When the authentication file or authentication file system is accessed by an application running in a container in the virtualized container environment, the authentication handler is invoked to communicate locally with the underlying host OS to request the security artifact corresponding to the access from an underlying host security database (DB). Multiple instances of a guest OS can access the security artifacts in the security DB via each instance's respective authentication handler, such that provision of copies of the security artifacts throughout the system may not be required. In some embodiments, the authentication handler can implement a store hypervisor information (STHYI) instruction that allows the guest OS to communicate directly with the host OS environment without requiring network access. The virtualized container environment can run as a started task under a user identifier (ID) on the host environment, and the user ID can be used for authentication with the security DB to access a requested security artifact and convert the security artifact into any format that is required by the virtualized container environment.

[0018] Embodiments of the invention allow access to a secure centralized security DB, including a certificate and key store, that belongs to a hypervisor (i.e., a host operating system) and is stored in a native storage format of the hypervisor to be transparently accessible in real time to a number of instances of a guest OS via the guest OS's native interfaces, such that there is no need to statically export and store the keys and certificates into the formats used by the guest OS. Translations and conversions of security artifacts between the native formats of the hypervisor and the formats used by the guest OS can be performed in real time by the authentication handler, and the security artifacts can be converted from any storage format used in the security DB to any appropriate format that is required by an instance of the guest OS. The security DB can be subject to the hypervisor's access controls in order to limit access to the centralized certificate and key store based on the identity (e.g., a user ID) associated with a request from the guest OS.

[0019] Turning now to Fig. 1A, system 100A that includes integrated authentication for a container-based environment is generally shown in accordance with one or more embodiments of the present invention. Embodiments of system 100A can correspond to a cloud computing environment, such as is discussed below with respect to Figs. 3 and 4, and can be implemented in conjunction with any appropriate computer system, including but not limited to computer system 500 of Fig. 5. System 100A includes a host system, including resources such as address spaces 101, central processing unit (CPU) pool 102, datasets 111, and network 112, that run a host OS virtualization layer 110 (also referred to as a hypervisor). Embodiments of the host OS virtualization layer 110 can include any appropriate OS, including but not limited to z/OS. Host OS virtualization layer 110 supports a number of virtualized container environments 103A-N. Each virtualized container environment of virtualized container environments 103A-N runs a guest OS such as guest OS 106 as is shown in virtualized container environment 103A. Guest OS 106 can include any appropriate OS, including but not limited to Linux. As shown in container environment 103A, each container environment of container environments 103A-N hosts a respective set of containers such as containers 104A-N. Each container of containers 104A-N can host one or more applications. The containers 104A-N are

supported by a container runtime environment 105. In some embodiments of the invention, the container runtime environment 105 can include Docker®. The container runtime environment 105 is hosted by the guest OS 106 and guest OS virtualization layer 108. Each container environment of container environments 103A-N can include a respective instance of the container runtime environment 105, guest OS 106, and guest OS virtualization layer 108 as shown in container environment 103A. The container environments 103A-N can access the resources of the host system via guest OS virtualization layer 108 and host OS virtualization layer 110.

[0020] Security DB 113 can include a stored set of security artifacts, including but not limited to certificates and keys, for use in authentication operations. As shown in Fig. 1A, applications hosted in containers 104A-N in container environment 103A can access the security artifacts in security DB 113 via an authentication module including authentication file 107A and authentication handler 109A. Each of container environments 103A-N can include respective authentication files such as authentication file 107A, and an authentication handler such as authentication handler 109A, for communication with security DB 113. Authentication operations that can be performed in embodiments of system 100A via authentication file 107A and authentication handler 109A include, but are not limited to, a TLS/SSL connection from a virtual environment Docker daemon (e.g., container runtime environment 105) to an external Docker registry, to an LDAP server for user authentication, or to an HTTP/HTTPS proxy server. Operation of authentication file 107A and authentication handler 109A are discussed in further detail below with respect to method 200A of Fig. 2A.

[0021] In some embodiments of the invention, the names of security artifacts in the security DB 113 can be provided in container environment 103A via authentication file 107A. During the provision of the container environment 103A, the names of any security artifacts can be provided to the guest OS 106. The container environment 103A can create a mapping of security artifacts from security DB 113 to one or more authentication files such as authentication file 107A, and can place one or more authentication files such as authentication file 107A as placeholders at

appropriate directory locations. For example, in some embodiments of the invention, for a private Docker registry, an authentication file 107A can be placed under the /etc/docker/certs.d directory; for an LDAP server, an authentication file 107A can be placed under /etc/ldap/ldap-ca; and for an HTTP/HTTPS proxy server, an authentication file 107A can be placed under /etc/certs.d/docker-proxy-ca. When an authentication file such as authentication file 107A is accessed by any of containers 104A-N, the authentication handler 109A can be invoked by the access to communicate locally with the underlying host OS virtualization layer 110 to request a security artifact corresponding to the access from the underlying security DB 113. The authentication file 107A can have a predefined special file extension, and the invoking of authentication handler 109A can be performed by guest OS 106 based on the predefined file extension of authentication file 107A. The authentication handler 109A can include an extended STHYI instruction that allows the guest OS 106 to communicate directly with the host OS virtualization layer 110 without requiring network access. The container environment 103A can run as a started task having an associated a user ID on the host OS virtualization layer 110, and the user ID can be used by authentication handler 109A to authenticate with the security DB 113 and obtain any requested CA certificates from the appropriate key rings. The authentication handler 109A can convert the requested certificates from a format used in the security DB 113 into any appropriate format that is required by the container environment 103A.

[0022] In some embodiments of system 100A, the security artifacts in the security DB 113 can include certificates, and cleartext or encrypted private keys (e.g., such as are used by Integrated Cryptographic Service Facility, or ICSF), for use by server-side applications deployed inside the virtual environment, and by applications running inside the containers 104A-N that are supported by the guest OS 106. In some embodiments of system 100A, RACF can be the underlying host OS security product that is implemented in the security DB 113, and real and virtual key rings can be used for certificate and private key storage. A real keyring is explicitly defined and configured to include specific certificates and private keys corresponding to a user ID. A RACF virtual keyring is the set of all certificates and private keys owned by a user

ID in the host environment corresponding to host OS virtualization layer 110. The set of certificates in a RACF key ring can be used by a user or server application to determine the trustworthiness of a client or peer. Each RACF user ID can be associated with a virtual keyring. A special certificate authority (CERTAUTH) virtual keyring can include all trusted CA certificates in the RACF database that comprises the security DB 113, and can be accessed by any user ID. Certificates associated with keyrings can be associated with user IDs, stored in security DB 113, and retrieved for application usage and peer verification via authentication file 107A and authentication handler 109A.

[0023] The RACF database that can comprise embodiments of security DB 113 can store certificates in an internal binary format, such as privacy-enhanced mail (PEM) format and Base64 encoded X.509 certificates. The PEM and Base64 formats are text formats, and may be transported by authentication handler 109A as text. In some embodiments of the invention, the authentication handler 109A can perform a conversion from extended binary coded decimal interchange code (EBCDIC) to American standard code for information exchange (ASCII) based on the certificate package format type and the guest OS 106. The authentication handler 109A can automatically convert from a RACF binary format into any format that is required by the virtualized container environment 103A. The certificates can be converted into any appropriate format by the authentication handler 109A for use in the guest OS 106, including but not limited to PEM format, public key cryptography standards (PKCS) #12 packages, or implementation-specific formats including but not limited to Java® keystores or OpenSSL key databases. The authentication handler 109A can serve the certificates in any required guest OS certificate format based on the type of certificate and the virtualization environment guest OS 106.

[0024] It is to be understood that the block diagram of Fig. 1A is not intended to indicate that the system 100A is to include all of the components shown in Fig. 1A. Rather, the system 100A can include any appropriate fewer or additional components not illustrated in Fig. 1A (e.g., additional memory components, embedded controllers, functional blocks, connections between functional blocks, modules, inputs, outputs, address spaces, CPUs, virtualized container environments, container runtime

environments, guest OSes, guest OS virtualization layers, authentication files, authentication handlers, containers, applications, security databases, etc.). Further, the embodiments described herein with respect to system 100A may be implemented with any appropriate logic, wherein the logic, as referred to herein, can include any suitable hardware (e.g., a processor, an embedded controller, or an application specific integrated circuit, among others), software (e.g., an application, among others), firmware, or any suitable combination of hardware, software, and firmware, in various embodiments.

[0025] Turning now to Fig. 1B, system 100B that includes integrated authentication for a container-based environment is generally shown in accordance with one or more embodiments of the present invention. Embodiments of system 100B can correspond to a cloud computing environment, such as is discussed below with respect to Figs. 3 and 4, and can be implemented in conjunction with any appropriate computer system, including but not limited to computer system 500 of Fig. 5. System 100B includes a host system, including resources such as address spaces 101, central processing unit (CPU) pool 102, datasets 111, and network 112, that run a host OS virtualization layer 110 (also referred to as a hypervisor). Embodiments of the host OS virtualization layer 110 can include any appropriate OS, including but not limited to z/OS. Host OS virtualization layer 110 supports a number of virtualized container environments 103A-N. Each virtualized container environment of virtualized container environments 103A-N runs a guest OS such as guest OS 106 as is shown in virtualized container environment 103A. Guest OS 106 can include any appropriate OS, including but not limited to Linux. As shown in container environment 103A, each container environment of container environments 103A-N hosts a respective set of containers such as containers 104A-N. Each container of containers 104A-N can host one or more applications. The containers 104A-N are supported by a container runtime environment 105. In some embodiments of the invention, the container runtime environment 105 can include Docker®. The container runtime environment 105 is hosted by the guest OS 106 and guest OS virtualization layer 108. Each container environment of container environments 103A-N can include a respective instance of the container runtime environment 105,

guest OS 106, and guest OS virtualization layer 108 as shown in container environment 103A. The container environments 103A-N can access the resources of the host system via guest OS virtualization layer 108 and host OS virtualization layer 110.

[0026] Security DB 113 can include a stored set of security artifacts, including but not limited to certificates and keys, for use in authentication operations. As shown in Fig. 1B, applications hosted in containers 104A-N in container environment 103A can access the security artifacts in security DB 113 via an authentication module including an authentication file system 107B, which includes authentication handler 109B. Each of container environments 103A-N can include respective a respective authentication file system 107B such as authentication file system 107B, including a respective authentication handler such as authentication handler 109B, for communication with security DB 113. Authentication operations that can be performed in embodiments of system 100B via authentication file system 107B and authentication handler 109B include, but are not limited to, a TLS/SSL connection from a virtual environment Docker daemon (e.g., container runtime environment 105) to an external Docker registry, to an LDAP server for user authentication, or to an HTTP/HTTPS proxy server. Operation of authentication file system 107B and authentication handler 109B are discussed in further detail below with respect to method 200B of Fig. 2B.

[0027] In some embodiments of the invention, the names of security artifacts in the security DB 113 can be provided in container environment 103A via placeholder files in authentication file system 107B. Authentication file system 107B can include a mapping of security artifacts from security DB 113 to one or more placeholder files in the authentication file system 107B. The placeholder files in the authentication file system 107B can correspond to symbolic links that are mounted at appropriate locations in the regular file system of the guest OS 106. For example, in some embodiments of the invention, for a private Docker registry, a symbolic link to a placeholder file in authentication file system 107B can be included in a /etc/docker/certs.d directory; for an LDAP server, a symbolic link to a placeholder file in authentication file system 107B can be included in a /etc/ldap/ldap-ca directory;

and for an HTTP/HTTPS proxy server, a symbolic link to a placeholder file in authentication file system 107B can be included in a /etc/certs.d/docker-proxy-ca directory in the regular file system of the guest OS 106. Based on an application accessing a symbolic link in order to perform an authentication operation, the file access request can be redirected by the guest OS 106 to the placeholder file in the authentication file system 107B that corresponds to the symbolic link. When any placeholder file in authentication file system 107B is accessed by any of containers 104A-N, the authentication handler 109B in authentication file system 107B can be invoked to communicate locally with the underlying host OS virtualization layer 110 to request a security artifact corresponding to the access from the underlying security DB 113. The authentication handler 109B can include an extended STHYI instruction that allows the guest OS 106 to communicate directly with the host OS virtualization layer 110 without requiring network access. The container environment 103A can run as a started task having an associated a user ID on the host OS virtualization layer 110, and the user ID can be used by authentication handler 109B to authenticate with the security DB 113 and obtain any requested CA certificates from the appropriate key rings. The authentication handler 109B can convert the requested certificates from a format used in the security DB 113 into any appropriate format that is required by the container environment 103A. In some embodiments of system 100B, the authentication file system 107B can include file system in user space (FUSE). Embodiments of a system 100B including an authentication file system 107B may not require any kernel changes to the guest OS 106. Any additional metadata that may be needed in container environment 103A can be maintained in authentication file system 107B.

[0028] In some embodiments of system 100B, the security artifacts in the security DB 113 can include certificates, and cleartext or encrypted private keys (e.g., such as are used by ICSF), for use by server-side applications deployed inside the virtual environment, and by applications running inside the containers 104A-N that are supported by the guest OS 106. In some embodiments of system 100B, RACF can be the underlying host OS security product that is implemented in the security DB 113, and real and virtual key rings can be used for certificate and private key storage. A

real keyring is explicitly defined and configured to include specific certificates and private keys corresponding to a user ID. A RACF virtual keyring is the set of all certificates and private keys owned by a user ID in the host environment corresponding to host OS virtualization layer 110. The set of certificates in a RACF key ring can be used by a user or server application to determine the trustworthiness of a client or peer. Each RACF user ID can be associated with a virtual keyring. A special certificate authority (CERTAUTH) virtual keyring can include all trusted CA certificates in the RACF database that comprises the security DB 113, and can be accessed by any user ID. Certificates associated with keyrings can be associated with user IDs, stored in security DB 113, and retrieved for application usage and peer verification by authentication file system 107B and authentication handler 109B.

[0029] The RACF database that can comprise embodiments of security DB 113 can store certificates in an internal binary format, such as privacy-enhanced mail (PEM) format and Base64 encoded X.509 certificates. The PEM and Base64 formats are text formats, and may be transported by authentication handler 109B as text. In some embodiments of the invention, the authentication handler 109B can perform a conversion from extended binary coded decimal interchange code (EBCDIC) to American standard code for information exchange (ASCII) based on the certificate package format type and the guest OS 106. The authentication handler 109B can automatically convert from a RACF binary format into any format that is required by the virtualized container environment 103A. Some conversions by authentication handler 109B may require metadata stored within the authentication file system 107B, or can be performed based on configuration parameters that are set during mounting of the authentication file system 107B. The certificates can be converted into any appropriate format by the authentication handler 109B for use in the guest OS 106, including but not limited to PEM format, public key cryptography standards (PKCS) #12 packages, or implementation-specific formats including but not limited to Java® keystores or OpenSSL key databases. The authentication handler 109B can serve the certificates in any required guest OS certificate format based on the type of certificate and the virtualization environment guest OS 106.

[0030] It is to be understood that the block diagram of Fig. 1B is not intended to indicate that the system 100B is to include all of the components shown in Fig. 1B. Rather, the system 100B can include any appropriate fewer or additional components not illustrated in Fig. 1B (e.g., additional memory components, embedded controllers, functional blocks, connections between functional blocks, modules, inputs, outputs, address spaces, CPUs, virtualized container environments, container runtime environments, guest OSes, guest OS virtualization layers, authentication file systems, authentication handlers, containers, applications, security databases, etc.). Further, the embodiments described herein with respect to system 100B may be implemented with any appropriate logic, wherein the logic, as referred to herein, can include any suitable hardware (e.g., a processor, an embedded controller, or an application specific integrated circuit, among others), software (e.g., an application, among others), firmware, or any suitable combination of hardware, software, and firmware, in various embodiments.

[0031] Fig. 2A shows a process flow diagram of a method 200A for integrated authentication for a container-based environment in accordance with one or more embodiments of the present invention. Embodiments of method 200A can be implemented in, and are discussed with reference to, system 100A of Fig. 1A. In block 201 of method 200A, one or more authentication files such as authentication file 107A is provided at a predefined location in the container environment 103A. For example, for a container environment 103A including a container runtime environment comprising a private Docker registry, authentication file 107A can be placed under the /etc/docker/certs.d directory; for an LDAP server, authentication file 107A can be placed under /etc/ldap/ldap-ca; and for an HTTP/HTTPS proxy server, authentication file 107A can be placed under /etc/certs.d/docker-proxy-ca. Authentication files such as authentication file 107A can be placed at any appropriate location in a container environment such as container environment 103A. The authentication files, such as authentication file 107A, may have a predefined file extension. The predefined file extension can have any appropriate format (e.g., symbolic link, character special, pipe, or socket file types). In block 202, an authentication handler 109A is provided in the container environment 103A.

Provision of the authentication handler 109A may include modification of the kernel of the guest OS 106.

[0032] In block 203 of method 200A, an application in a container 104A in the container environment 103A accesses authentication file 107A in order to request a security artifact to perform an authentication operation. In block 204, the authentication handler 109A is invoked by the accessing of the authentication file 107A that occurred in block 203. The authentication handler 109A can be invoked by guest OS 106 based on the file extension of the accessed authentication file 107A. In block 205, the invoked authentication handler 109A passes control to the host OS virtualization layer 110 to retrieve the requested security artifact from security DB 113. In some embodiments of the invention, the authentication handler 109A can implement STHYI interface calls to communicate with the host OS virtualization layer 110 in block 205. In some embodiments of block 205, the retrieval of the requested security artifact from security DB 113 can be performed based on a user ID associated with the requesting application. In block 206, the requested security artifact is provided to the requesting application from security DB 113 and the host OS virtualization layer 110 via the security handler 1109A. In some embodiments of block 206, the authentication handler 109A can automatically convert the security artifact from the format used in the security DB 113 into a format that is usable by the requesting application in container 104A. The format translation of block 206 can be performed based on a file extension of the security artifact. Blocks 203 to 206 of method 200A can be repeated throughout operation of system 100A in order for applications running in container environments 103A-N to access security artifacts in security DB 113.

[0033] The process flow diagram of Fig. 2A is not intended to indicate that the operations of the method 200A are to be executed in any particular order, or that all of the operations of the method 200A are to be included in every case. Additionally, the method 200A can include any suitable number of additional operations.

[0034] Fig. 2B shows a process flow diagram of a method 200B for integrated authentication for a container-based environment in accordance with one or more

embodiments of the present invention. Embodiments of method 200B can be implemented in, and are discussed with reference to, system 100B of Fig. 1B. In block 211 of method 200B, an authentication file system 107B is mounted to guest OS 106 in a predefined location in the container environment 103A. The authentication file system 107B includes one or more placeholder files and an authentication handler 109B. Placeholder files can be placed at any appropriate location in authentication files system 107B. The placeholder files can correspond to symbolic links located at appropriate locations in the regular file system of the guest OS 106. For example, in some embodiments of the invention, for a private Docker registry, a symbolic link to a placeholder file in authentication file system 107B can be included in a `/etc/docker/certs.d` directory; for an LDAP server, a symbolic link to a placeholder file in authentication file system 107B can be included in a `/etc/ldap/ldap-ca` directory; and for an HTTP/HTTPS proxy server, a symbolic link to a placeholder file in authentication file system 107B can be included in a `/etc/certs.d/docker-proxy-ca` directory in the regular file system of the guest OS 106. In some embodiments of the invention, mounting of the authentication file system 107B that includes authentication handler 109B in container environment 103A may not require modification of the kernel of guest OS 106.

[0035] In block 212 of method 200B, an application in a container 104A in the container environment 103A accesses a placeholder file in the authentication file system 107B in order to request a security artifact to perform an authentication operation. The application can access a symbolic link in the regular file system of the guest OS 106 in order to request the security artifact, and the access is redirected by guest OS 106 to the placeholder file corresponding to the accessed symbolic link in the authentication file system 107B. In block 213, the authentication handler 109B is invoked by the accessing of the placeholder file in the authentication file system 107B that occurred in block 212. In block 214, the authentication handler 109B passes control to the host OS virtualization layer 110 to retrieve the requested security artifact from security DB 113. In some embodiments of the invention, the authentication handler 109B can implement STHYI interface calls to communicate with the host OS virtualization layer 110 in block 214. In some embodiments of block

214, the retrieval of the requested security artifact from security DB 113 can be performed based on a user ID associated with the requesting application. In block 215, the security artifact is provided to the requesting application from security DB 113 and the host OS virtualization layer 110 via the security handler 1109B. In some embodiments of block 215, the authentication handler 109B can automatically convert the security artifact from a format that is used in security DB 113 into a format that is usable by the requesting application. The format translation of block 215 can be performed based on a file extension of the security artifact. Blocks 212 to 215 of method 200B can be repeated throughout operation of system 100B in order for applications running in container environments 103A-N to access security artifacts in security DB 113.

[0036] The process flow diagram of Fig. 2B is not intended to indicate that the operations of the method 200B are to be executed in any particular order, or that all of the operations of the method 200B are to be included in every case. Additionally, the method 200B can include any suitable number of additional operations.

[0037] It is to be understood that although this disclosure includes a detailed description on cloud computing, implementation of the teachings recited herein are not limited to a cloud computing environment. Rather, embodiments of the present invention are capable of being implemented in conjunction with any other type of computing environment now known or later developed.

[0038] Cloud computing is a model of service delivery for enabling convenient, on-demand network access to a shared pool of configurable computing resources (e.g., networks, network bandwidth, servers, processing, memory, storage, applications, virtual machines, and services) that can be rapidly provisioned and released with minimal management effort or interaction with a provider of the service. This cloud model may include at least five characteristics, at least three service models, and at least four deployment models.

[0039] Characteristics are as follows:

[0040] On-demand self-service: a cloud consumer can unilaterally provision computing capabilities, such as server time and network storage, as needed automatically without requiring human interaction with the service's provider.

Suitable I/O buses for connecting peripheral devices such as hard disk controllers, network adapters, and graphics adapters typically include common protocols, such as the Peripheral Component Interconnect (PCI). CLAIMS

What is claimed is:

1. A computer-implemented method comprising:

accessing, by an application that is running in a container in a container environment that is hosted by a hypervisor on a host system, an authentication module that is located in the container environment;

invoking an authentication handler in the container environment based on the accessing of the authentication module;

passing control to the hypervisor from the authentication handler;

retrieving a security artifact from a security database of the host system by the hypervisor;

providing the retrieved security artifact to the application via the authentication handler; and

performing an authentication operation by the application using the security artifact.
2. The method of claim 1, wherein the authentication module comprises an authentication file that is accessed by the application in order to perform the authentication operation, wherein a location of the authentication file in the container environment corresponds to a type of the security artifact.
3. The method of claim 2, wherein the authentication handler is invoked based on a file extension of the authentication file.
4. The method of claim 1, wherein the authentication module comprises an authentication file system that is mounted to a guest operating system (OS) of the container environment, wherein the authentication file system comprises a

placeholder file that is accessed by the application in order to perform the authentication operation.

5. The method of claim 4, wherein the placeholder file is accessed based on a symbolic link in a regular file system of the guest OS, and wherein a location of the symbolic link corresponds to a type of the security artifact.

6. The method of claim 4, wherein the authentication handler is located in the authentication file system.

7. The method of claim 1, wherein providing the retrieved security artifact to the application via the authentication handler comprises converting, by the authentication handler, the security artifact from a first format that is used for storage in the security database to a second format that is required for use by the application.

8. A system comprising:

a memory having computer readable instructions; and

one or more processors for executing the computer readable instructions, the computer readable instructions controlling the one or more processors to perform operations comprising:

accessing, by an application that is running in a container in a container environment that is hosted by a hypervisor on a host system, an authentication module that is located in the container environment;

invoking an authentication handler in the container environment based on the accessing of the authentication module;

passing control to the hypervisor from the authentication handler;

retrieving a security artifact from a security database of the host system by the hypervisor;

providing the retrieved security artifact to the application via the authentication handler; and

performing an authentication operation by the application using the security artifact.

9. The system of claim 8, wherein the authentication module comprises an authentication file that is accessed by the application in order to perform the authentication operation, wherein a location of the authentication file in the container environment corresponds to a type of the security artifact.

10. The system of claim 9, wherein the authentication handler is invoked based on a file extension of the authentication file.

11. The system of claim 8, wherein the authentication module comprises an authentication file system that is mounted to a guest operating system (OS) of the container environment, wherein the authentication file system comprises a placeholder file that is accessed by the application in order to perform the authentication operation.

12. The system of claim 11, wherein the placeholder file is accessed based on a symbolic link in a regular file system of the guest OS, and wherein a location of the symbolic link corresponds to a type of the security artifact.

13. The system of claim 11, wherein the authentication handler is located in the authentication file system.

14. The system of claim 8, wherein providing the retrieved security artifact to the application via the authentication handler comprises converting, by the authentication handler, the security artifact from a first format that is used for storage in the security database to a second format that is required for use by the application.

15. A computer program product comprising a computer readable storage medium having program instructions embodied therewith, the program instructions executable

by one or more processors to cause the one or more processors to perform operations comprising:

accessing, by an application that is running in a container in a container environment that is hosted by a hypervisor on a host system, an authentication module that is located in the container environment;

invoking an authentication handler in the container environment based on the accessing of the authentication module;

passing control to the hypervisor from the authentication handler;

retrieving a security artifact from a security database of the host system by the hypervisor;

providing the retrieved security artifact to the application via the authentication handler; and

performing an authentication operation by the application using the security artifact.

16. The computer program product of claim 15, wherein the authentication module comprises an authentication file that is accessed by the application in order to perform the authentication operation, wherein a location of the authentication file in the container environment corresponds to a type of the security artifact.

17. The computer program product of claim 16, wherein the authentication handler is invoked based on a file extension of the authentication file.

18. The computer program product of claim 15, wherein the authentication module comprises an authentication file system that is mounted to a guest operating system (OS) of the container environment, wherein the authentication file system comprises a placeholder file that is accessed by the application in order to perform the authentication operation.

19. The computer program product of claim 18, wherein the placeholder file is accessed based on a symbolic link in a regular file system of the guest OS, and wherein a location of the symbolic link corresponds to a type of the security artifact.
20. The computer program product of claim 18, wherein the authentication handler is located in the authentication file system.

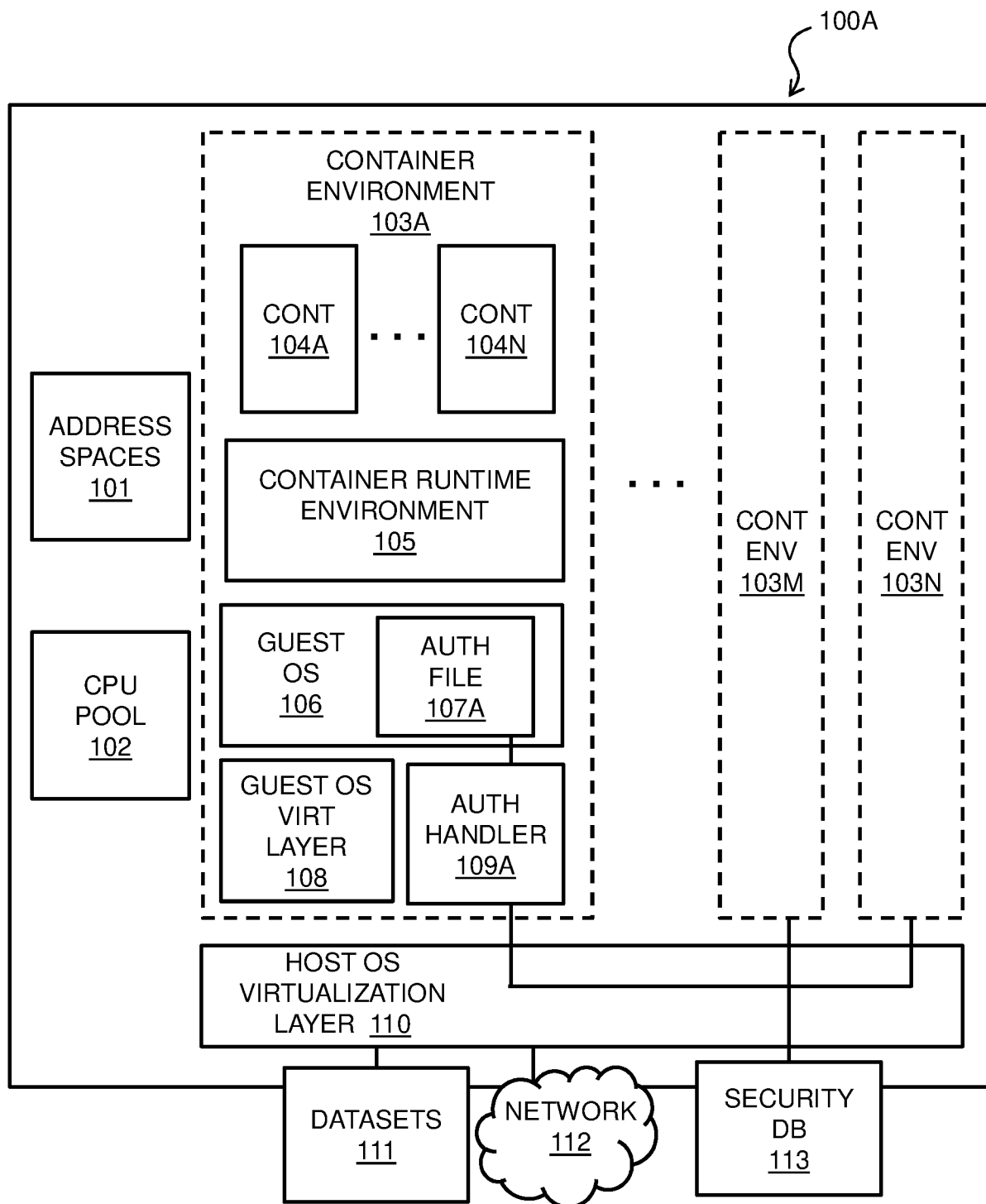

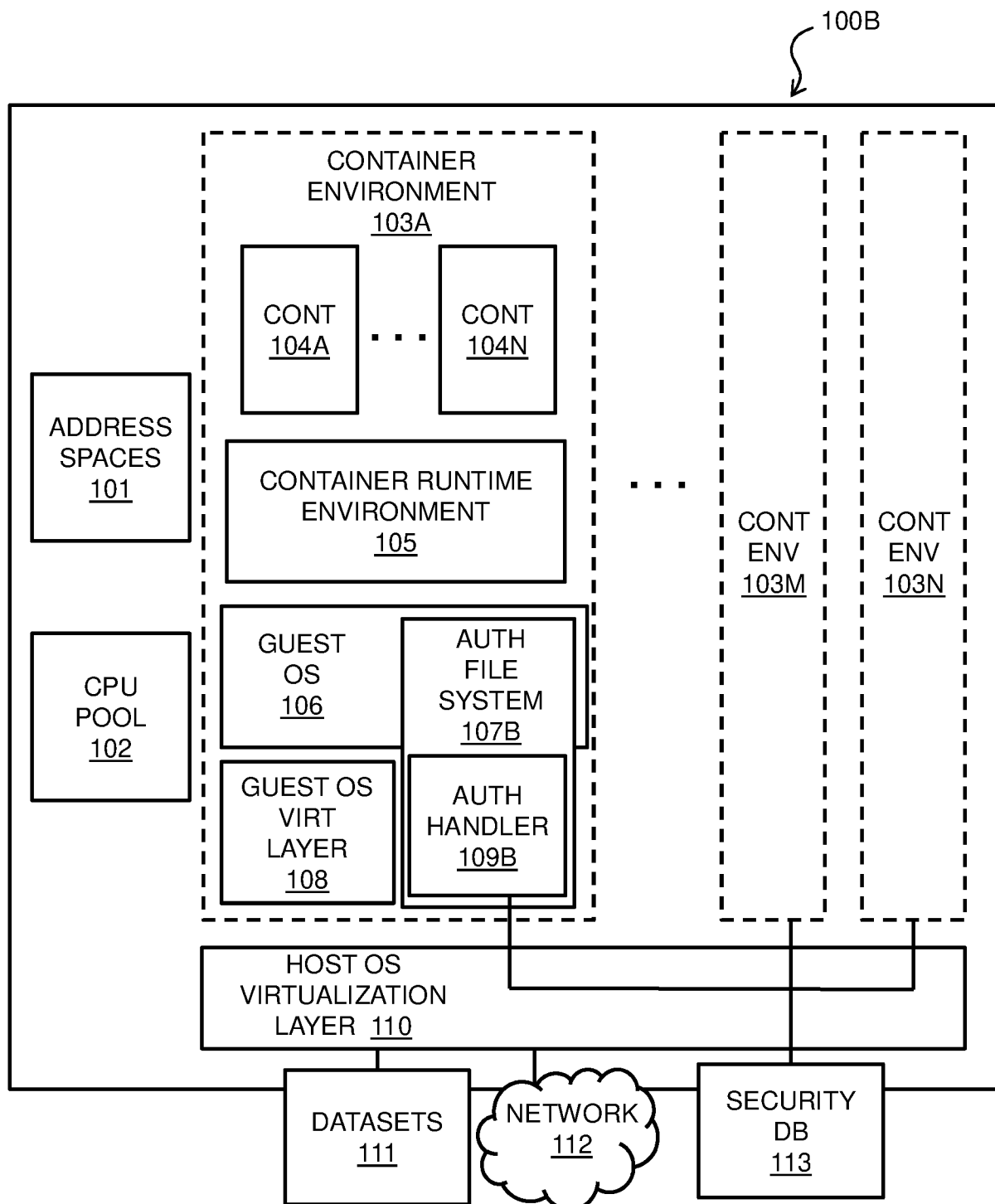

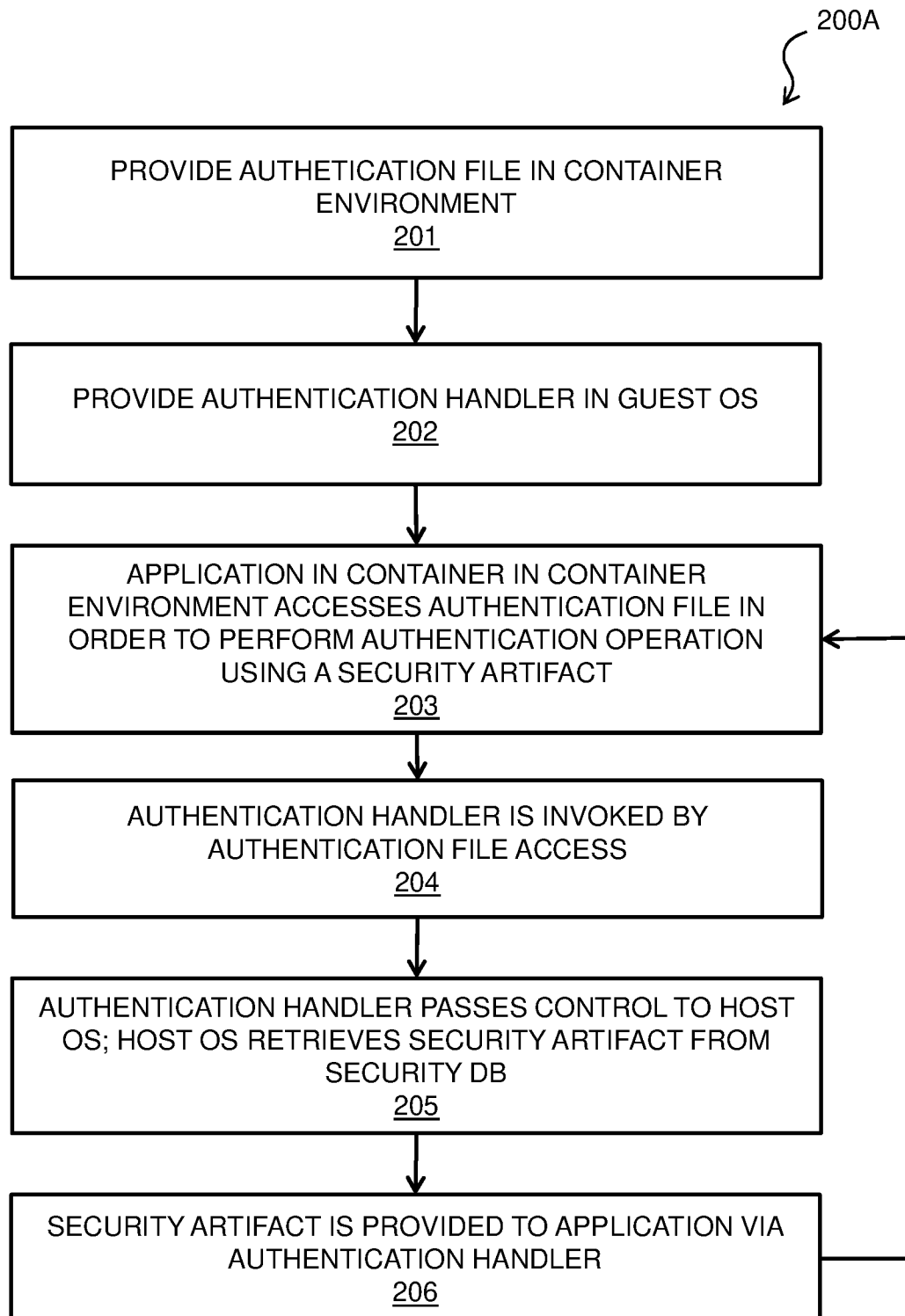

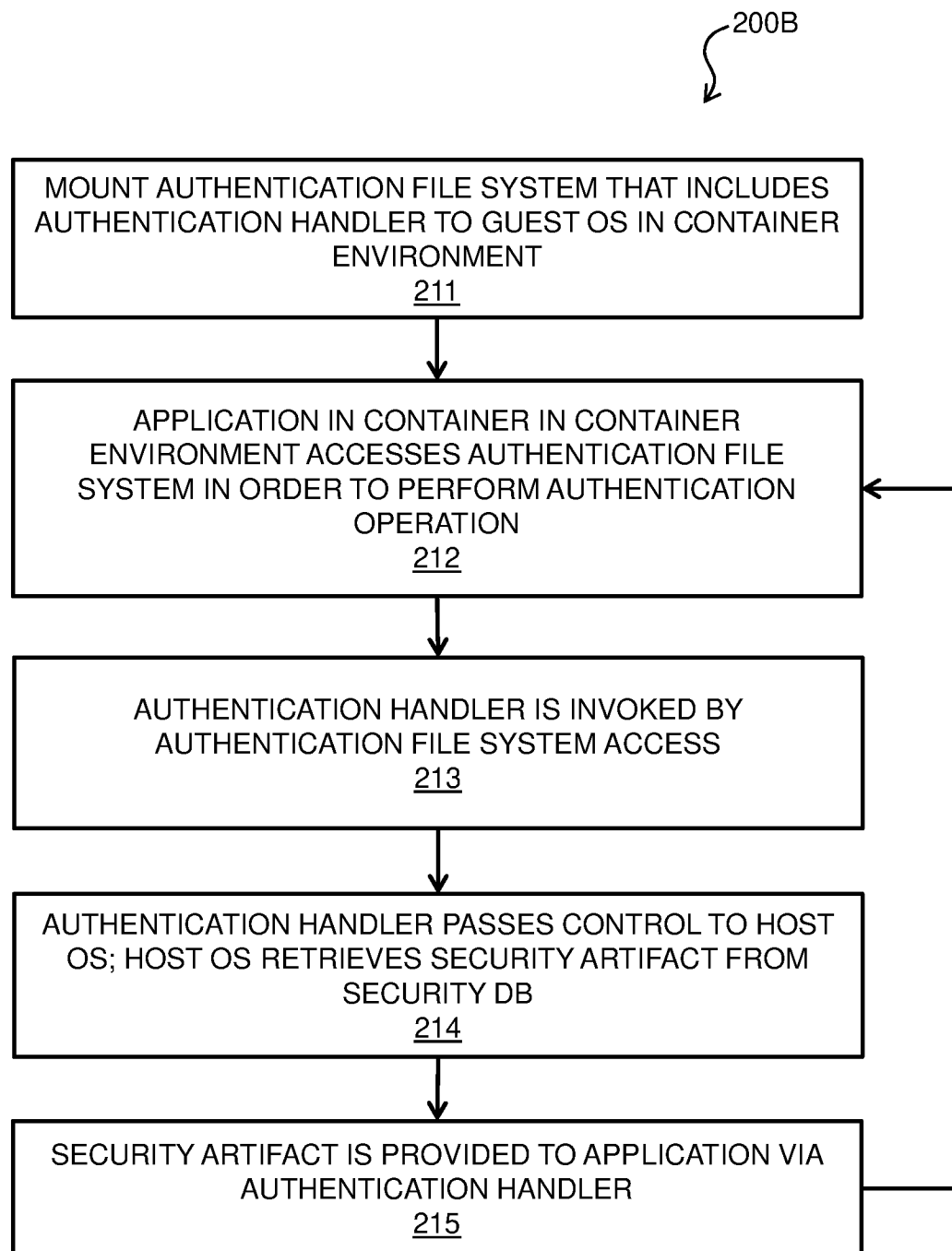

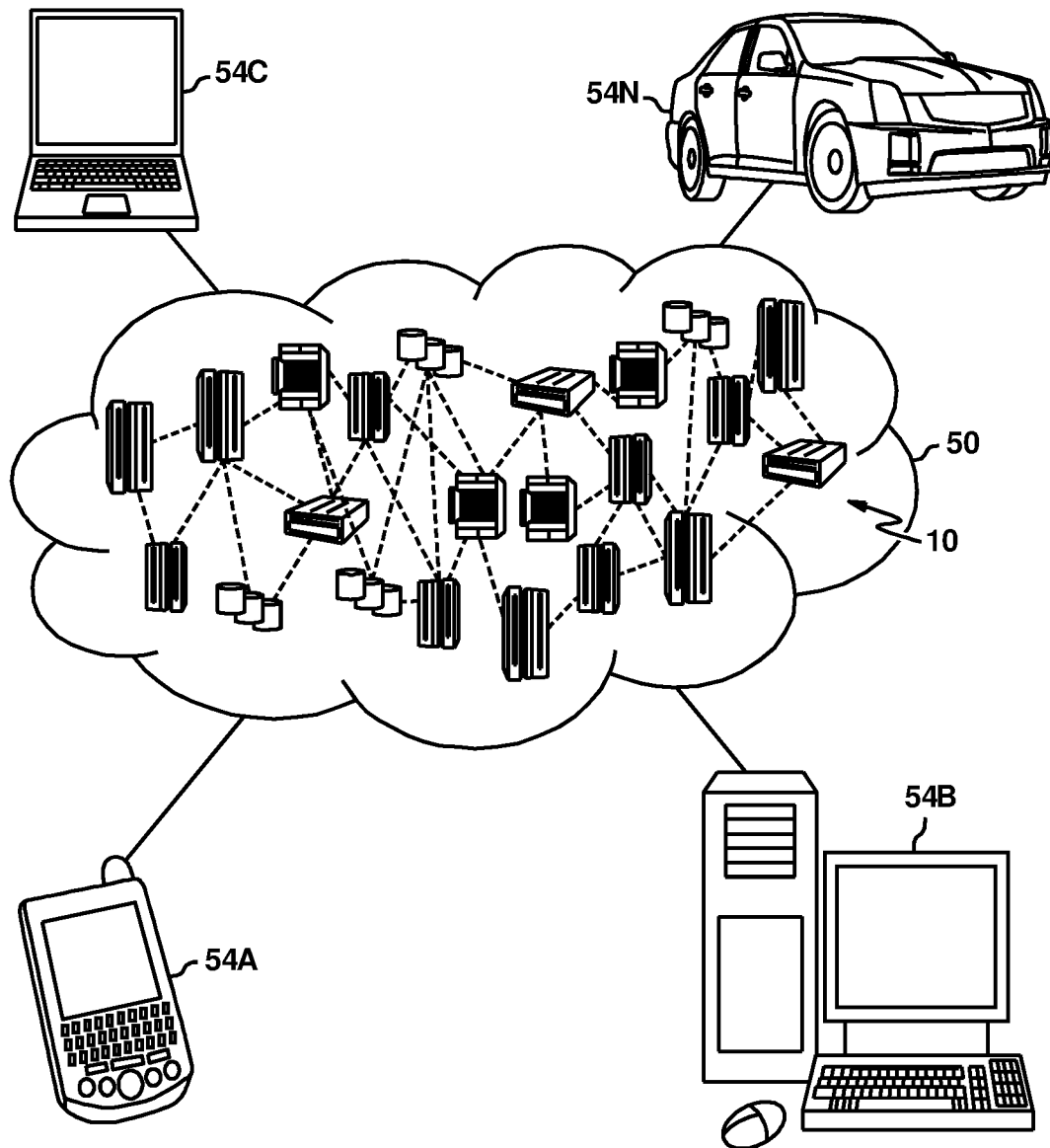

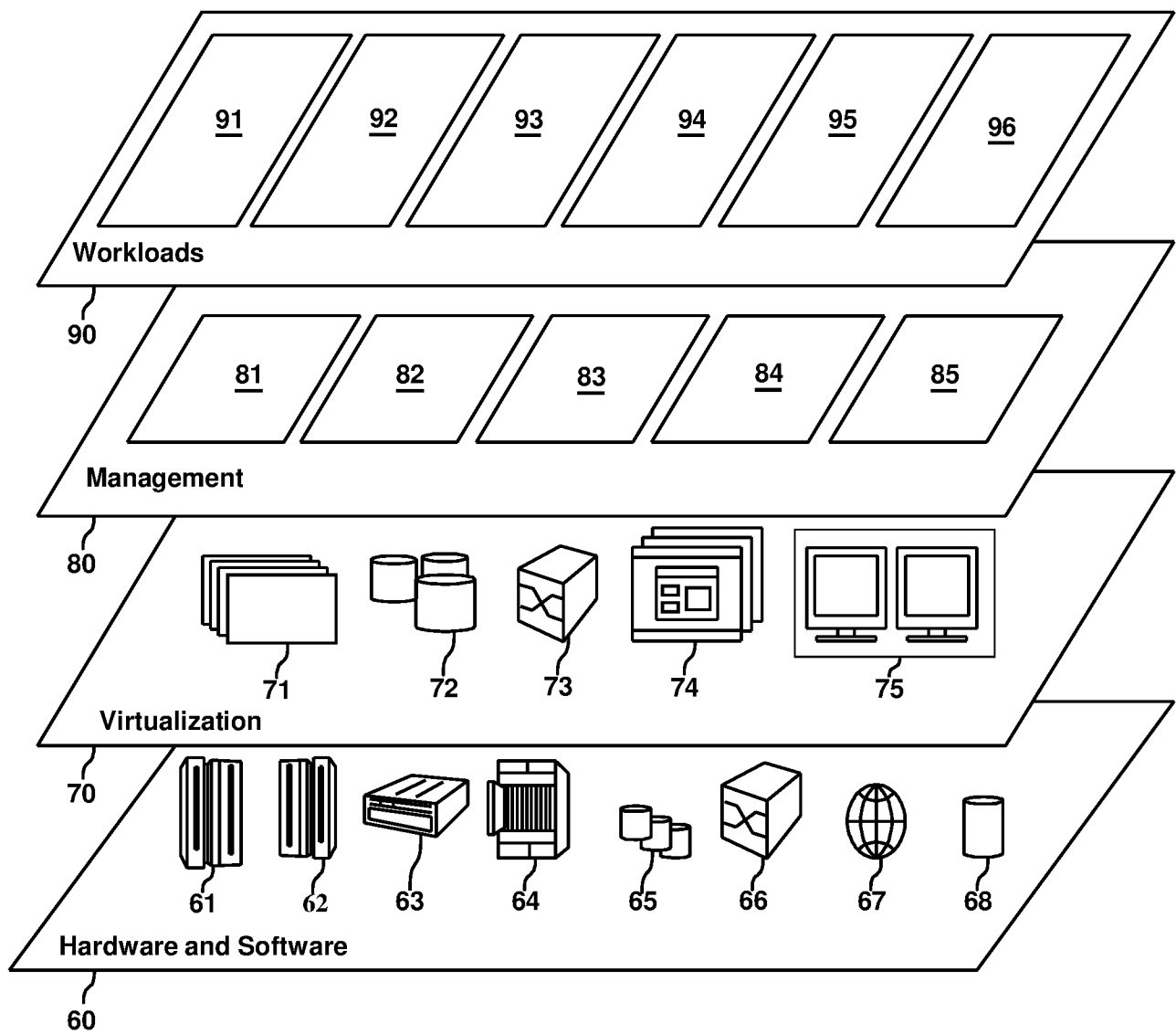

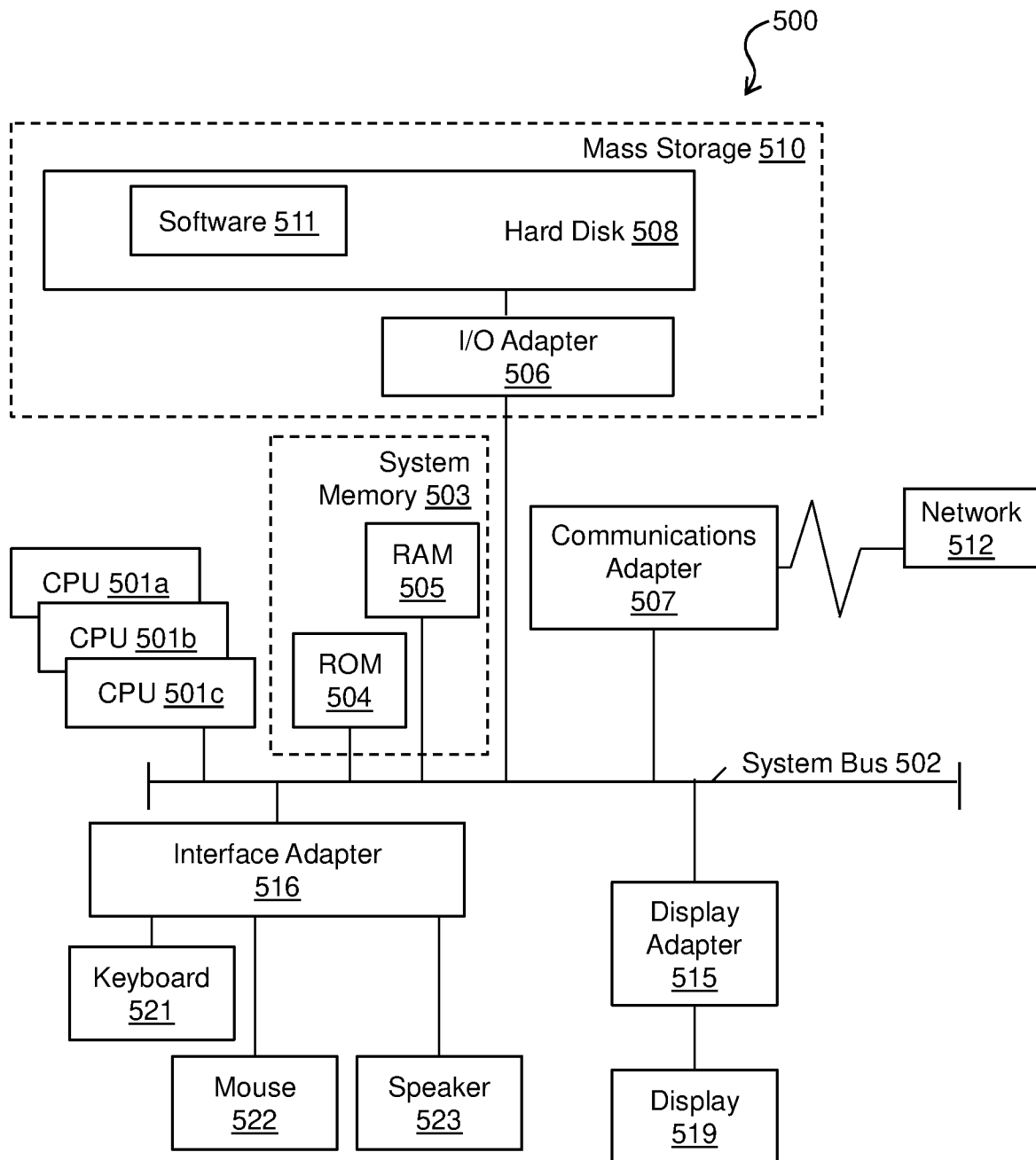
