**DESCRIPTION**


FIG. 1 is a side perspective view of a modular meat tenderizer showing my new design;  
 FIG. 2 is a front exploded perspective view thereof;  
 FIG. 3 is a top plan view of a handle element for use with the modular meat tenderizer thereof;  
 FIG. 4 is a right side elevational view of the handle element of FIG. 3, the opposite side being a mirror image hereof;  
 FIG. 5 is perspective view of a weighted roller element for use with the modular meat tenderizer thereof;  
 FIG. 6 is side elevational view of the weighted roller element of FIG. 5;  
 FIG. 7 is a front elevational view of the weighted roller element of FIGS. 5 and 6;  
 FIG. 8 is a perspective view of a meat tenderizing roller cover for use with the modular meat tenderizer thereof;  
 FIG. 9 is a front elevational view of the meat tenderizing roller cover of FIG. 8; and,  
 FIG. 10 is a side elevational view of the meat tenderizing roller cover of FIGS. 8 and 9.  
 The pieces of the claimed design are shown separately for clarity of illustration.

















