(57) **CLAIM**

The ornamental design for an air intake system with a ribbed airbox, as shown and described.

DESCRIPTION

FIG. 1 is a left-front perspective view of an air intake system with a ribbed airbox showing our new design.

FIG. 2 is a front elevation view thereof.

FIG. 3 cross-section view of the air intake system of FIG. 2 taken along 3-3.

FIG. 4 is a left side elevation view thereof.


FIG. 5 is a right side elevation view thereof.














