manifold base for electromagnetic valve;

FIG. 5 is a top plan view thereof;

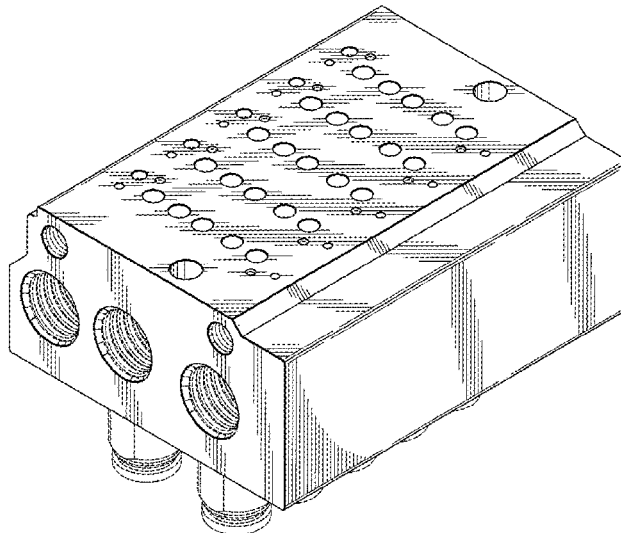
FIG. 6 is a bottom plan view thereof;

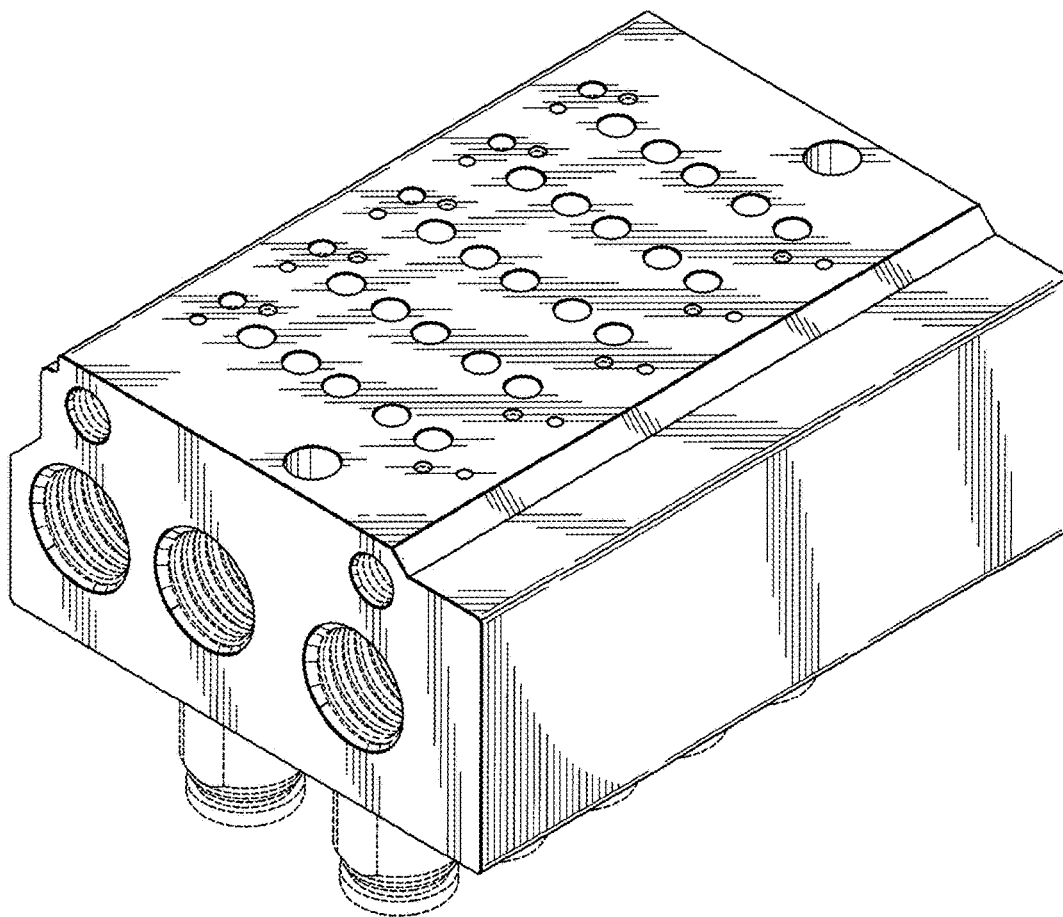

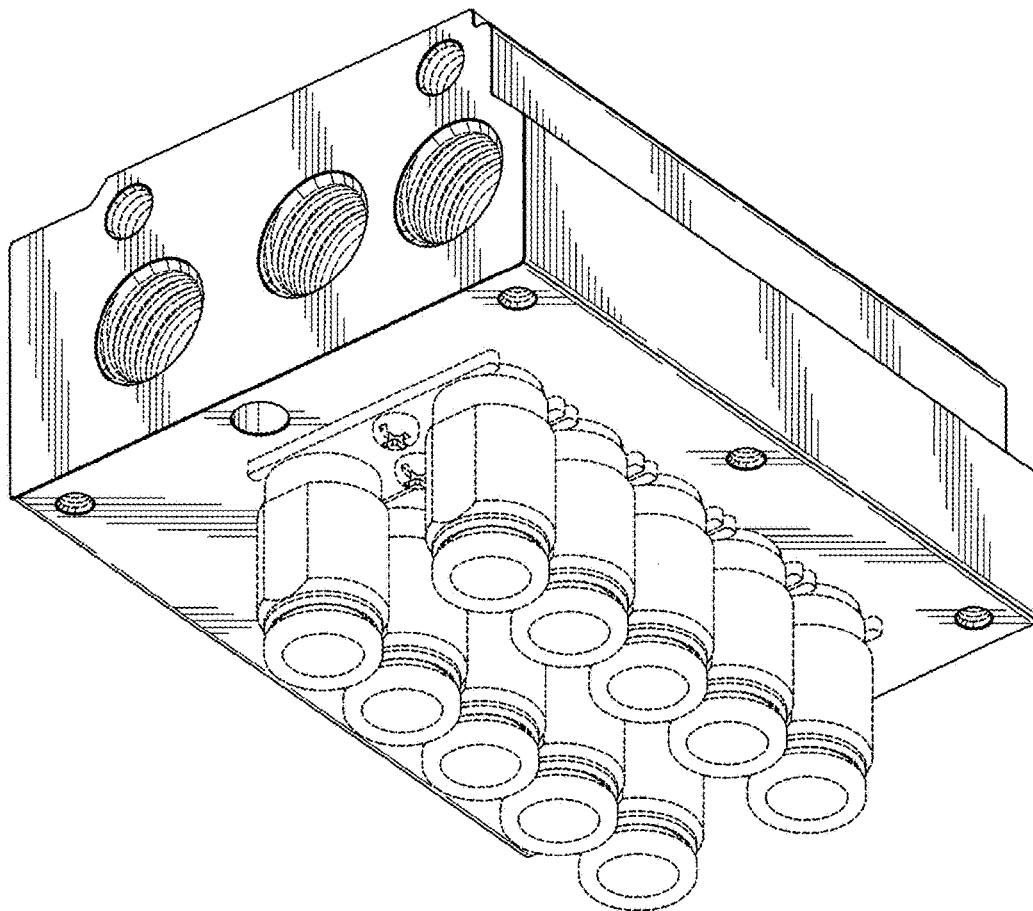

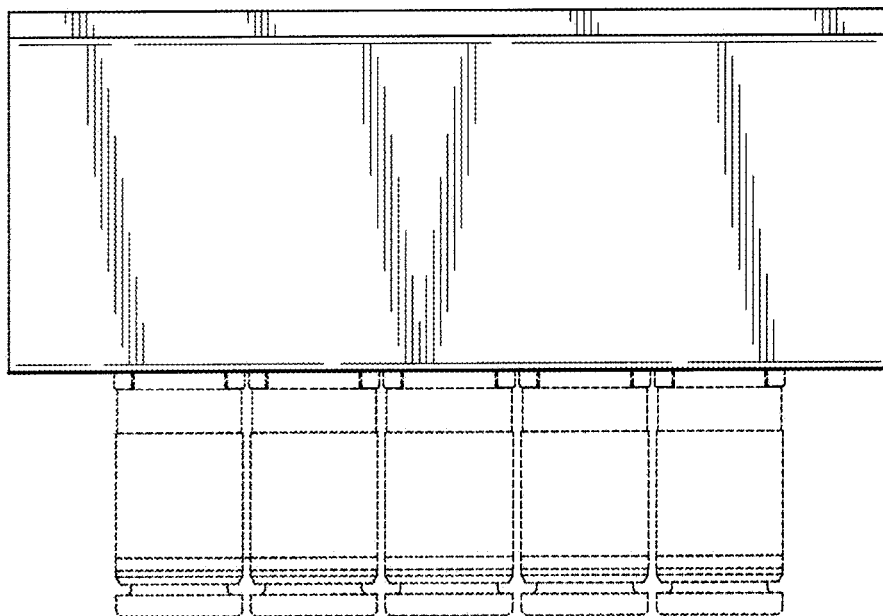

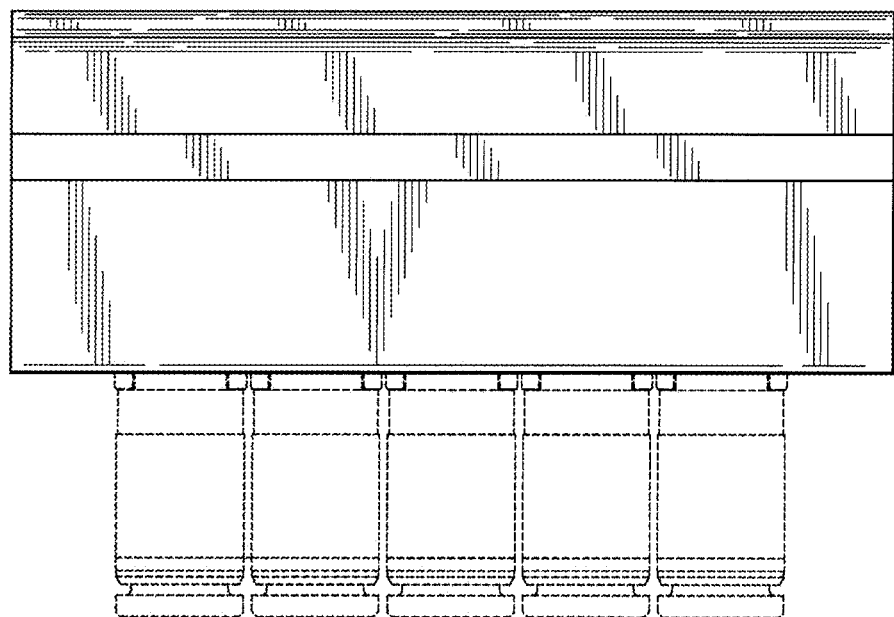

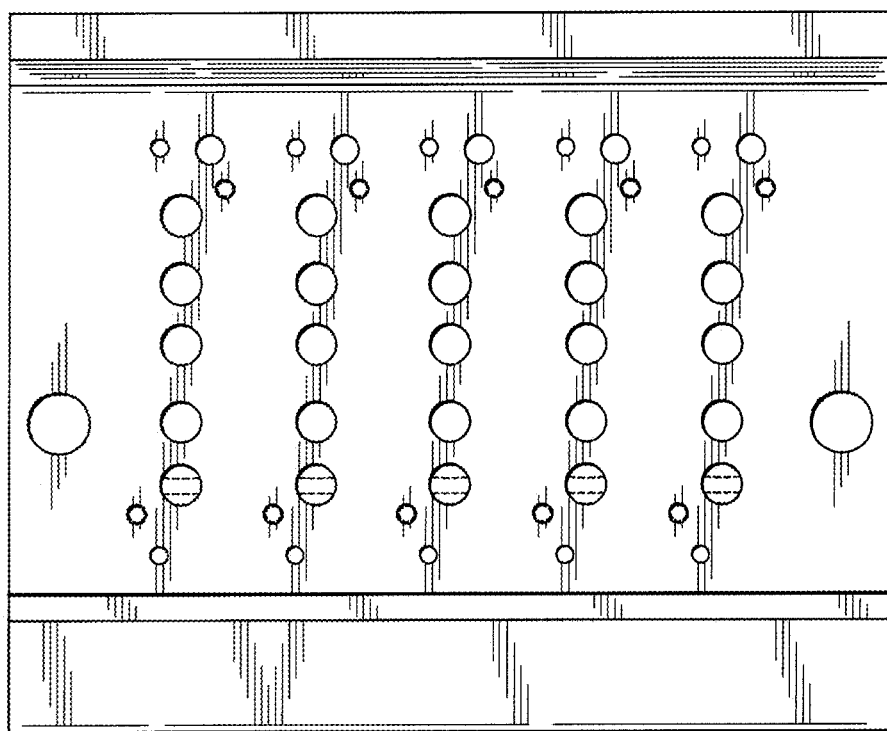

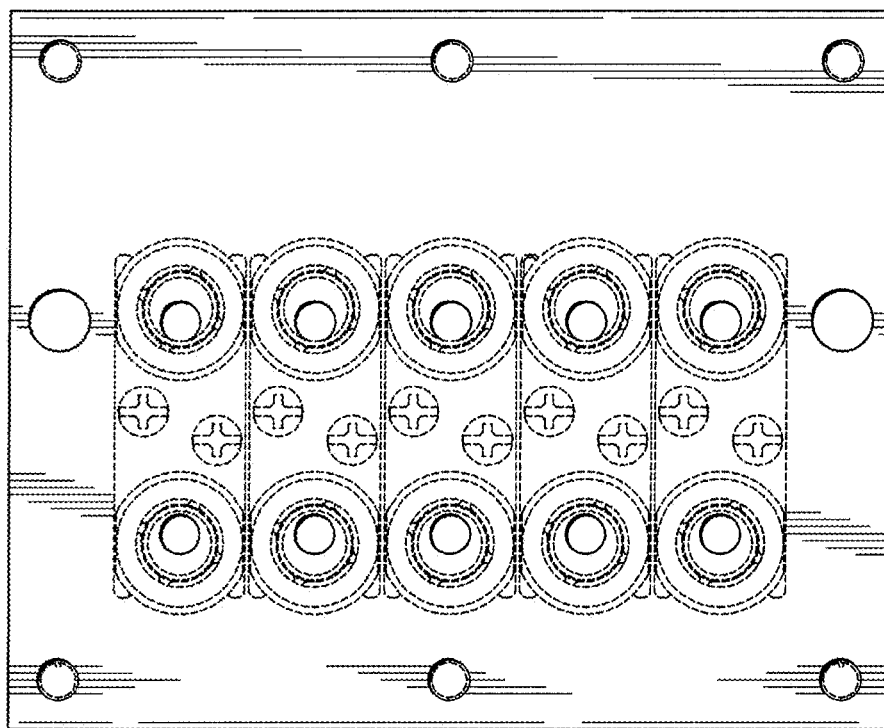

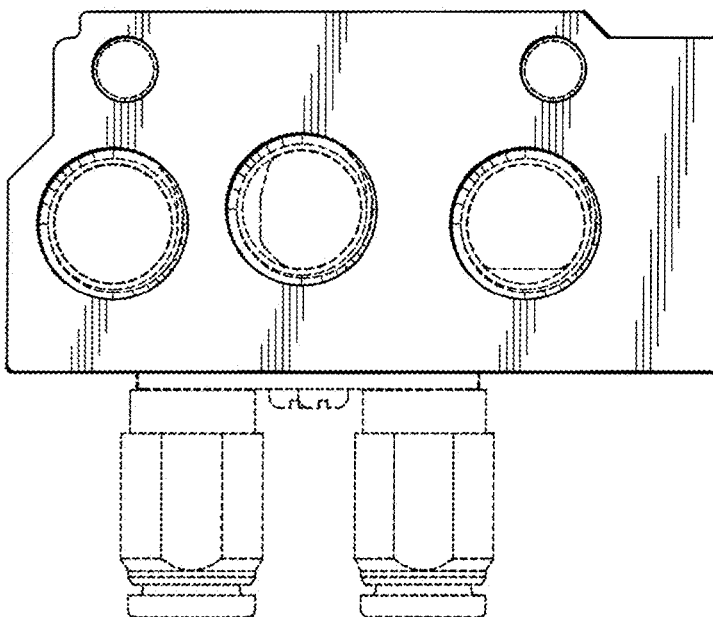

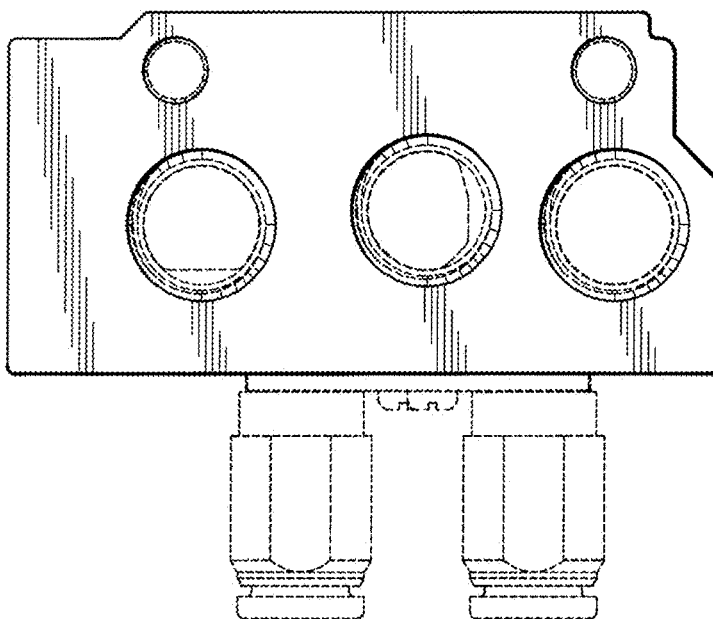
