(57) **CLAIM**

I claim the ornamental design for a tie tack, as shown.

DESCRIPTION

FIG. 1 is a front view of a tie tack having two elements showing my new design;
FIG. 2 is a rear view of the two elements thereof;
FIG. 3 is a right side view of the two elements thereof;
FIG. 4 is a left side view of the two elements thereof;
FIG. 5 is a top view of the two elements thereof;
FIG. 6 is a bottom view of the two elements thereof;
FIG. 7 is a front view of the two elements thereof positioned with a tie; and,
FIG. 8 is a left side view of the two elements thereof positioned with a tie.

















