DESCRIPTION


FIG. 1 is a perspective view of a detachable bucket base, showing my new design;

 FIG. 3 is a front elevational view of FIG. 2, the rear elevational view being a mirror image thereof;
 FIG. 4 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof; and,
 FIG. 7 is a cross-sectional view thereof, taken along line 7-7 of FIG. 3.
 The broken lines showing a bucket in FIG. 1 depict environmental matter and form no part of the claimed design.














