The ornamental design for a wireless omnidirectional micro-  
phone, as shown and described.

**DESCRIPTION**

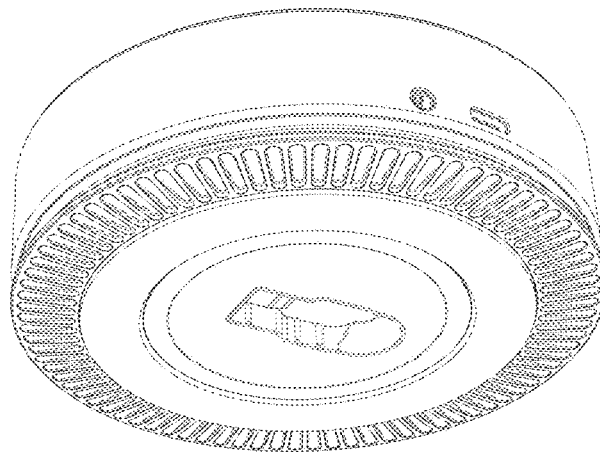
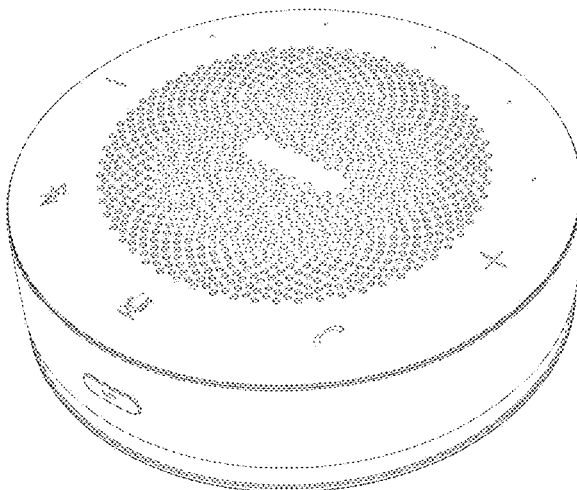

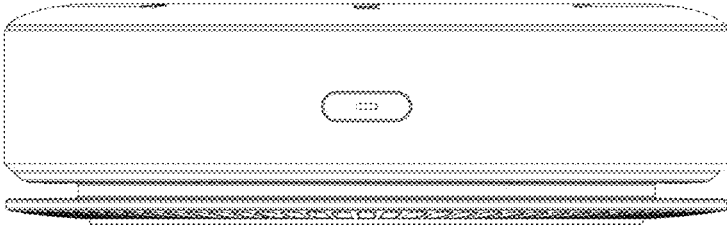

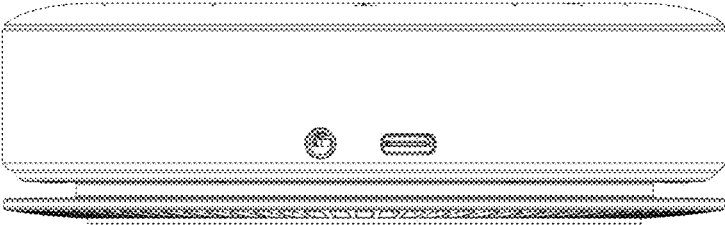

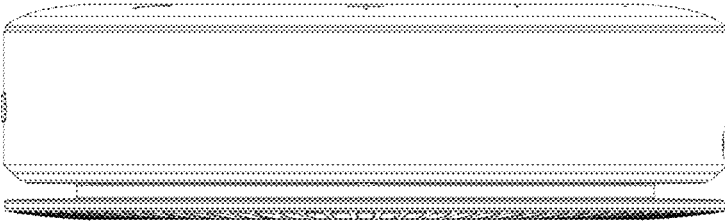

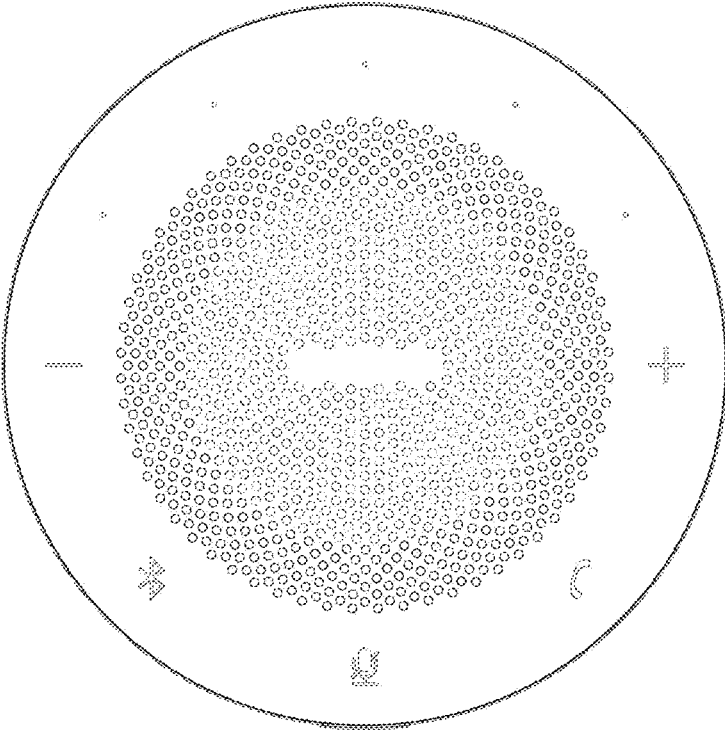

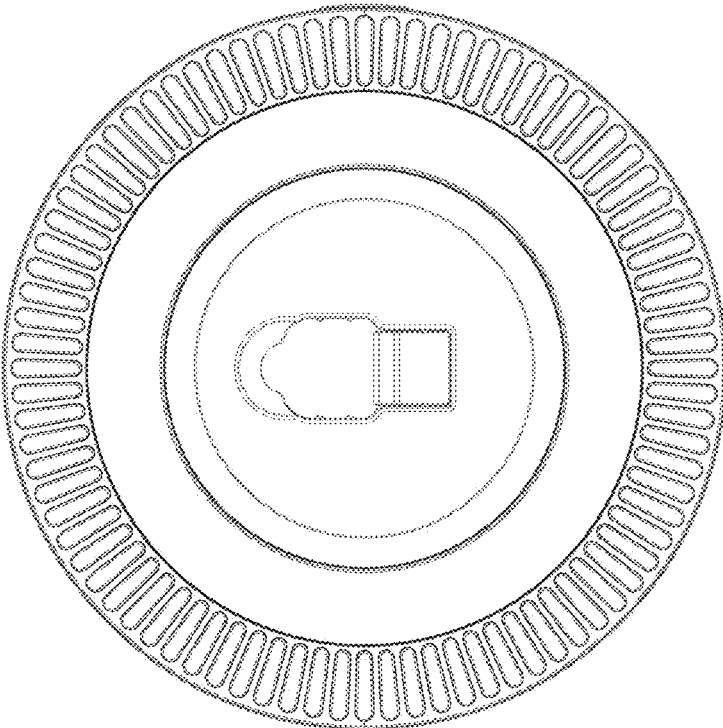

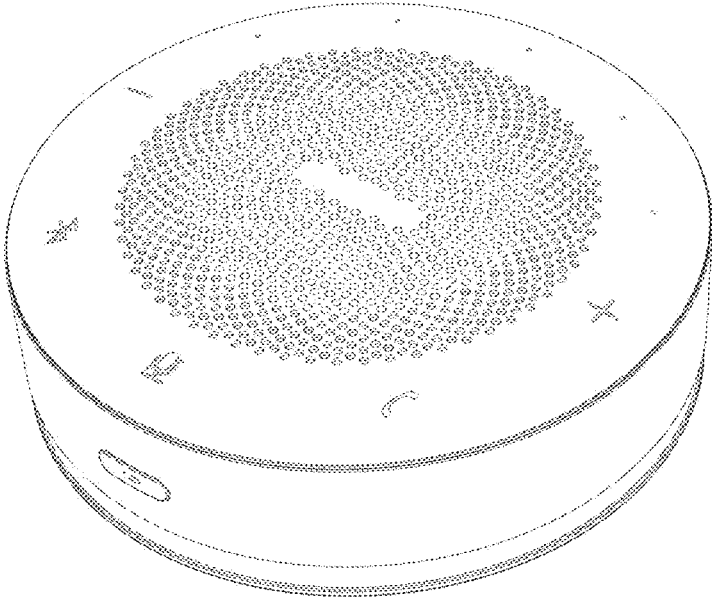

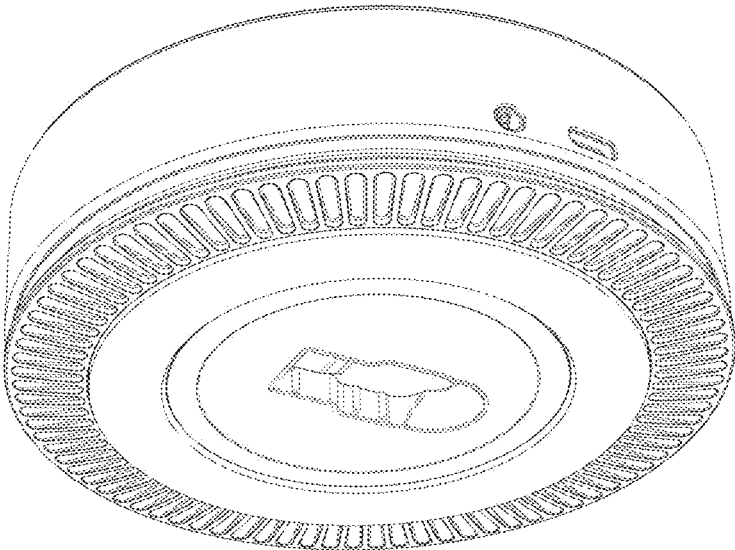
