The ornamental design for a firearm stock, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a firearm stock in an extended configuration, in accordance with the present invention;

FIG. 2 is a rear perspective view of the firearm stock of FIG. 1 in the extended configuration;

FIG. 3 is a right elevation view of the firearm stock of FIG. 1 in the extended configuration;

FIG. 13 is a top plan view of the firearm stock of FIG. 1 in the retracted configuration;


FIG. 14 is a bottom plan view of the firearm stock of FIG. 1 in the retracted configuration;
































