(57) **CLAIM**


The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a shoe showing our new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a rear view thereof; and, FIG. 4 is an opposite side view thereof. The broken lines immediately adjacent to the shaded areas define the bounds of the claimed design and form no part thereof. The unshaded broken line regions within the shaded areas form no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.








