DESCRIPTION

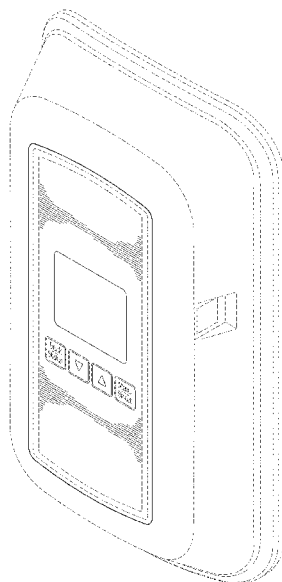

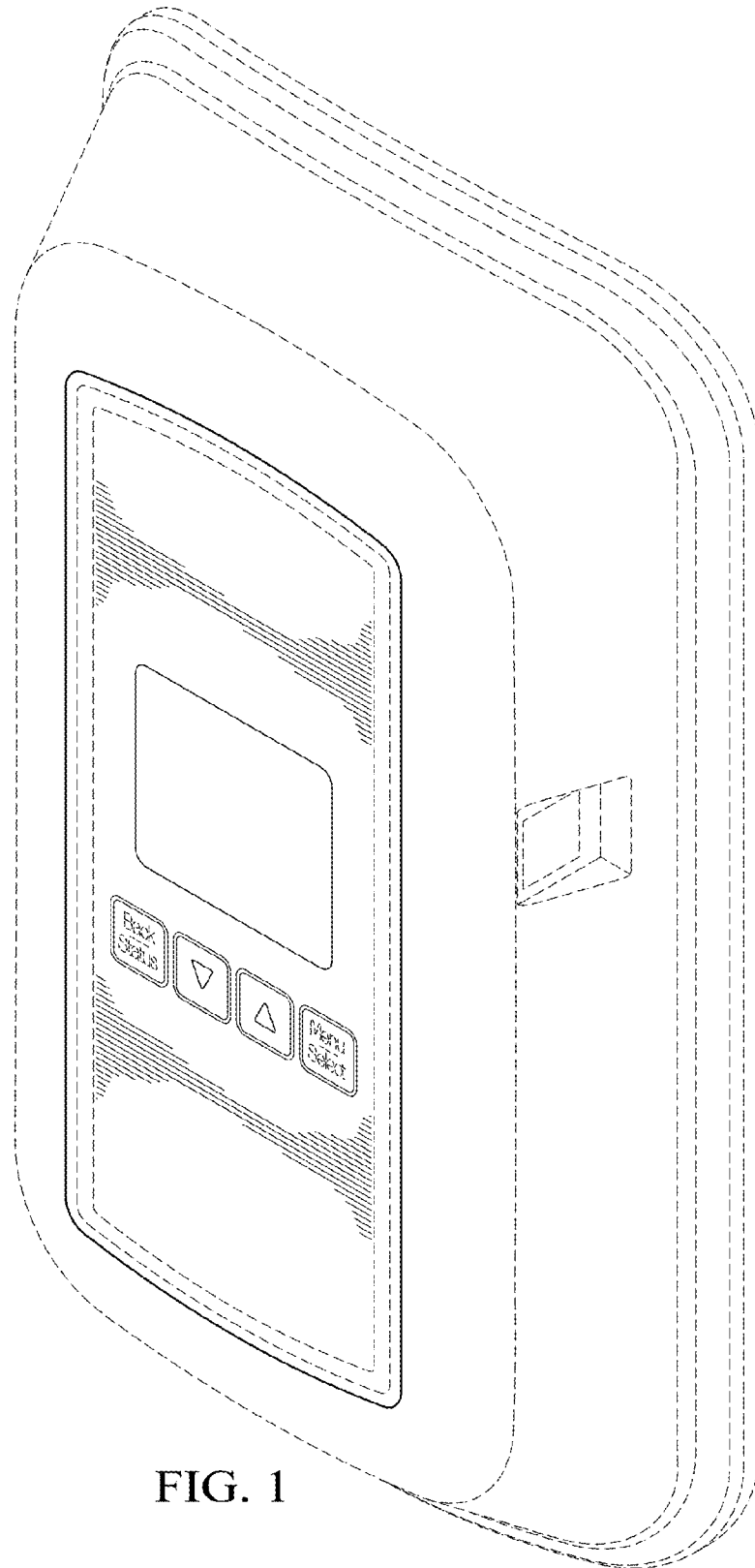

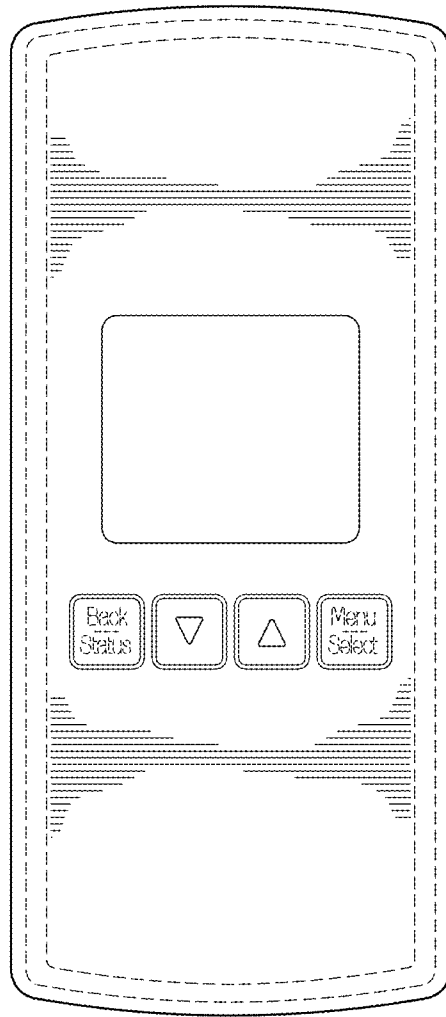
