The ornamental design for a headset, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom, perspective view of the headset;  
FIG. 2 is a top, perspective view thereof;  
FIG. 3 is a back, elevation view thereof;  
FIG. 4 is a front, elevation view thereof;  
FIG. 5 is a right side, elevation view thereof;  
FIG. 6 is a top, elevation view thereof;

FIG. 8 is a left side, elevation view thereof.

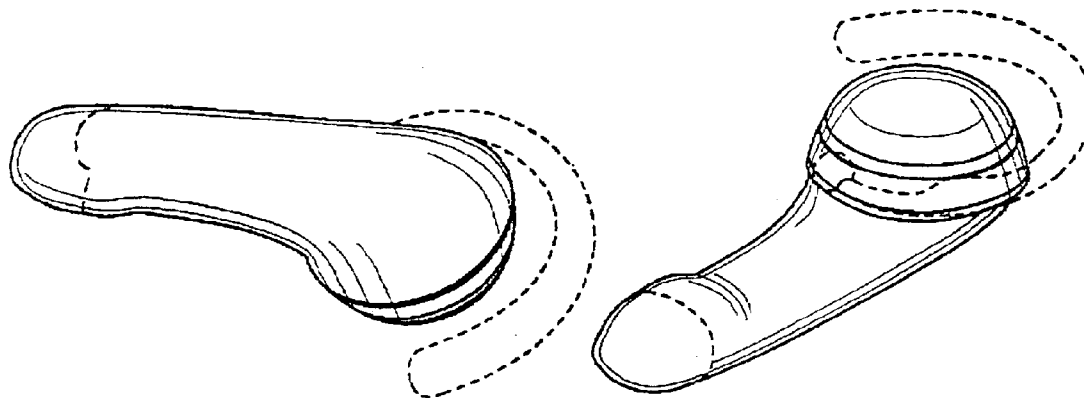

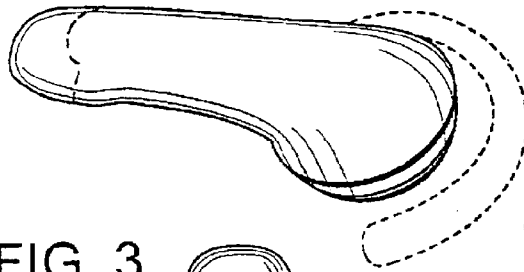

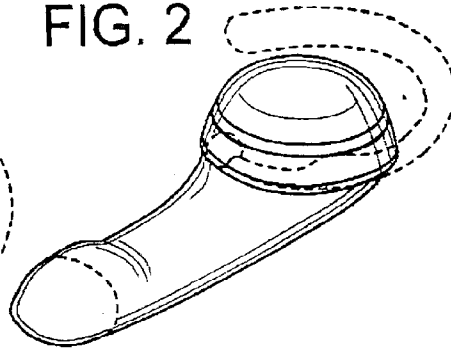

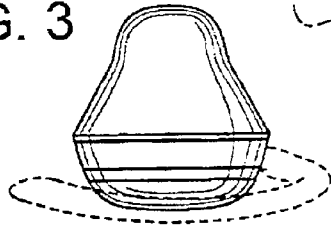

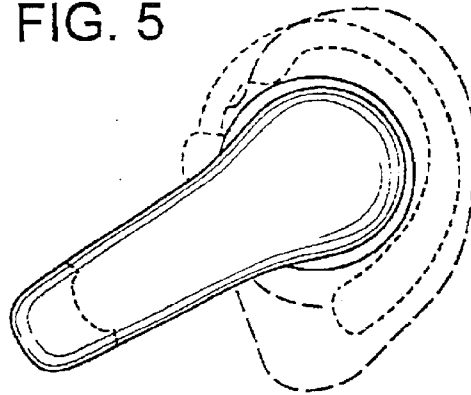

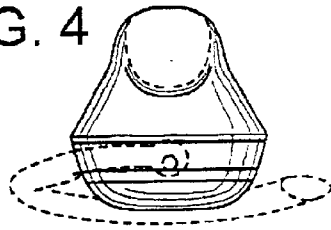

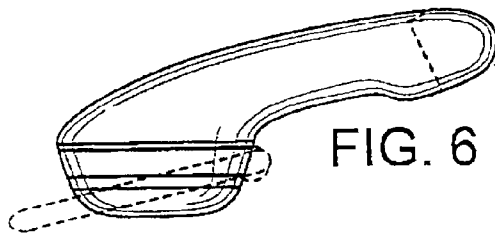

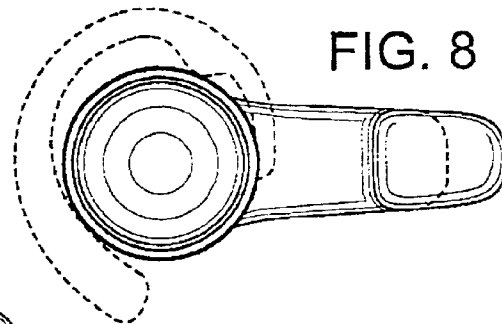
