DESCRIPTION

FIG. 1 is a perspective view of the boom showing my new design;

FIG. 2 is a bottom plan view of the boom of FIG. 1;

FIG. 4 is a front elevational view of the boom of FIG. 1;


FIG. 5 is a left side elevational view of the boom of FIG. 1;














